ARTICLES OF ORGANIZATION OF

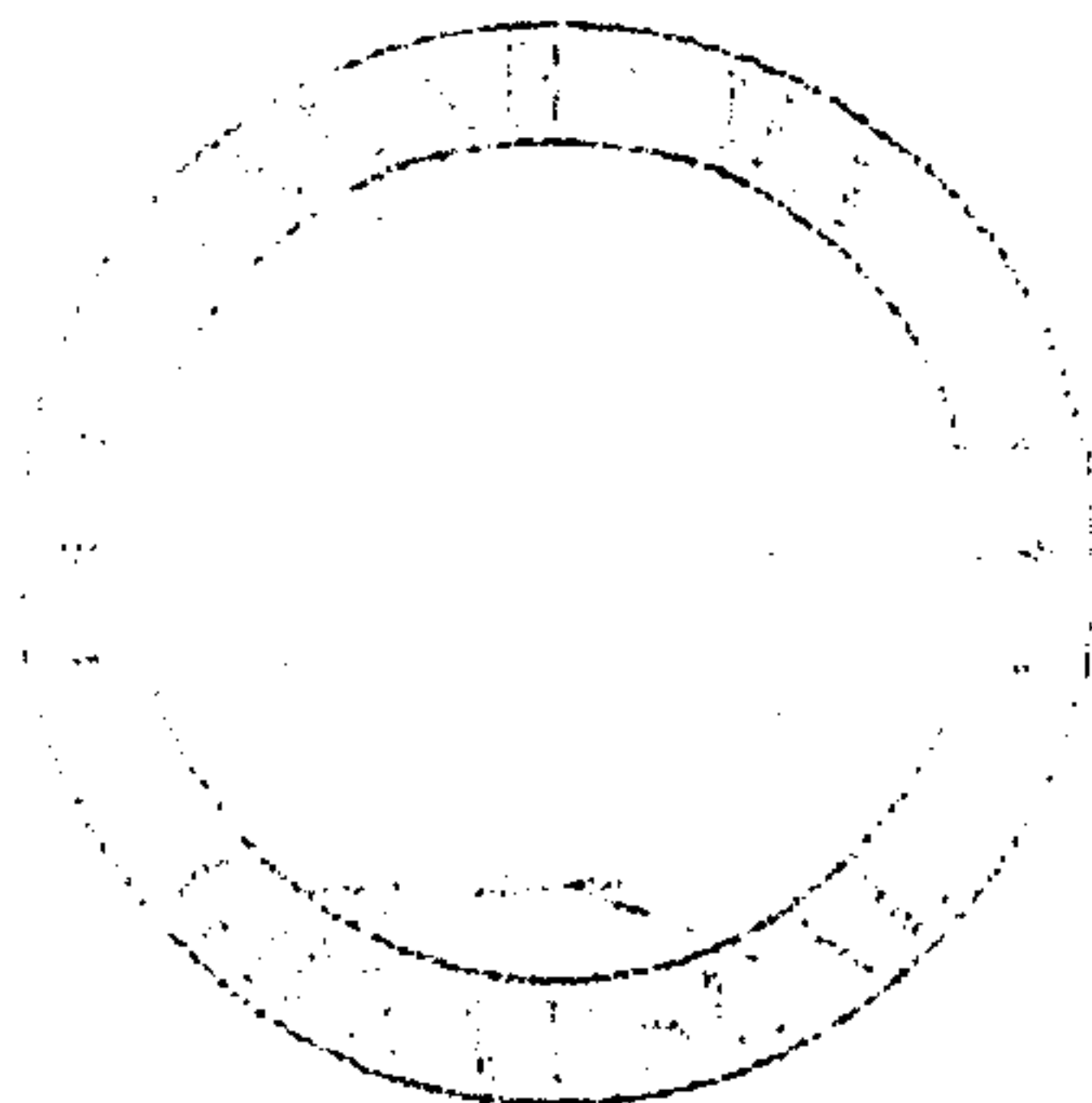

