NOW, THEREFORE, in consideration of the premises and \$100,288.17(**One Hundred Thousand**



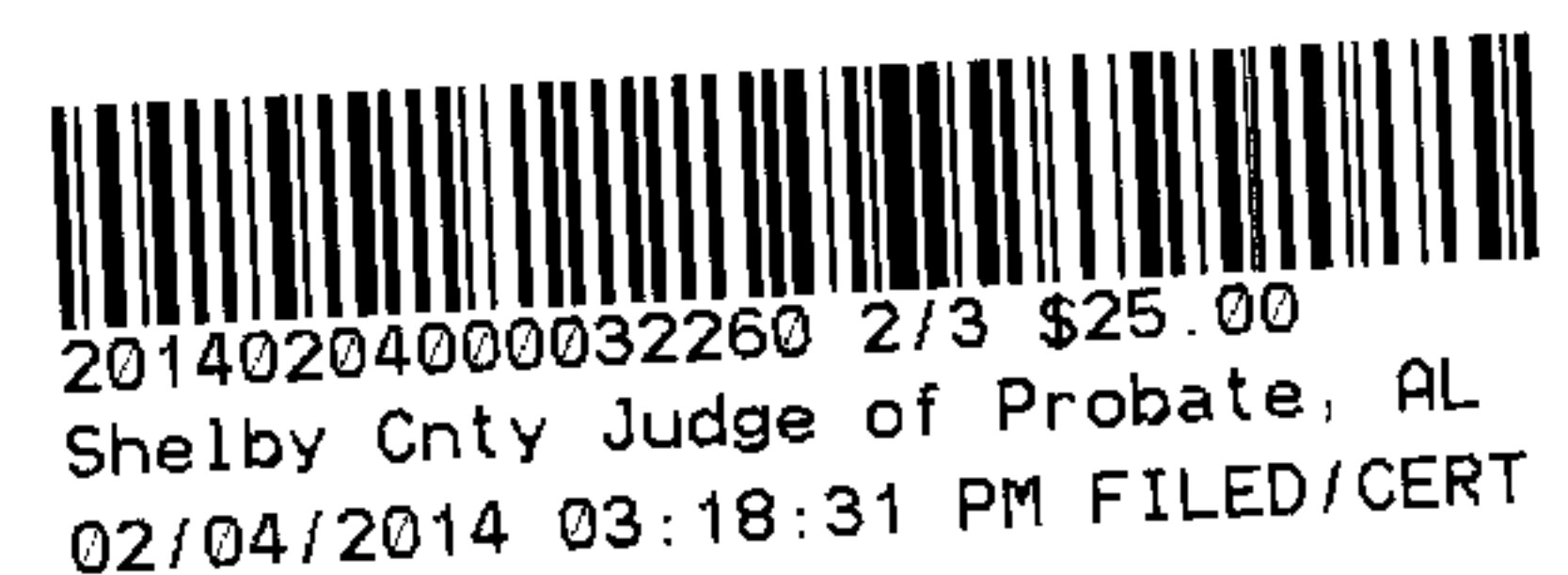
