Know All Men by These Presents: That in consideration of **Two hundred eighty eight** thousand seven hundred twenty and no/100 (\$288,720.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **DAL Properties, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Robert J. Grainger and Rebecca G.
