KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of September, 2011, Robert L. Hennessee, Jr, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Alabama Telco Credit Union, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20110912000268690, said mortgage having subsequently been transferred and assigned to Branch Banking And Trust Company, by instrument recorded in Instrument 20131122000460010, in the aforesaid Probate Office ("Transferee"); and

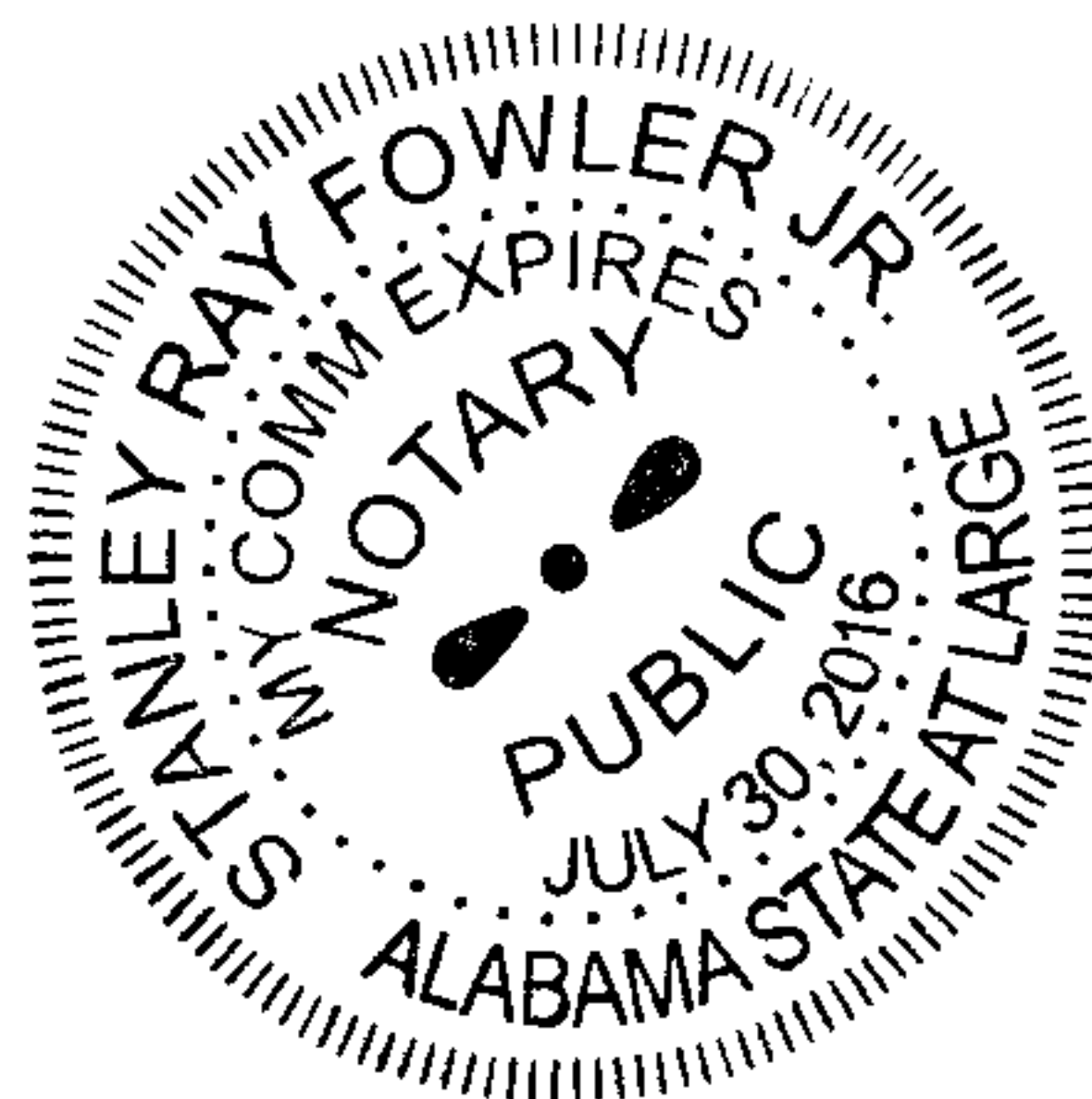
