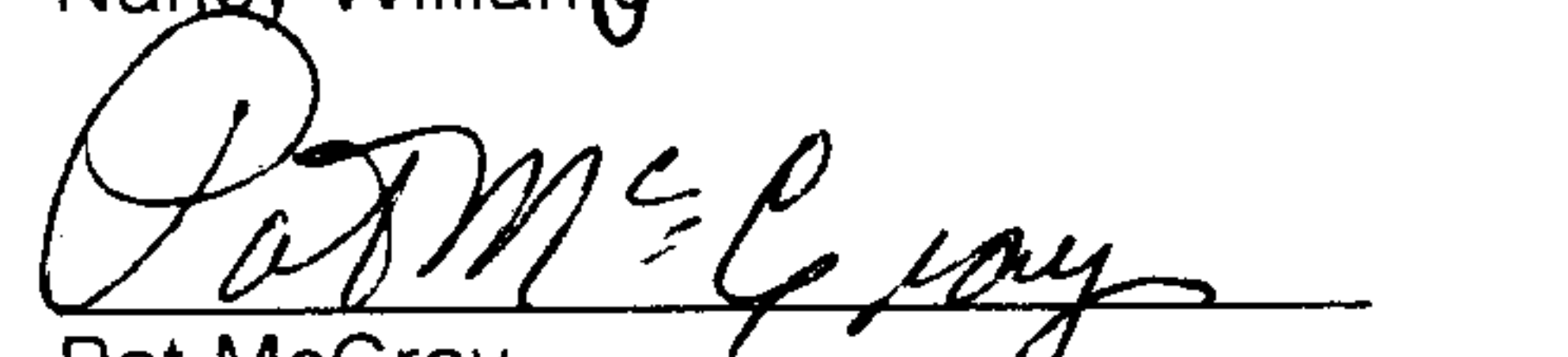
COLLATERAL TO BE RELEASED:

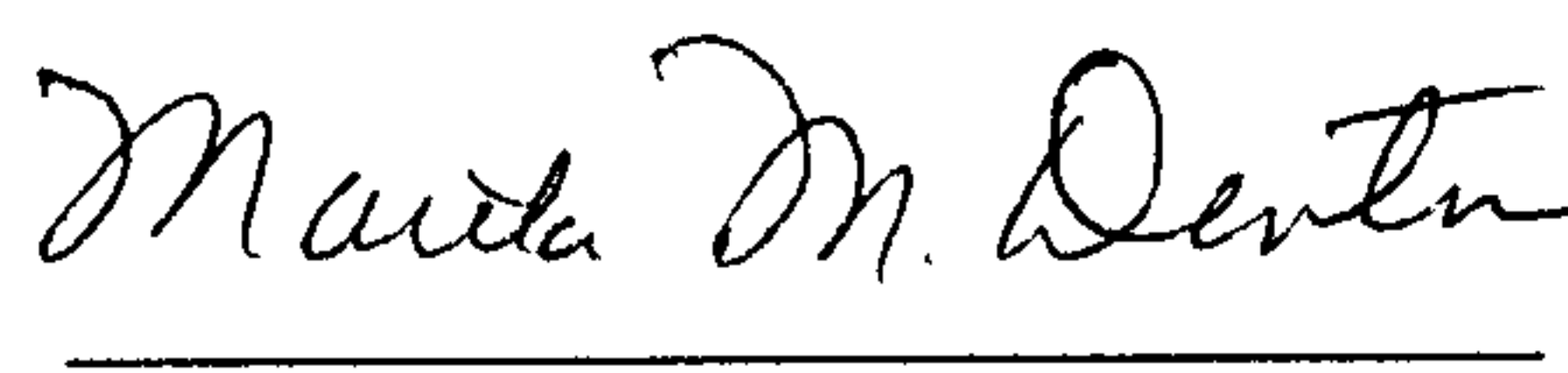
