


10	TO BE ENTITLED
11	AN ACT
12	
13	To alter, rearrange, and extend the boundary lines
14	and corporate limits of the City of Alabaster in Shelby
15	County.
16	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
17	Section 1. The boundary lines and corporate limits
18	of the City of Alabaster in Shelby County are altered,
19	rearranged, and extended to include within the corporate
20	limits of the municipality, in addition to the lands now
21	included, all of the following territory:
22	PARCEL A:
23	A parcel of land situated in the SE 1/4 of Section
24	5, Township 21 South, Range 2 West, in Shelby County, Alabama,
25	and being more particularly described as follows:
26	TO FIND the point of beginning, COMMENCE at the
27	Southeast Corner of Section 5, Township 21 South, Range 2
28	West; THENCE South 87 degrees 42 minutes 42 seconds West,
29	along the southerly boundary of the SE $1/4$ of the SE $1/4$ of

1	said section a distance of 78.58 feet to a point; THENCE South
2	87 degrees 42 minutes 42 seconds West along the last described
3	course, a distance of 261.26 feet to a point for the POINT OF
4	BEGINNING; THENCE North 49 degrees 05 minutes 57 seconds West,
5	a distance of 299.96 feet to a point; THENCE South 40 degrees
6	54 minutes 03 seconds West, a distance of 59.92 feet to a

19	arc distance of 69.08 feet, a radius of 400.00 feet, and a
20	chord of South 75 degrees 30 minutes 05 seconds East, a
21	distance of 68.99 feet to a point; THENCE South 70 degrees 33
22	minutes 14 seconds East, along said right-of-way line, a
23	distance of 282.45 feet to a point on the southerly boundary
24	line of the SE $1/4$ of the SE $1/4$ of said section; THENCE North
25	87 degrees 42 minutes 42 seconds East, along said southerly
26	boundary line and leaving said right-of-way line, a distance
27	of 564.38 feet to the POINT OF BEGINNING. Said parcel contains
28	15.66 acres, more or less.






1	LESS AND EXCEPT a prescriptive use right-of-way
