KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 12th day of December, 2007, James Thomas Roy and Tammy Lynette Edwards Roy husband and wife, executed that certain mortgage on real property hereinafter described to Gulfstates Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20071218000568520, said mortgage having subsequently been transferred and assigned to LPP Mortgage LTD, by instrument recorded in Instrument Number 20100414000114200, in the aforesaid Probate Office ("Transferee"); and

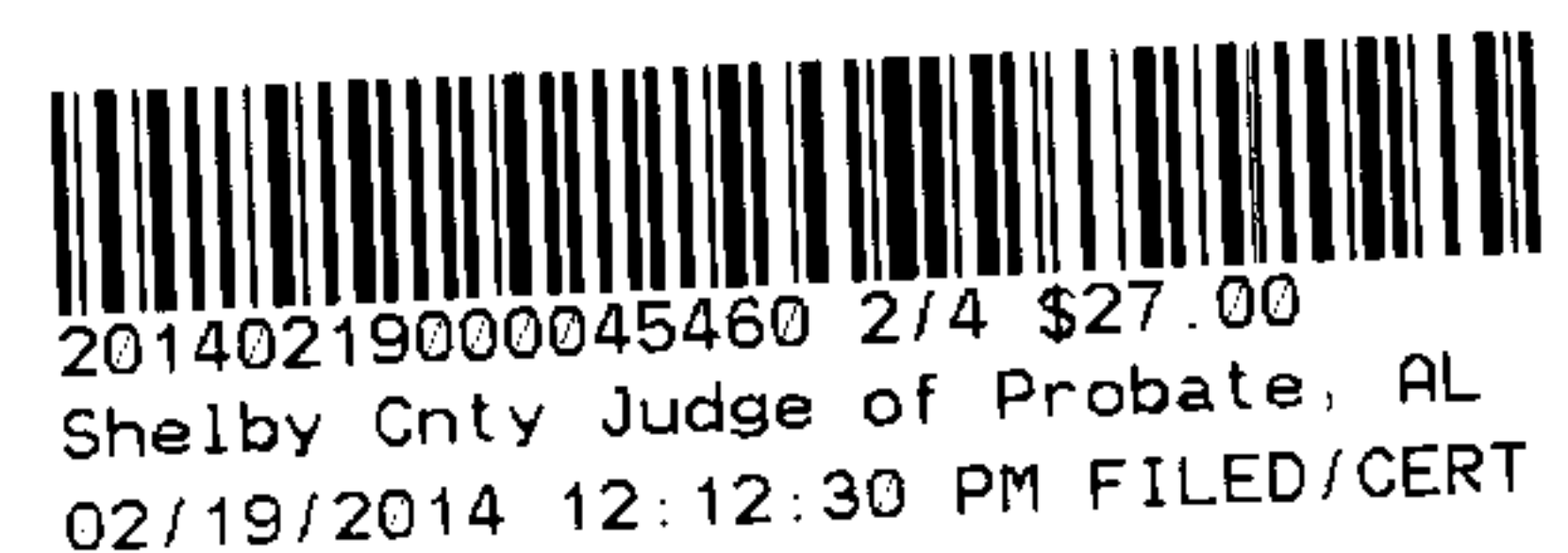

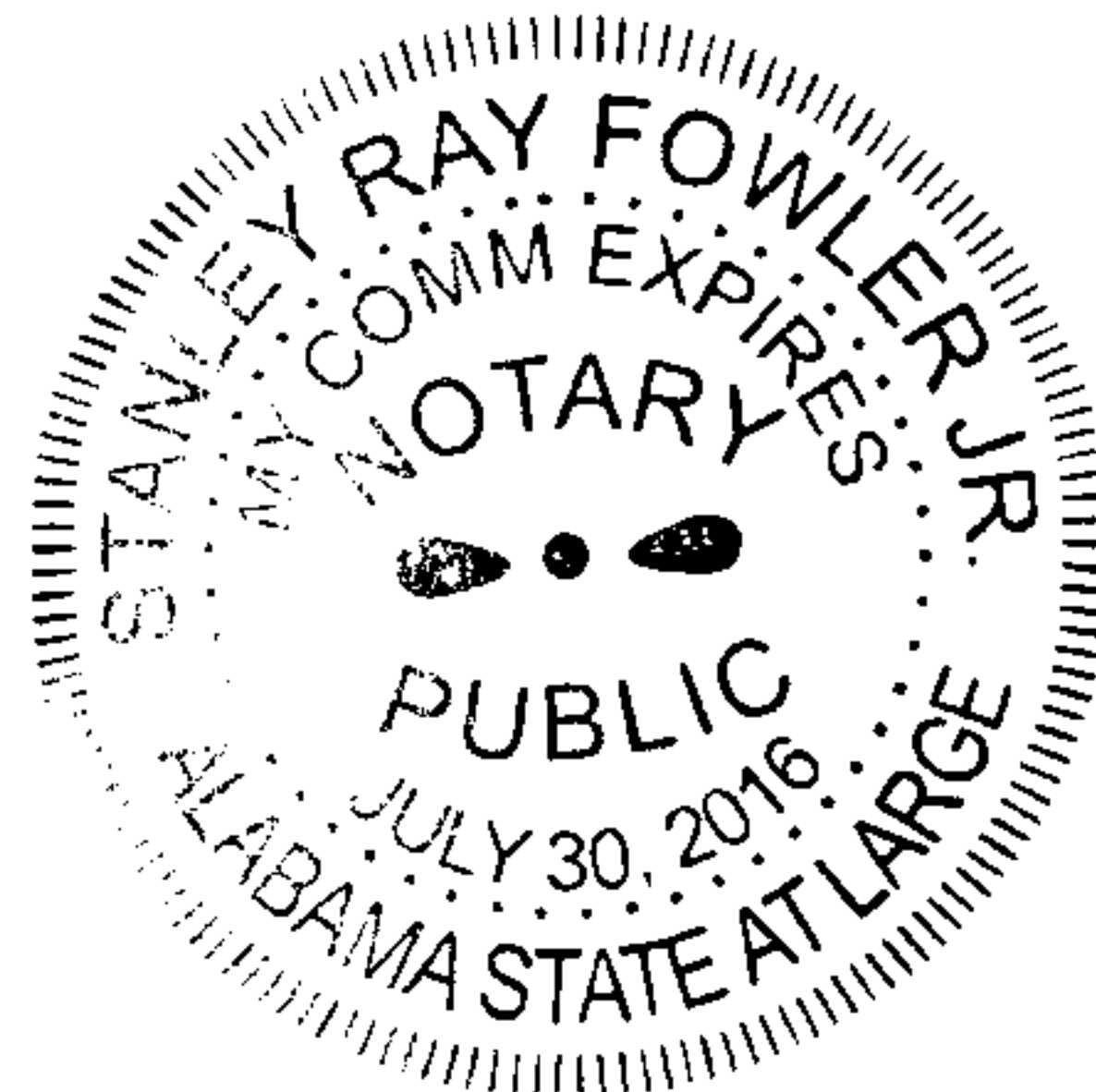
