Pursuant to the Alabama Limited Liability Company Act ("Act"), the undersigned acting as organizer of a limited liability company hereby adopts the following Limited Liability Company ("Company") Articles of Organization:

ARTICLE I

NAME

MATRIX MUSCLE CARS, LLC

ARTICLE II

DURATION

The period of duration shall be perpetual unless the Company shall be sooner dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act or the Operating Agreement.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

To own, manage, and operate a garage for repair of vehicles, buy and sell vehicles and to engage in any lawful business permitted under Alabama law as may be agreed upon by the Member(s).

ADMISSION OF ADDITIONAL MEMBERS


The Manager may permit the admission of Additional Members upon the unanimous consent of all Members of the Company.
