

CERTIFICATE OF FORMATION FOR

Article I

The name and address of the Organizer are as follows:

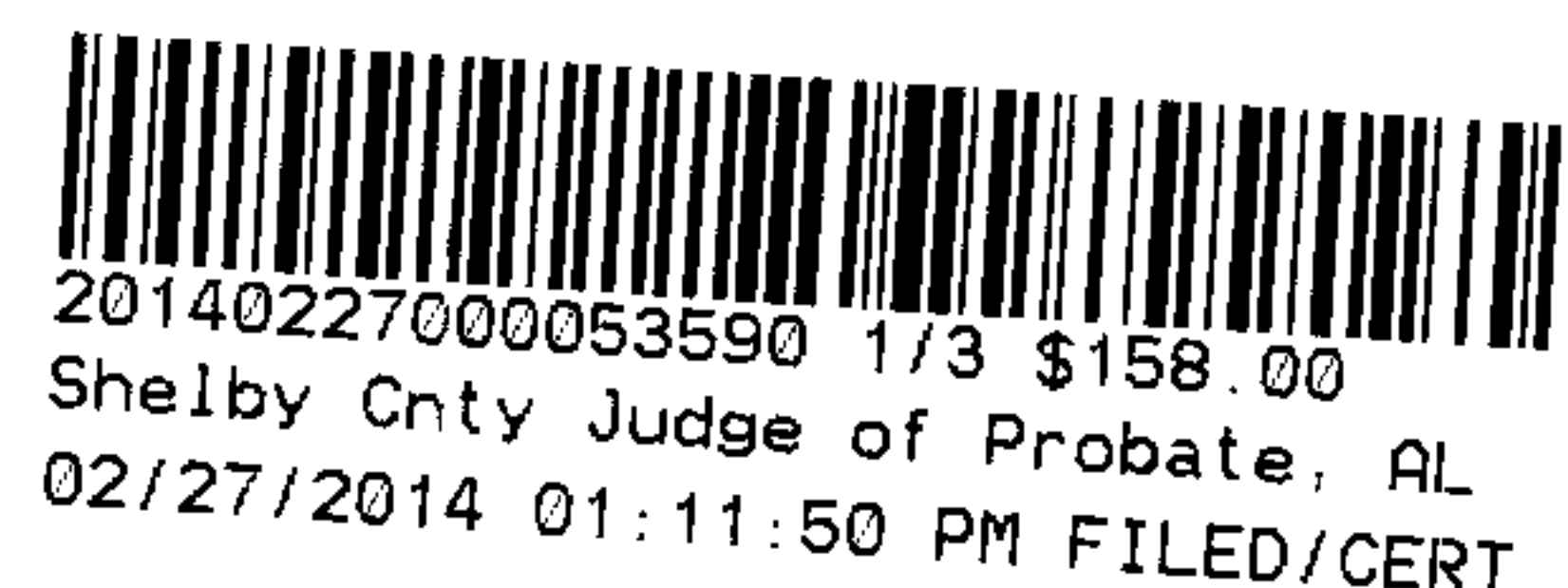

The filing of the limited liability company is effective immediately on the date filed by the judge of probate.



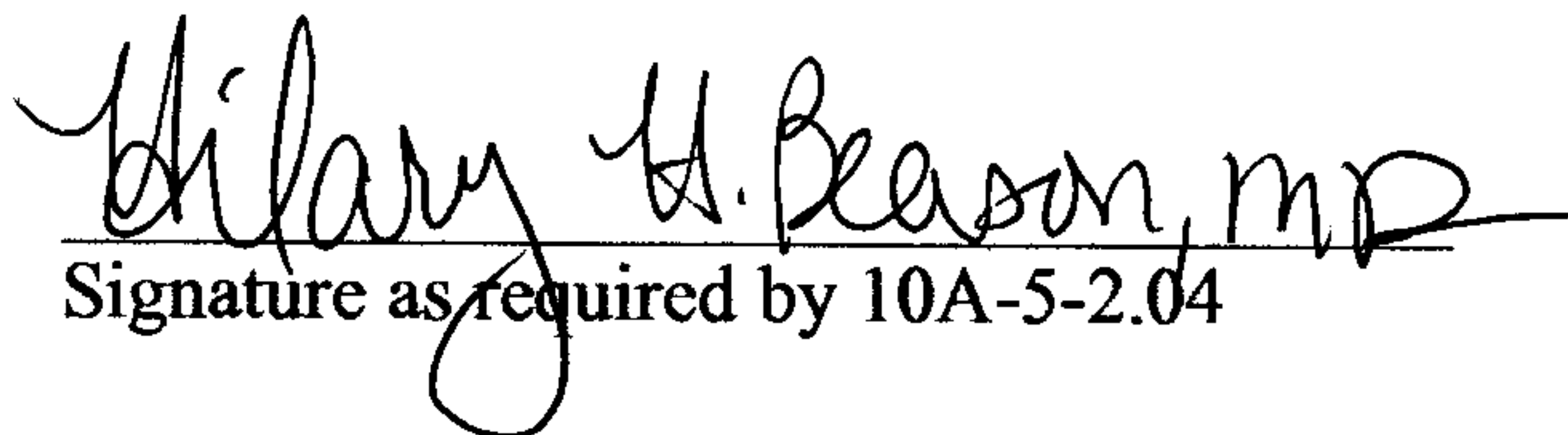
Article IX

The current member may, by a majority vote, allow a new member to join this limited liability company. A person may become a new member from an assignment of an interest in the limited liability company from an existing Member if the Member or Members vote(s) in majority to allow the assignee to become a member. If he or they do not so vote, then the assignee will be a non-member assignee. A Member can encumber his LLC interest by a security interest or other form of collateral only with the consent of a majority of the other Member(s). Such consent shall not be withheld if the proceeds of the encumbrance are contributed to the LLC to respond to a cash call of the LLC under the Operating Agreement. Said assignment is only valid if the Member who desires to make the assignment first offers to sell the interest to the limited liability company at the then existing set price. If the limited liability company does not purchase the interest, then an individual Member shall have that right. To the extent the limited liability company or non-assigning Member(s) do/does not buy the offered interest, the assigning Member can then assign the interest and, as stated, the assignee shall become a member if a majority of the existing Members vote to allow him to become a Member.

Article X

The cessation or dissociation of any member will not result in the dissolution of the limited liability company.
