That in consideration of the sum of **Two Hundred Seventy Five Thousand Dollars and No Cents (\$275,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **L. Daniel Joseph and Ashton Joseph, as husband and wife** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Brett Bolden and Kelly Bolden**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 1, according to the Final Plat of Joseph Family Subdivision, as recorded in Map Book 41, Page 145, in the Probate Office of Shelby County, Alabama.

\$245,073.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

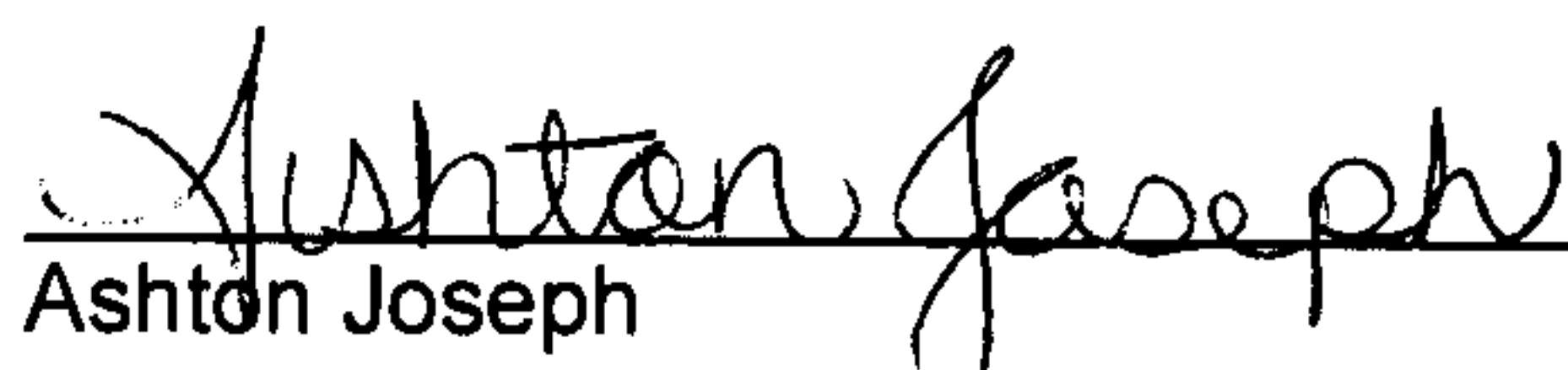

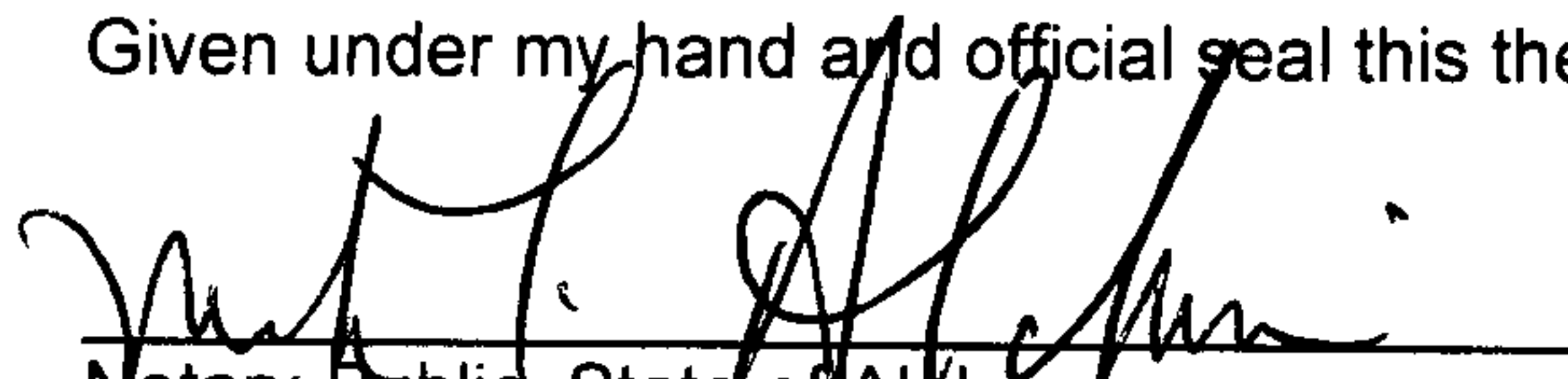

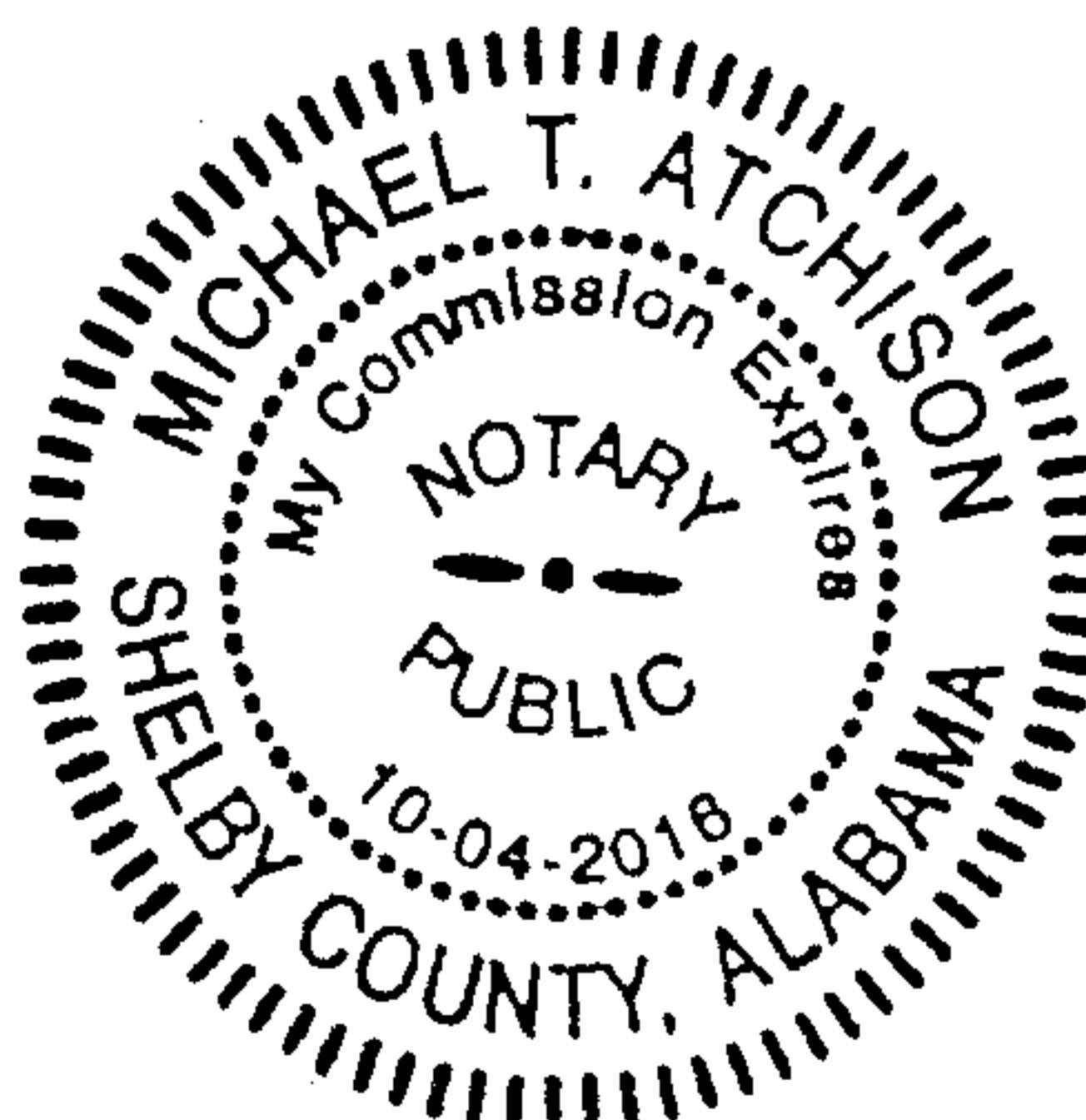
