

**CERTIFICATION OF TRUST

The undersigned, Michael P. Schmitt and Joyce E. Schmitt, being first duly sworn, deposes and says, they are at least 19 years of age and are currently acting trustees of the Schmitt Living Trust, and further states the following:

1. The Schmitt Living Trust is a valid, existing trust, having been created by Schmitt Living Trust dated June 26, 2007.
2.
 - A. The original settlors and successor settlor, if any, of the trust are Michael P. Schmitt and Joyce E. Schmitt.
 - B. The following persons contributed money, funds, real property or personal property to the trust: Michael P. Schmitt and Joyce E. Schmitt.
 - C. Michael P. Schmitt is alive and well. Joyce E. Schmitt is alive and well.
 - D. The name and address of the currently acting trustees are Michael P. Schmitt and Joyce E. Schmitt, 211 Kings Crest Lane, Pelham, AL 35124.
3. The Schmitt Living Trust has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.
4. Excerpts from the trust agreement that establish the trust, designate the Trustee and set forth powers of the Trustee will be provided upon request. The administrative and/or managerial powers of the trustees are shown on the Powers of Trustee, and include the power to acquire, sell assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.

 - A. The trust is revocable
 - B. The persons holding the power to revoke the trust are Michael P. Schmitt and Joyce E. Schmitt.

 - A. The following trustees have the authority to sign documents and instruments: Michael P. Schmitt and Joyce E. Schmitt
 - B. Michael P. Schmitt or Joyce E. Schmitt are required to sign.
7. The conditions for the succession of the successor trustees are vacancy.
8. The social security number assigned to the trust is the social security number of either Michael P. Schmitt and Joyce E. Schmitt.
9. Trust property should be titled as follows: Michael P. Schmitt and Joyce E. Schmitt, Trustees of the Schmitt Living Trust dated June 26, 2007, and any amendments thereto.
10. To the best of the undersigned's knowledge, the trust has not been revoked, modified or amended in any manner that would cause the representations and statements contained herein to be incorrect.

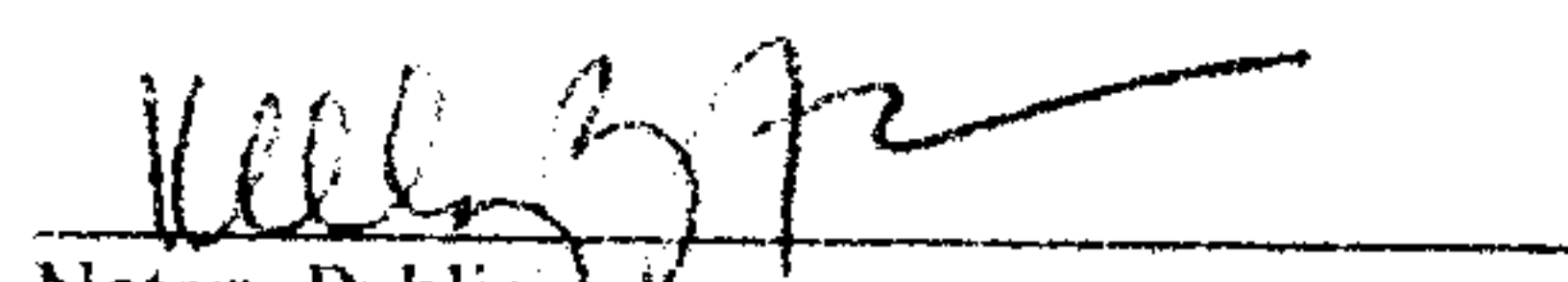
