

DURABLE POWER OF ATTORNEY

Know all men by these presents, which are intended to constitute a Durable Power of Attorney, that I, Nina M Shields, the undersigned, of Alabaster, Alabama, do hereby make, constitute and appoint my father, William Mullins, my true and lawful Attorney in Fact, for me and in my name, place and stead, and on my behalf and for my use and benefit.

To exercise or perform and act, power, duty, right, or obligation whatsoever that I now have, or may hereafter acquire the legal right, power of capacity to exercise or perform in connection with, arising from, or relating to any person, item, transaction, thing, business property, real or personal, tangible or intangible or whatsoever;

To request, ask, demand, sue for, recover, collect, receive, and hold and possess all such sums of money, debts, dues, commercial paper, checks, drafts, accounts, deposits, legacies, bequests, devises, notes, interests, stock certificates, bonds, dividends, certificates of deposit, annuities, pension and retirement benefits, insurance benefits and proceeds, any and all documents of title, choses in action, personal and real property, tangible and intangible property and property rights, and demands whatsoever, liquidated or unliquidated, as now are, or shall hereafter become, owned by me, or due, owing payable or belonging to me, or in which I have or may hereafter acquire interest, to have, use and take all lawful means and equitable and legal remedies, procedures, and writs in my name for the collection and recovery thereof, and to adjust, sell, compromise, and agree for the same, and to make, execute, and deliver for me, on my behalf and in my name, all endorsements, acquittances, releases, receipts, or other sufficient discharges for the same;

To lease, purchase, exchange, and acquire, and to agree, bargain and contract for the lease, purchase, exchange, and acquisition of, and to accept, take, receive, and possess any real or personal property whatsoever, tangible or intangible, or interest thereon, on such terms and conditions, and under such covenants, as my said Attorney in Fact shall deem proper.

To maintain, repair, improve, manage, insure, rent, lease, sell, convey, subject to liens, mortgage, subject to deeds of trust, and hypothecate, and in any way or manner deal with all or any part of any real or personal property whatsoever, tangible or intangible, or any interest therein, that I now own or may hereafter acquire, for me, in my behalf, and in my name and under such terms and conditions, and under such covenants, as my said attorney in Fact shall deem proper.


To conduct, engage in, and transact any and all lawful business of whatever nature or kind for me, on my behalf, and in my name.

To make, receive, sign, endorse, execute, acknowledge, deliver, and possess such applications, contracts, agreements, options, covenants, conveyances, deeds, trust deeds, security agreements, bill of sale, leases, mortgages, assignments, insurance policies, bills of lading, warehouse receipts, documents of title, bills, bonds, debentures, checks, drafts, bills exchange, letters of credit, notes, stock certificates, proxies, warrants, commercial paper, receipts, withdrawal receipts and deposit instruments relating to accounts or deposits in, or certificates of deposit of banks, savings and loan associations, credit unions, or other financial institutions or associations, proof of low, evidences of debt, releases, and satisfaction of mortgages, liens, judgments, security agreements and other debts and obligations and such other instruments in writing of whatever kind and nature as may be necessary or proper in the exercise of the rights and powers herein granted.

The rights, power and authority of my said attorney in Fact herein granted shall commence and be in full force and effect upon the disability, incompetence, or incapacity of the said principal, Nina M. Shields, and such right, powers, and authority shall remain in full force and effect thereafter until the death of the principal, Nina M. Shields, or until Ms Shields's disability, incompetency or incapacity is otherwise terminated. She shall be considered disabled, incompetent, or incapacitated when, in the opinion of two physicians, she is disabled or incapacitated to carry out the responsibilities due to physical condition. Nina M. Shields shall be considered mentally incompetent when, in the opinion of two physicians (one of whom is a psychiatrist), they together state that she is incompetent to look out after personal affairs. If, in the opinion of the physicians, Nina M. Shields has regained capacity, then the rights, powers and authority of said Attorney in Fact shall terminate.

To induce any third party to act hereunder, I hereby agree that any third party receiving a duly executed copy or facsimile of this power of attorney may act hereunder, and that revocation or termination hereof shall be ineffective as to such third party unless and until actual notice or knowledge of such revocation or termination shall have been received by such third party, and I, for myself and my heirs, executors, legal representatives and assigns, hereby agree to indemnify and hold harmless any such third party from and against any and all claims that may arise against such third party by reason of reliance upon this power of attorney.

IN WITNESS WHEREOF, I HAVE EXECUTED THIS POWER OF ATTORNEY ON THE 17th
 DAY OF December AND I HAVE DIRECTED THAT PHOTOGRAPHIC COPIES OF THIS
 POWER BE MADE WHICH SHALL HAVE THE SAME FORCE AND EFFECT AS AN ORIGINAL.
