<u>CONSENT ORDER ON DISCHARGEABILITY OF INCOME TAXES, INTEREST AND PENALTIES OWED</u> TO THE UNITED STATES OF AMERICA AND ITS AGENCY THE INTERNAL REVENUE SERVICE AND THE STATE OF ALABAMA AND ITS AGENCY THE ALABAMA DEPARTMENT OF REVENUE

On April 11, 2013, the Plaintiff filed a Complaint to Determine Dischargeability of Debt of Income Taxes, Interest and Penalties which was owed to the Internal Revenue Service and the Alabama Department of Revenue for the tax years 2006 and 2007. This case was set for a pretrial conference on June 5, 2013. Prior to that date, counsel for the respective parties informed the Court that they had reached an agreement as to the disposition of the allegations contained in the complaint. Based on that agreement;

It is hereby ORDERED that the Plaintiff's liability for the tax, interest and penalty for the income tax years 2006 and 2007 is determined to be a DISCHARGEABLE debt and IS NOT EXCEPTED from the Plaintiff's discharge in this case; and,

It is hereby ORDERED that this consent order shall only be applicable to the Plaintiff's income tax liability owed to the Internal Revenue Service and the Alabama Department of Revenue for the tax years 2006 and 2007 and shall not be applicable to any other tax liability which may be owed by the Plaintiff to the Internal Revenue Service or the Alabama Department of Revenue; and,

It is hereby further ORDERED that the Clerk of this Court is to close this Adversary Proceeding.
