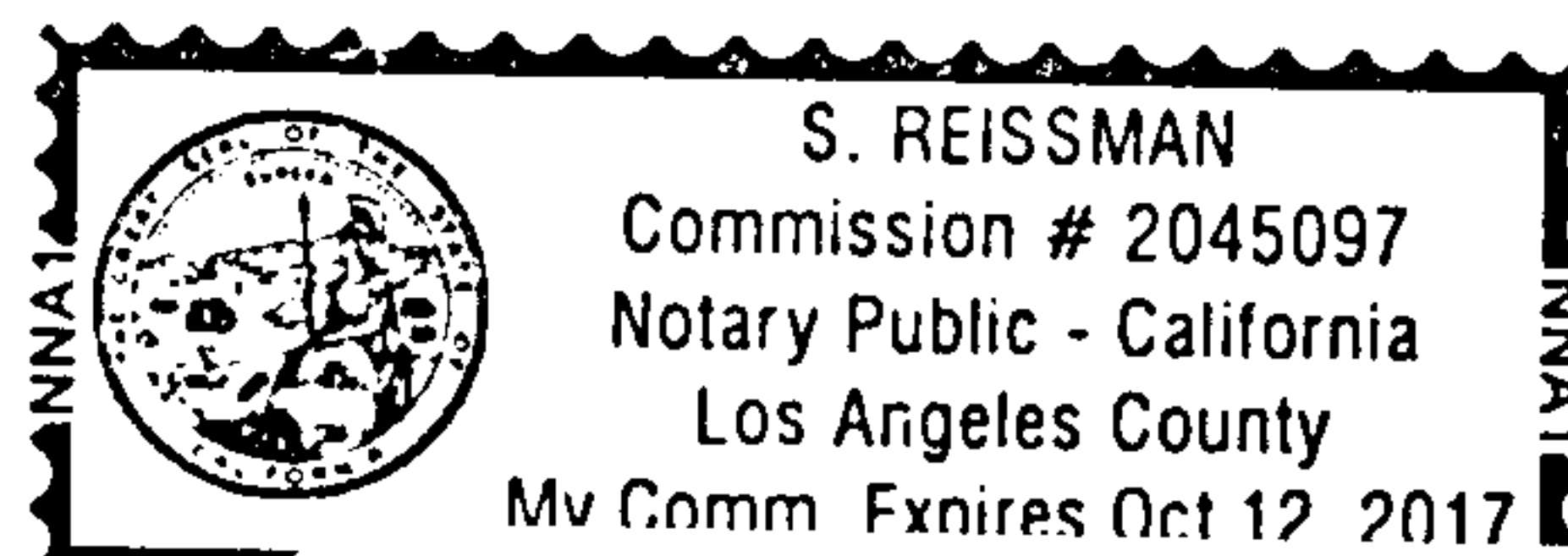

INSTRUCTIONS FOR COMPLETING THIS FORM
