**GENERAL WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **One Hundred Thirty-Nine Thousand Nine Hundred and NO/100 Dollars (\$139,900.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**Jason Jones and Kathryn L. Jones, husband and wife**

(herein referred to as Grantor), grants, bargains, sells and conveys unto

**Kenneth A. Gilliam and Kathryn B. Helms**

(herein referred to as **Grantees**), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

**LOT 95, ACCORDING TO THE SURVEY OF ST. CHARLES PLACE, MAGNOLIA PARK, PHASE 3, SECTOR 4, AS RECORDED IN MAP BOOK 22, PAGE 144, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.**
