**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
DEVDAV INVESTMENTS, L.L.C.**

Pursuant to Code of Alabama (1975), Sections 10A-1-3.13, 10A-1-3.17 and 10A-5-2.03, the undersigned, being all of members of Devdav Investments, L.L.C., a limited liability company organized and existing under the laws of the State of Alabama, hereby submits the following:

Whereas, the Articles of Organization of the limited liability company were filed in the office of the Judge of Probate of Shelby County, Alabama on February 2, 2004; and

Whereas, the limited liability company was assigned Alabama Entity Number 697-144; and

Whereas, the member of the limited liability company desires to amend and restate the Articles of Organization of the limited liability company;

Now, therefore, in consideration of the premises, the Articles of Organization of the limited liability company are hereby amended, superseded and restated as follows:

**ARTICLE I**  
**NAME**

The name of the limited liability company is Devdav Investments, L.L.C.

**ARTICLE II**  
**DURATION**

The existence of the limited liability company commenced on February 2, 2004, being the date of the filing of the original Articles of Organization in the office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members, (b) as provided in the Operating Agreement, or (c) as may be required by the Alabama Limited Liability Company Law.

**ARTICLE III**  
**PURPOSE**

The purpose for which this limited liability company is organized is to engage in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.

ARTICLE IV  
REGISTERED AGENT AND REGISTERED OFFICE.

The location and mailing address of the registered office and the name of the registered agent at said address, until changed pursuant to the provisions of the Operating Agreement and in accordance with the Alabama Limited Liability Company Law, are as follows:

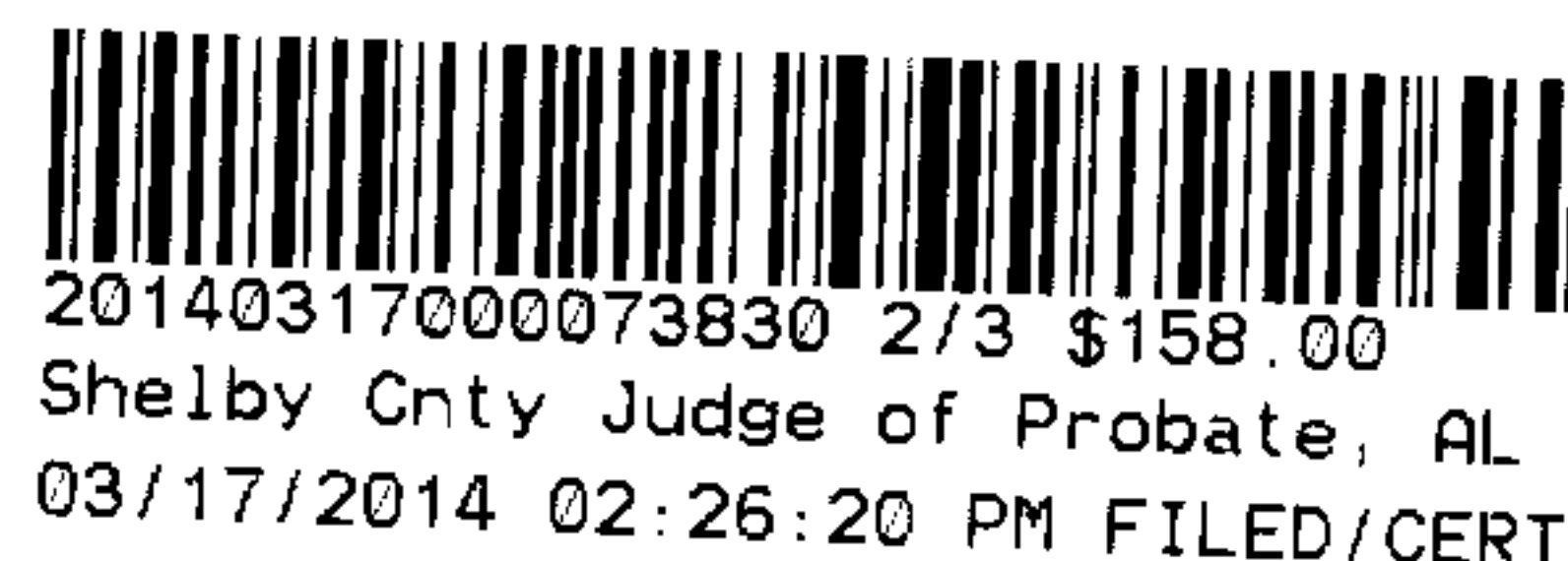
ARTICLE VI

The members of the limited liability company shall have the right to admit additional members to the limited liability company, as provided in the Operating Agreement.





