## Quit Claim Deed

WITNESSETH, the Grantor, for and in consideration of the sum of \$1.00 dollars, and other valuable consideration paid to the Grantor, the receipt of which is hereby acknowledged, do by the presents, Remise, Release and forever all of my right, title and interest unto the Grantee the following described real estate, tact of parcel of land, lying and being situate in the County of Shelby and the State of Alabama, to wit:

Commence at the Southwest corner of the Northeast one-forth of the Northwest one-fourth of Section 9, Township 19 South, Range 2 East, Shelby County, Alabama, thence proceed North along the West boundary of said quarter-quarter section for a distance of 390.0 feet to the point of beginning. From this beginning point turn an angle of 101 degree 57 minutes to the right and proceed south 78 degrees 03 minutes East for a distance of 1034.5 feet to a point on the West right of way line of the Harpersville-Calcis Road; thence proceed Northeasterly along the Westerly right of way line of said road for a distance of 510.0 feet, more or less, to a point that is South 85 degrees 16 minutes East of and 1277.43 feet from; thence proceed North 85 degrees 16 minutes West for a distance of 1277.43 feet to a point on the West boundary of said quarter-quarter section; thence proceed South along the West boundary of said quarter-quarter section for a distance of 335.0 feet to appoint of beginning.
