**MEMORANDUM
OF
SITE LICENSE ACKNOWLEDGMENT**

THIS MEMORANDUM OF SITE LICENSE ACKNOWLEDGMENT (this "Memorandum") is made this 14 day of May, 2013, and is by and between Global Signal Acquisitions II LLC, a Delaware limited liability company, with its principal offices at 2000 Corporate Drive, Canonsburg, Pennsylvania 15317, hereinafter designated "Licensor," and New Cingular Wireless PCS, LLC, a Delaware limited liability company, with its principal offices located at 12555 Cingular Way, Suite 1300, Alpharetta, GA 30004, hereinafter designated "Licensee".

1. Licensor and Licensee entered into a Site License Acknowledgment on March 30, 1998 (the "SLA"), as may have been amended, for a term of not less than fifteen (15) years ("Revised Term") pursuant to a Master License Agreement executed as of July 1, 2005, as may have been amended (the "MLA").

2. In consideration of the payments and other obligations of the parties under the MLA and this SLA, Licensor licensed to Licensee the use of a certain portion of property located in Shelby County, State of Alabama (the "Licensed Space"), as more specifically described in Exhibit 1 attached hereto and made a part hereof, together with a non-exclusive license for ingress and egress, extending to a public right of way.

3. The SLA initially commenced on May 1, 1998, with the Revised Term beginning on May 1, 2008, and copies of the MLA and SLA are on file in the offices of Licensor and Licensee.

4. The terms, covenants and provisions of the SLA and the MLA of which this is a Memorandum, shall extend to and be binding upon the respective administrators, successors and assigns of Licensor and Licensee.
