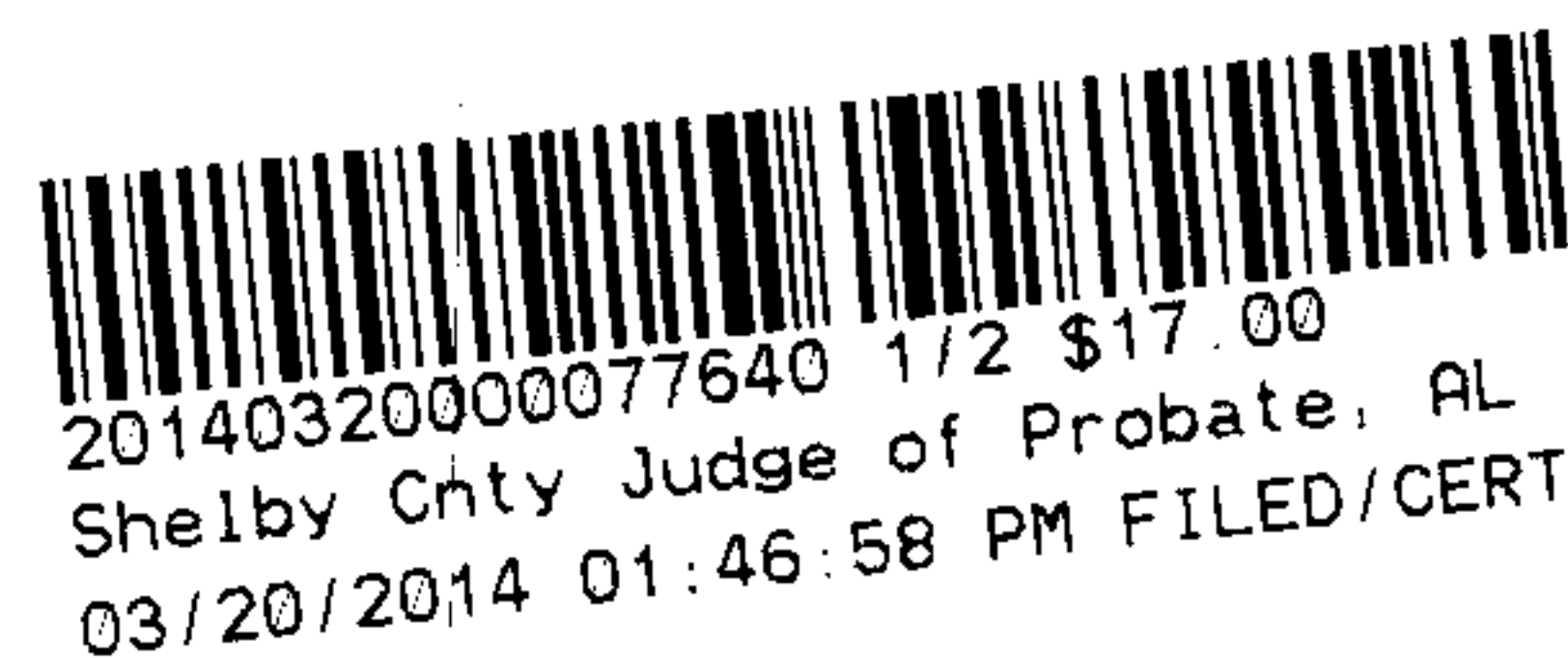

3. The present Trustees of the Trust (the "Trustees") are:





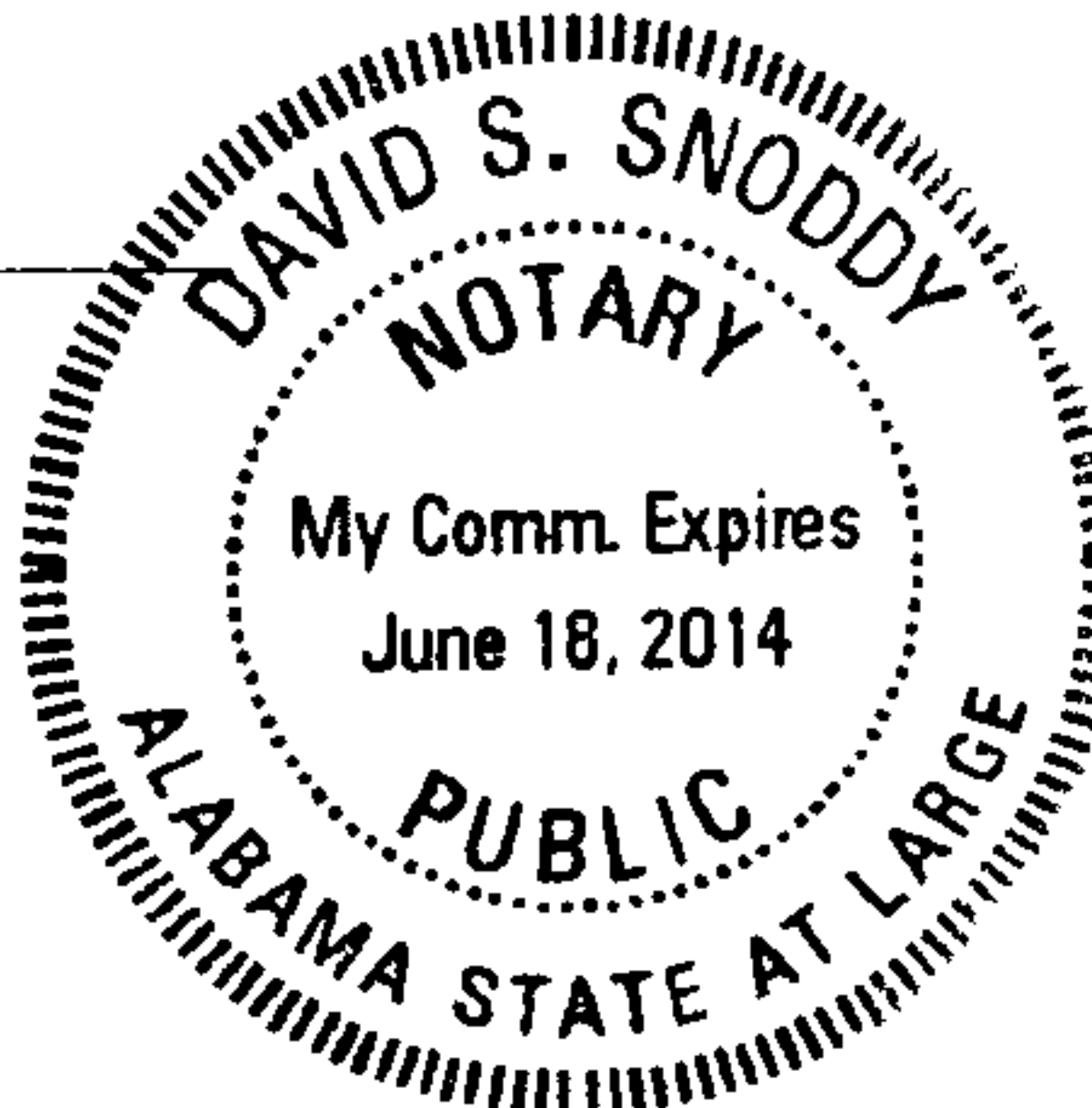
