- STEP 1:** THE NAME OF THE LIMITED LIABILITY COMPANY MUST CONTAIN THE WORDS LIMITED LIABILITY COMPANY, LLC OR L.L.C.
STEP 2: FILE THE ORIGINAL AND TWO COPIES OF THE ARTICLES OF ORGANIZATION IN THE COUNTY WHERE THE LLC'S REGISTERED OFFICE IS LOCATED. THE SECRETARY OF STATE'S FILING FEE IS \$100. FOR JEFFERSON COUNTY JUDGE OF PROBATE THE FILING FEE IS \$83 AND FOR SHELBY COUNTY JUDGE OF PROBATE FILING FEE IS \$58

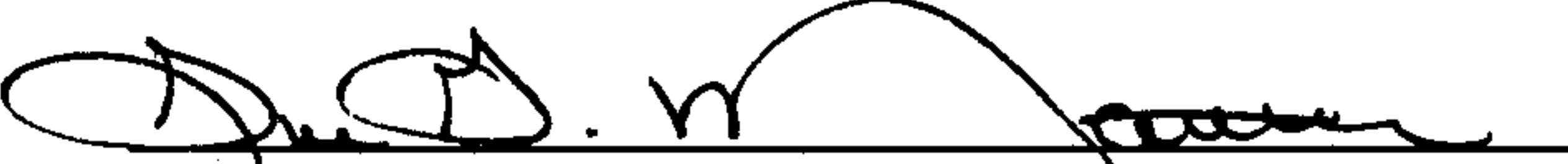
