KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of March, 2005, Scott Machan and Joyce S. 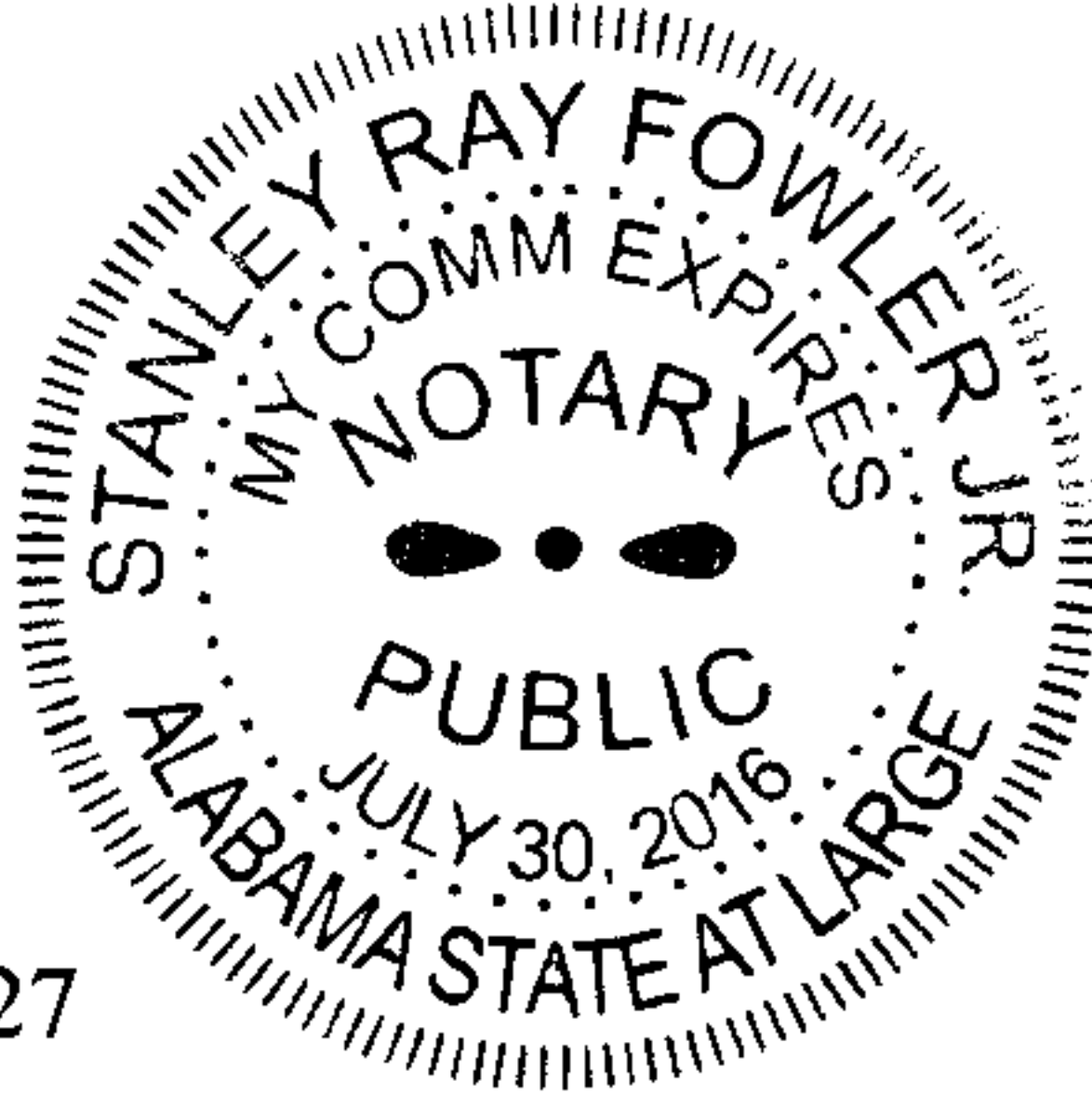

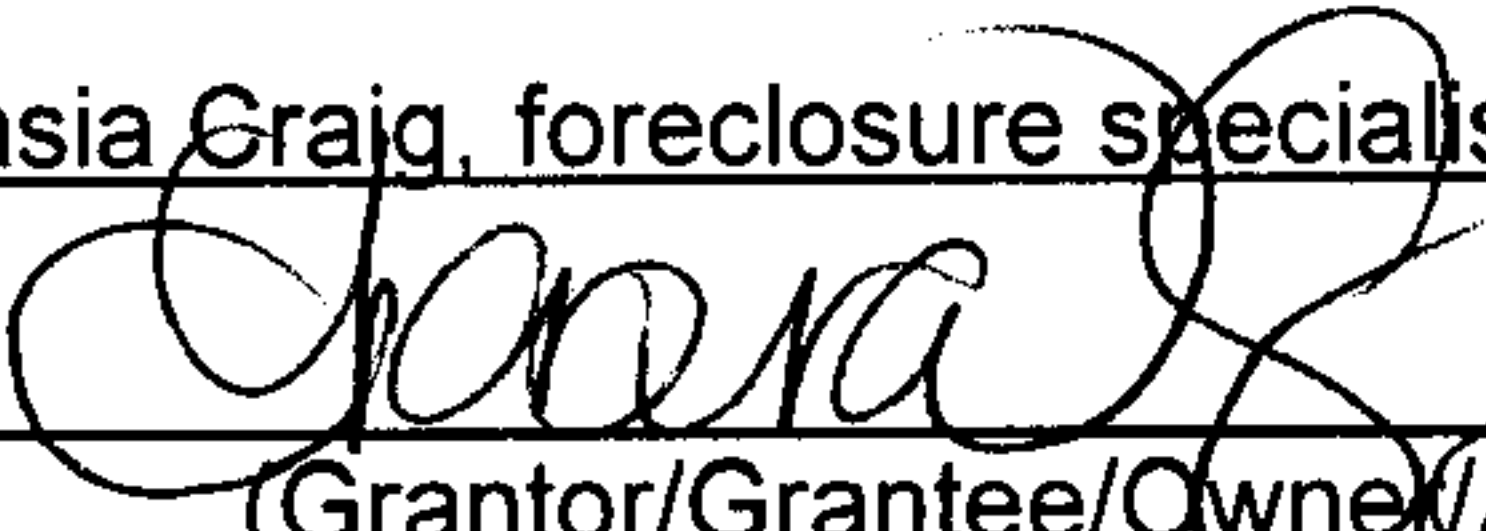
