WITH REMAINDER TO SURVIVOR

Know all Men by these Presents: That, in consideration of One Hundred Eighty Nine Thousand and No/100ths Dollars (\$189,000.00) and other good and valuable consideration to them in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **LENNIE J. LOGAN AND DANA Y. LOGAN, Husband and Wife** (herein referred to as "Grantors") do by these presents grant, bargain, sell and convey unto **CHRISTY WALTON AND CHRISTOPHER WALTON** (herein referred to as "Grantees") for and during their joint lives and, upon the death of either of them, then to the survivor, in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 69, according to the survey of Southern Hills, Sector 6, Phase 2, as recorded in Map Book 18, page 79, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

This conveyance is subject to subdivision restrictions, utility, drainage and sewer easements, and minimum setback lines, if any, applicable to the aforesaid property appearing of record in the Office of the Judge of Probate of Calera, Shelby County, Alabama. This conveyance is also subject to any prior reservation, severance or conveyance of minerals or mineral rights, taxes and assessments for the year 2014 and all subsequent years, and the following:

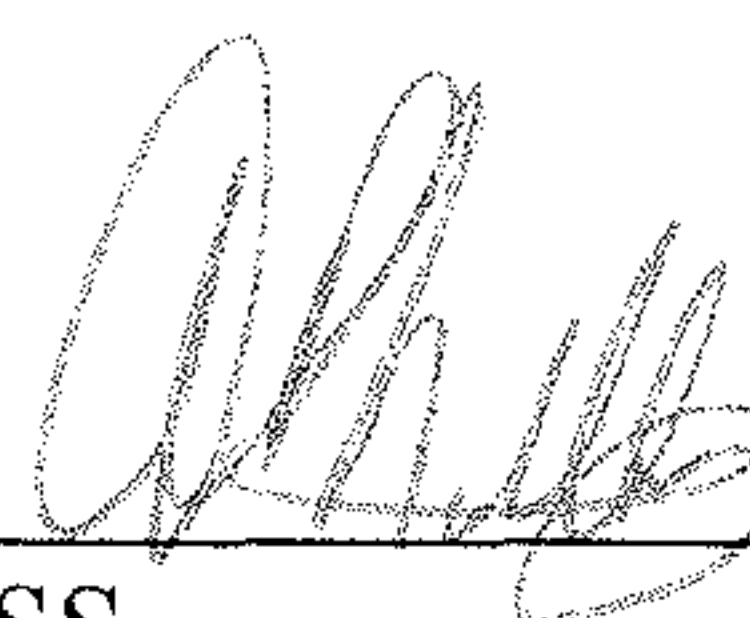
1. **Building Setback line of 30 feet reserved from East Milgray, as shown per plat.**
2. **Utility easements as shown by recorded plat, including, 7.5 feet on the southwesterly side, 7.5 feet on the northeasterly side, and a 15 foot easement through the southwesterly corner of lot.**
3. **Restrictions, covenants, and conditions as set out in Inst. No. 1994-18720, in Probate Office, but omitting any covenants or restrictions, if an, based upon race, color, religion, sex, sexual orientation, familial status, marital status, disability, handicap, national origin, ancestry, or source of income, as set forth in applicable state or federal laws, except to the extent that said covenant or restriction is permitted by applicable law.**
4. **Restrictions, limitations and conditions as set out in Plat Book 18, page 79, in the Probate Office of Shelby County, Alabama.**
5. **Transmission Line Permit(s) granted to Alabama Power Company as shown by instrument(s) recorded in Deed Book 212, page 100, in Probate Office.**
6. **Right(s) of Way(s) granted to Alabama Power Company, as set out in Deed Book 220, page 40 and Deed Book 217, page 100, in the Probate Office.**

And the said Grantors do, for themselves, their heirs and assigns, covenant with said Grantees, their heirs and assigns, that they are lawfully seized in fee simple of said premises, that it is free from all encumbrances, except as otherwise noted above, that they have a good right to sell and convey the same as aforesaid, and that they will and their heirs and assigns shall **Warrant and Defend** the premises to the said Grantees, their heirs, personal representatives and assigns forever, against the lawful claims of all persons.

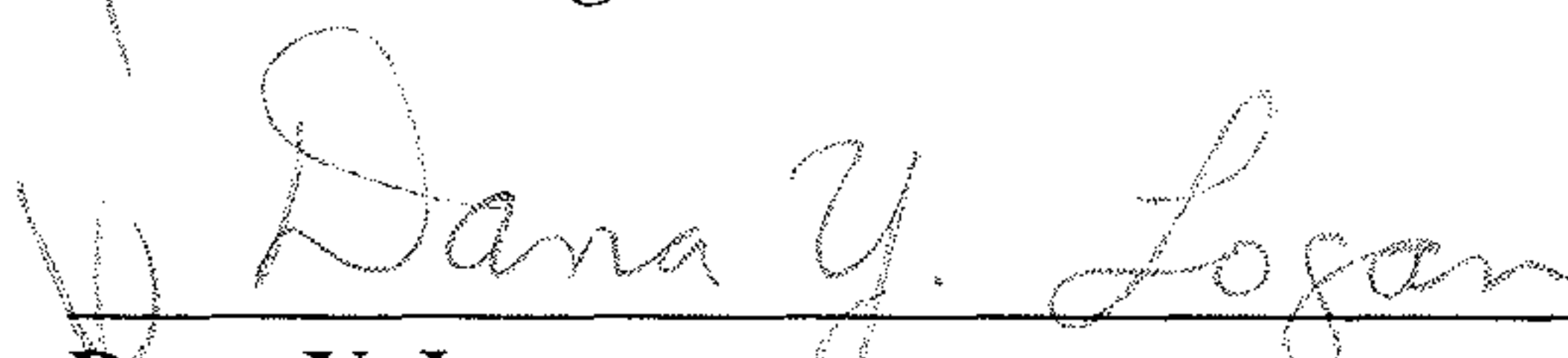

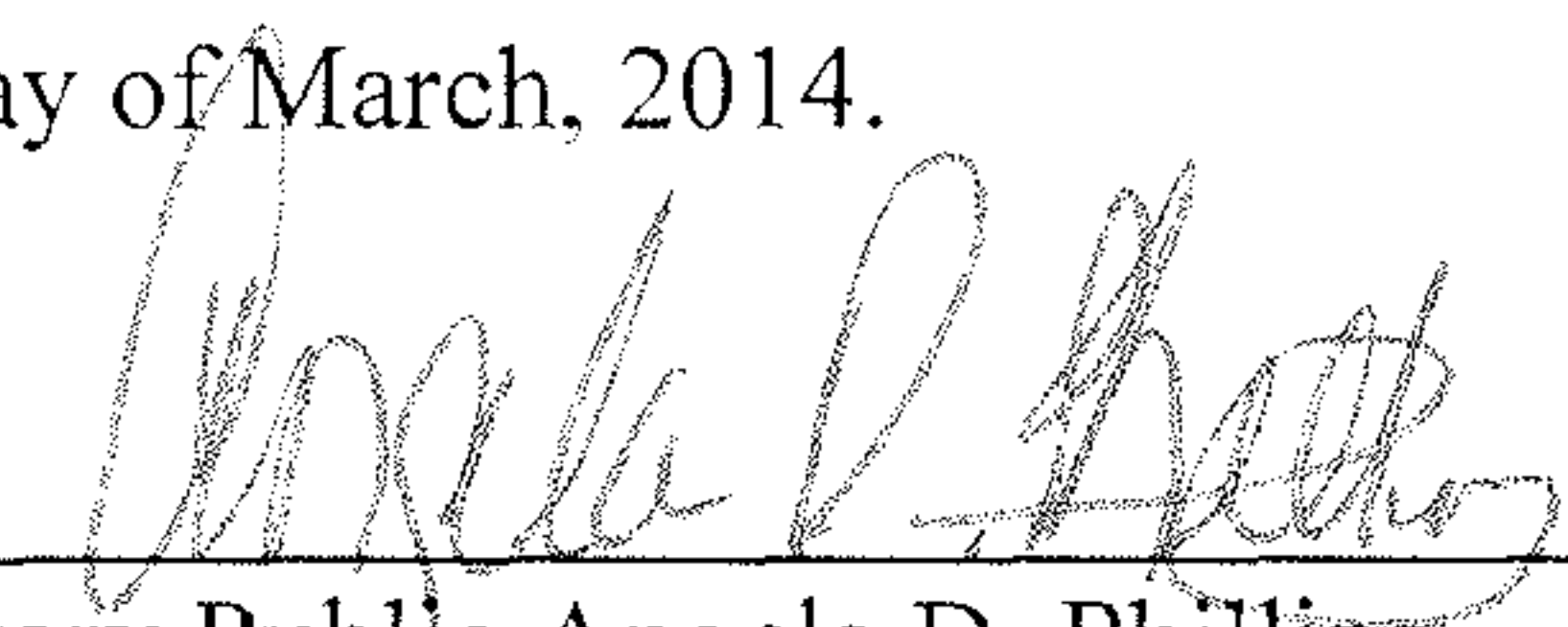

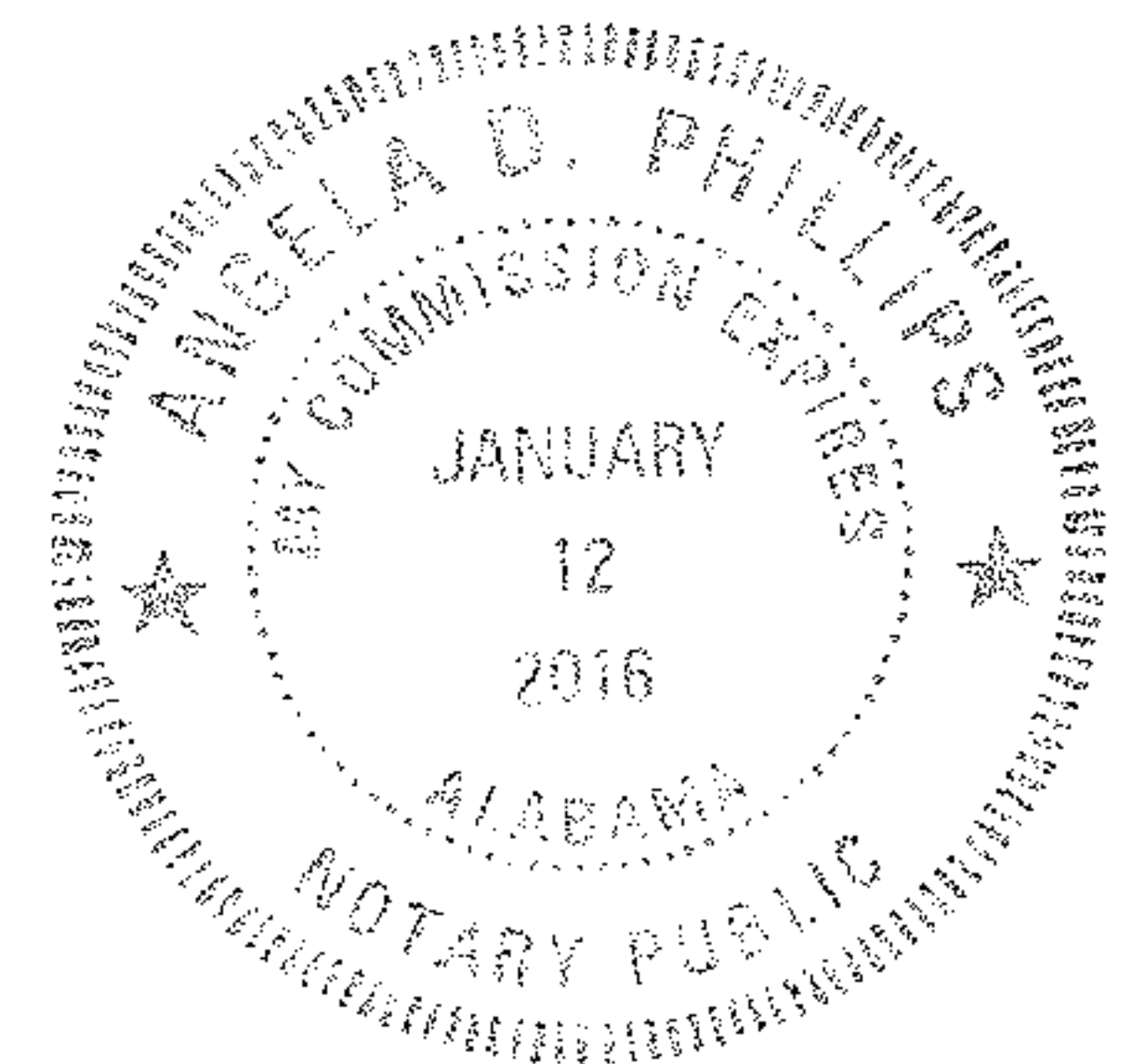
