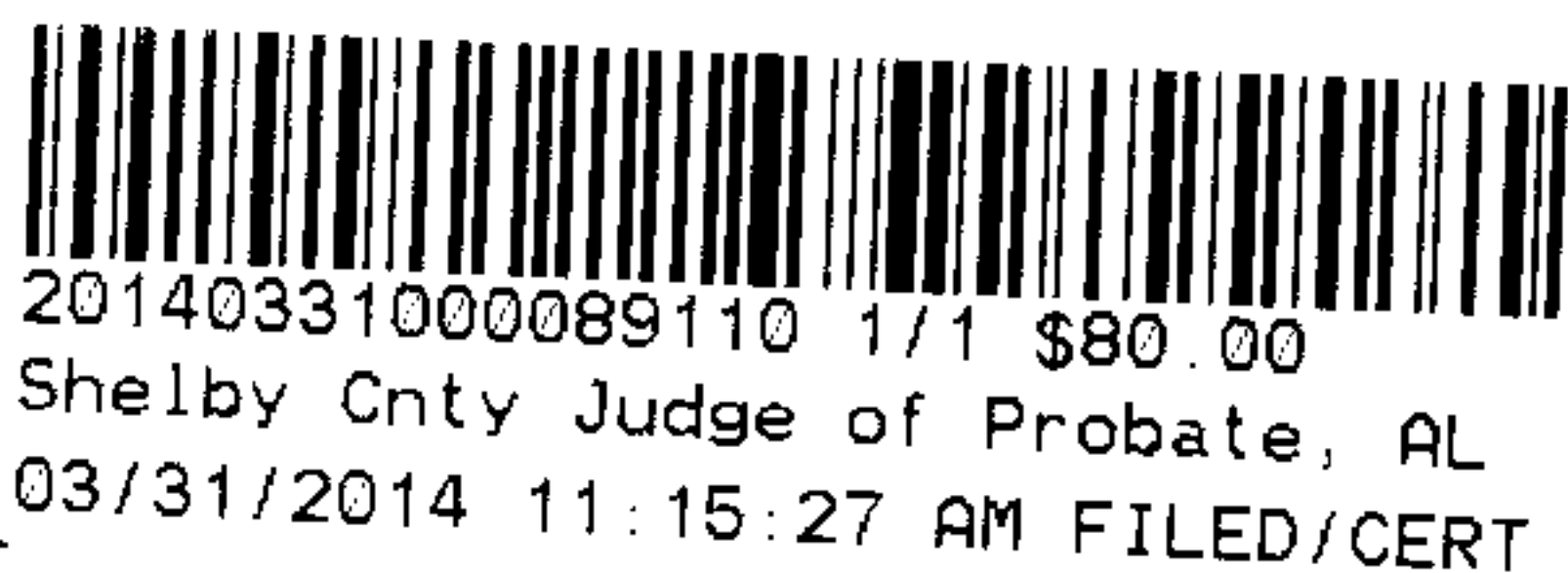
\$ 263,300.00 of the purchases price recited above was paid from a mortgage loan closed simultaneously herewith.
