KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of September, 2007, Kenny F. Shiver and Crystal Lynn Shiver, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Mortgage Professionals, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070925000448460, said mortgage having subsequently been transferred and assigned to Trustmark National Bank, by instrument recorded in Instrument 20140207000035010, in the aforesaid Probate Office ("Transferee"); and




