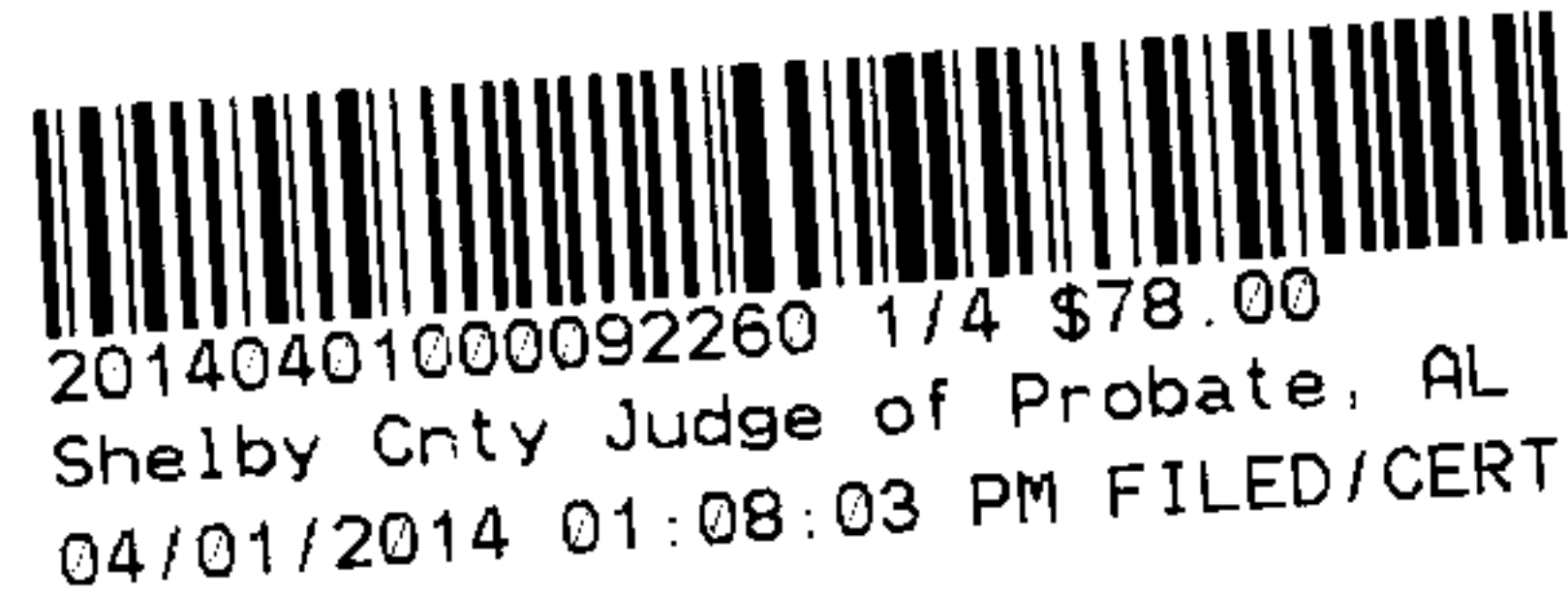

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 17th day of December, 2004, Sid Gurram and Helen Gurram, husband and wife, executed that certain mortgage on real property hereinafter described to Long Beach Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20041229000704430, said mortgage having subsequently been transferred and assigned to JP Morgan Chase Bank, National Association, by instrument recorded in Instrument Number 20120914000350320, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, on March 17, 2014, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and JP Morgan Chase Bank,



National Association did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

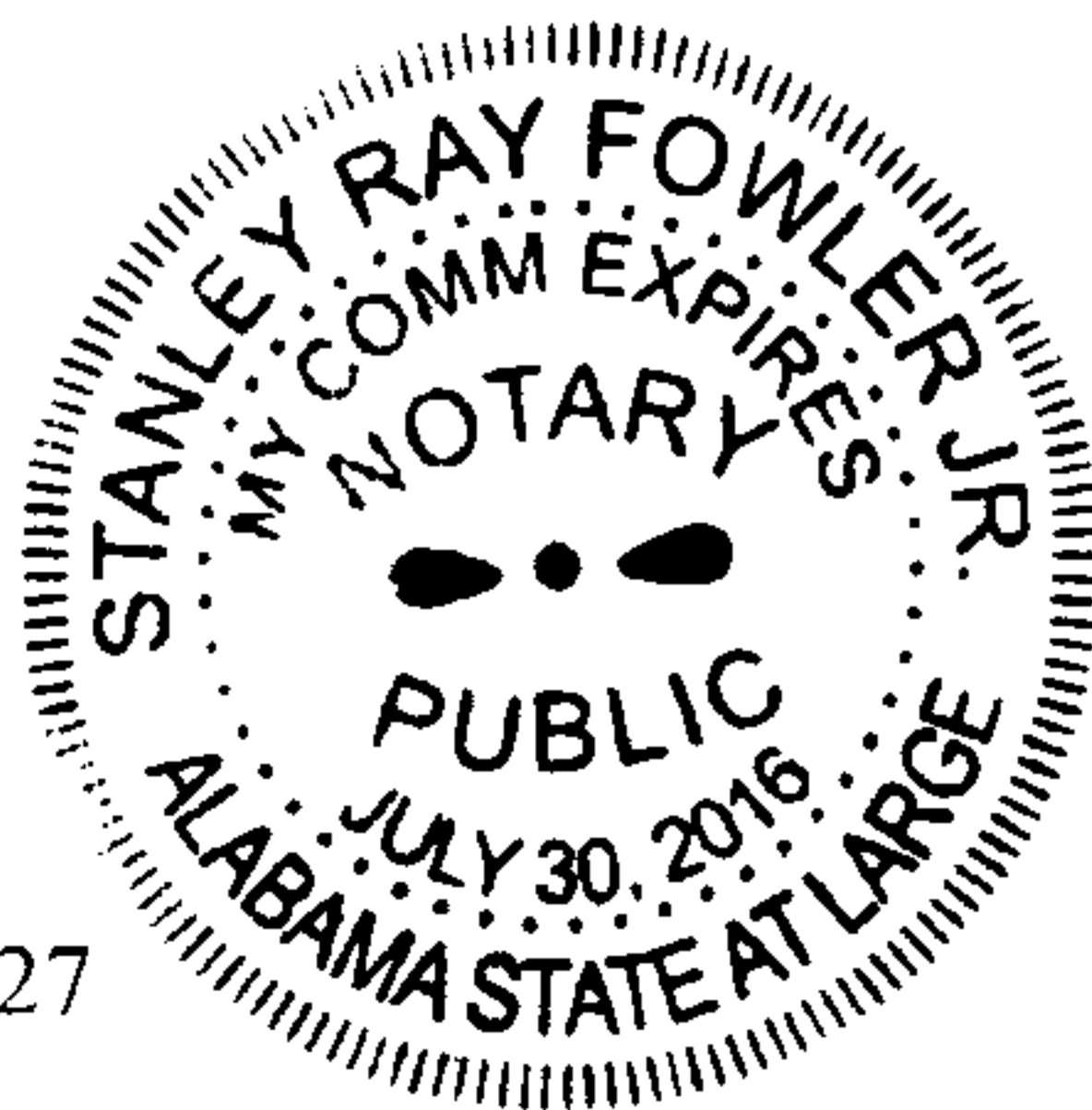



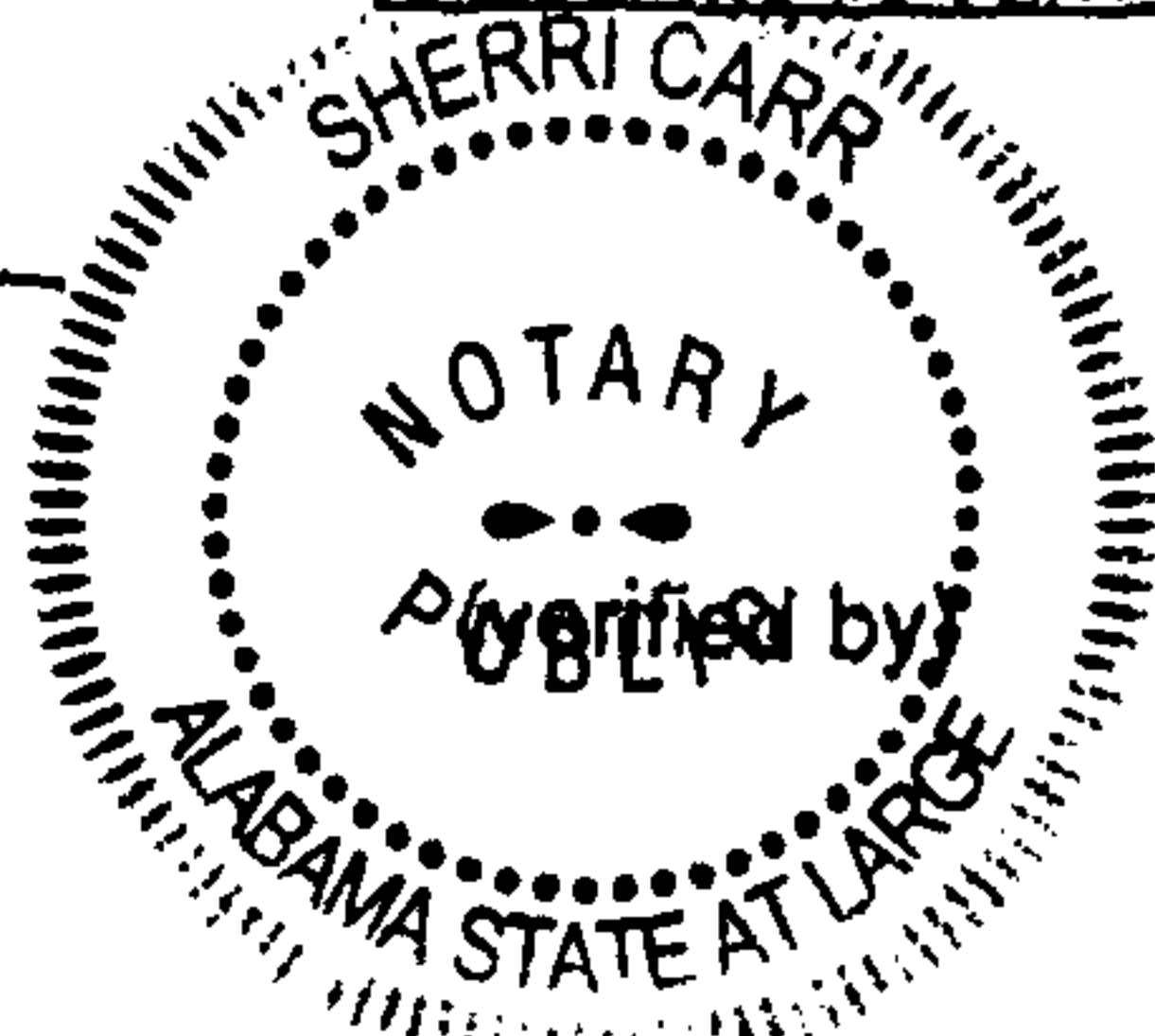
