
**WHEREAS**, the Mortgagor has requested the Mortgagee to satisfy and release the Mortgage;

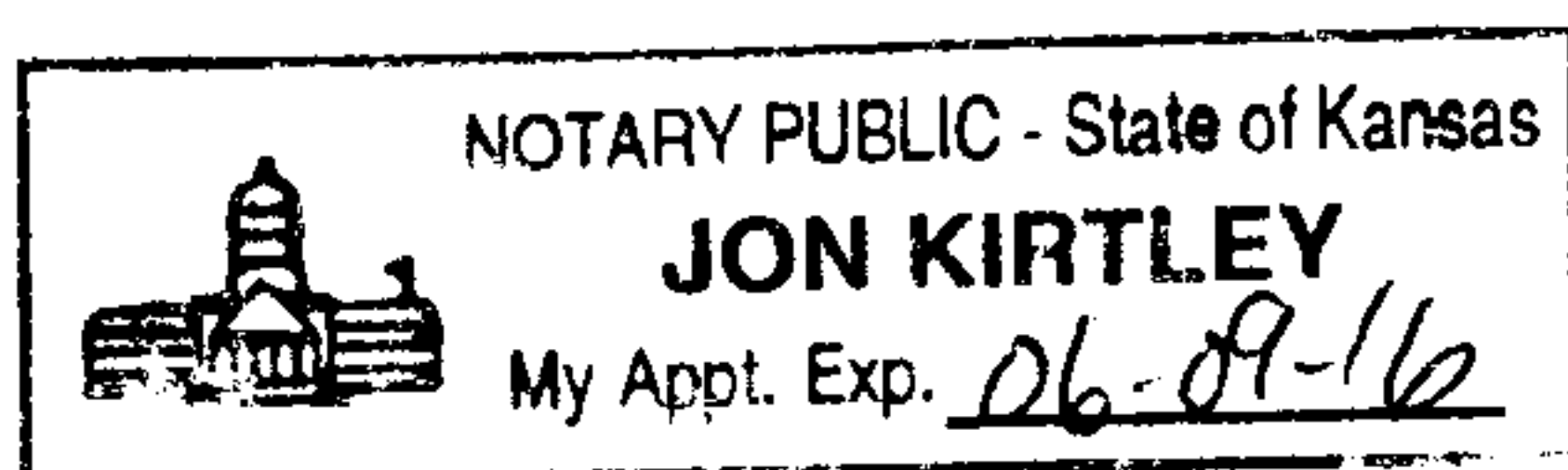
