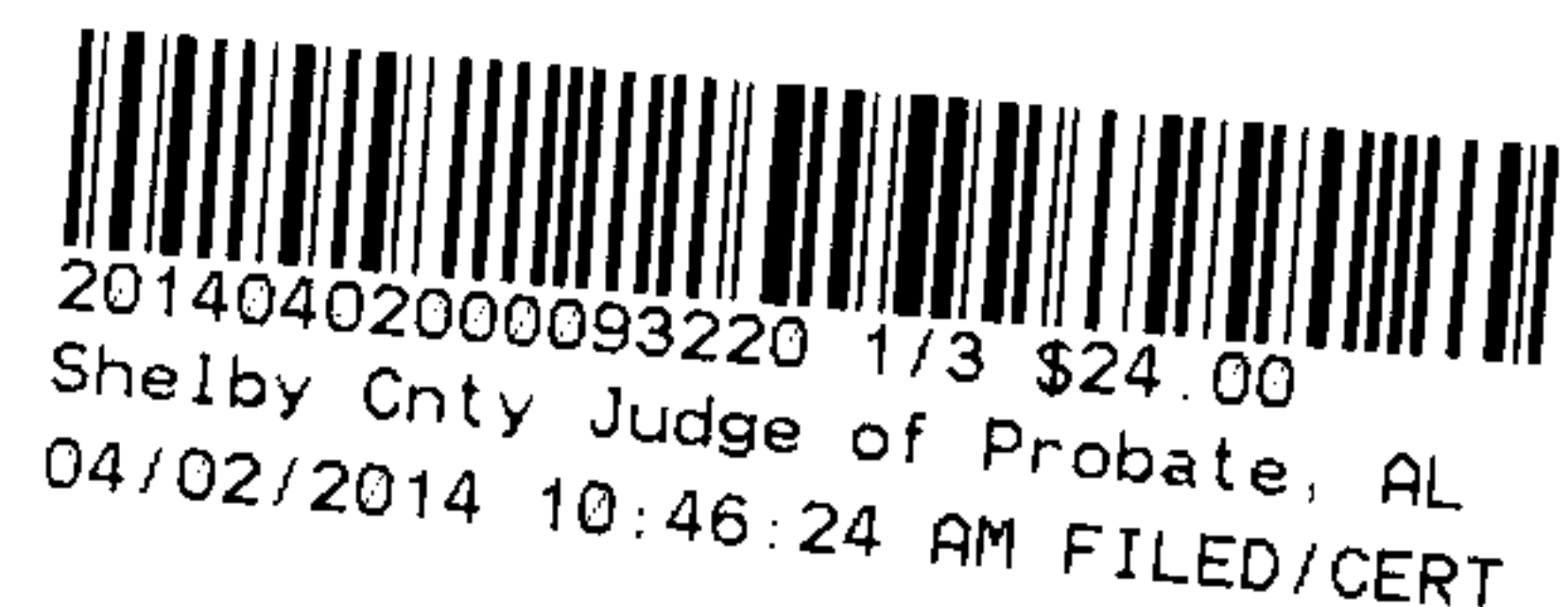

KNOW ALL PERSONS BY THESE PRESENTS: That Maria L Calamas, a single woman, did, on to-wit, May 22nd, 2009, execute a mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Evabank, which mortgage is recorded in Instrument #20090602000208960, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage being lastly assigned to Bank of America, N.A. by instrument recorded in Instrument #20130911000368990 said Probate Court records; and
