WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this March 28, 2014, That for and in consideration of **TWO HUNDRED FIFTY EIGHT THOUSAND AND NO/100 (\$258,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **GINA DEAVERS and CHRISTA ALLEN**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **CAROLLYN HAWKINS and BRETT FLEURY and KATIE HAWKINS**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 12, according to the Survey of Eagle Cove Subdivision, as recorded in Map Book 35, Page 121, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2014 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book . Page .
7. Transmission Line Permits granted to Alabama Power Company as set forth in Deed Book 2015, Page 15 and Deed Book 127, Page 375 and 376.
8. 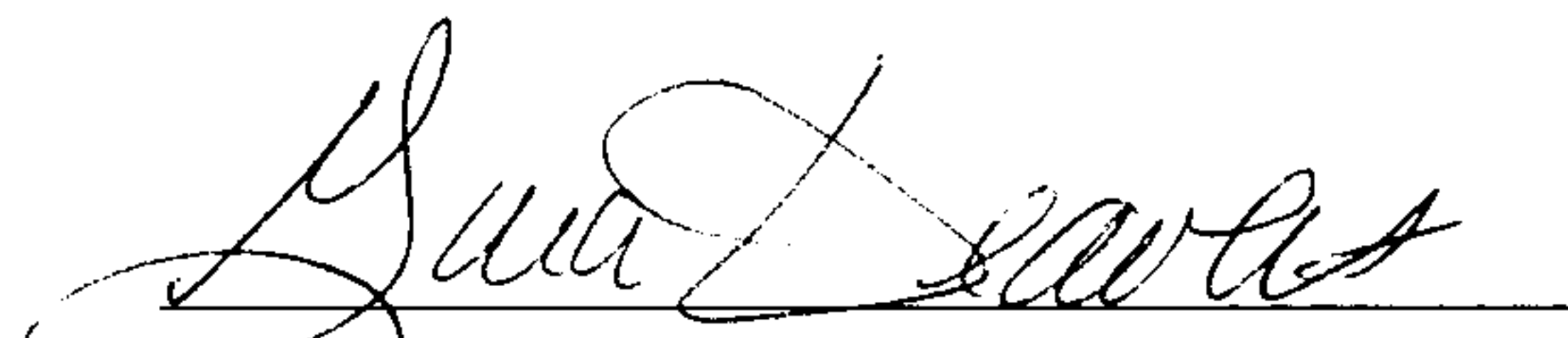
9. Right of way to Shelby County as recorded in Deed Book 231, Page 189.

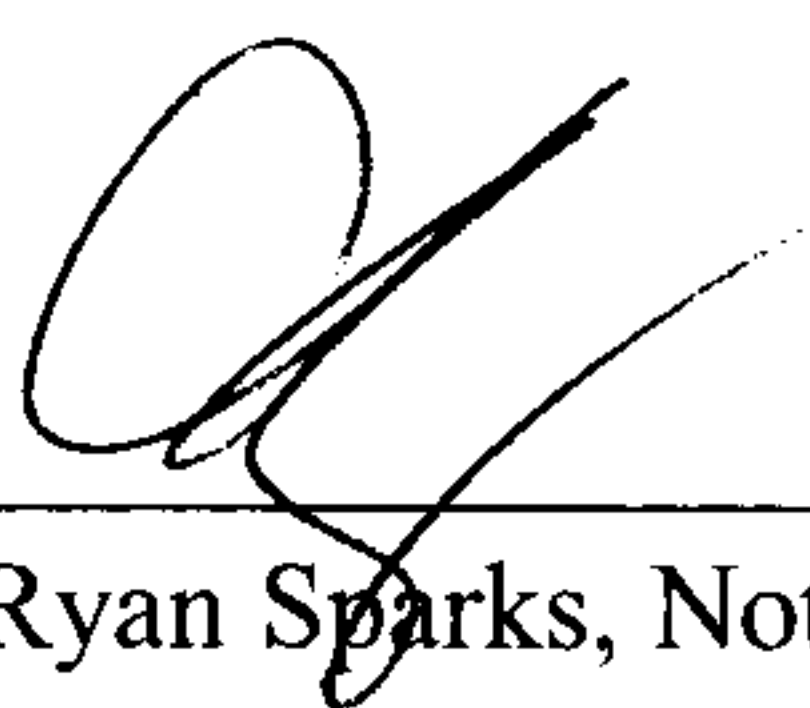

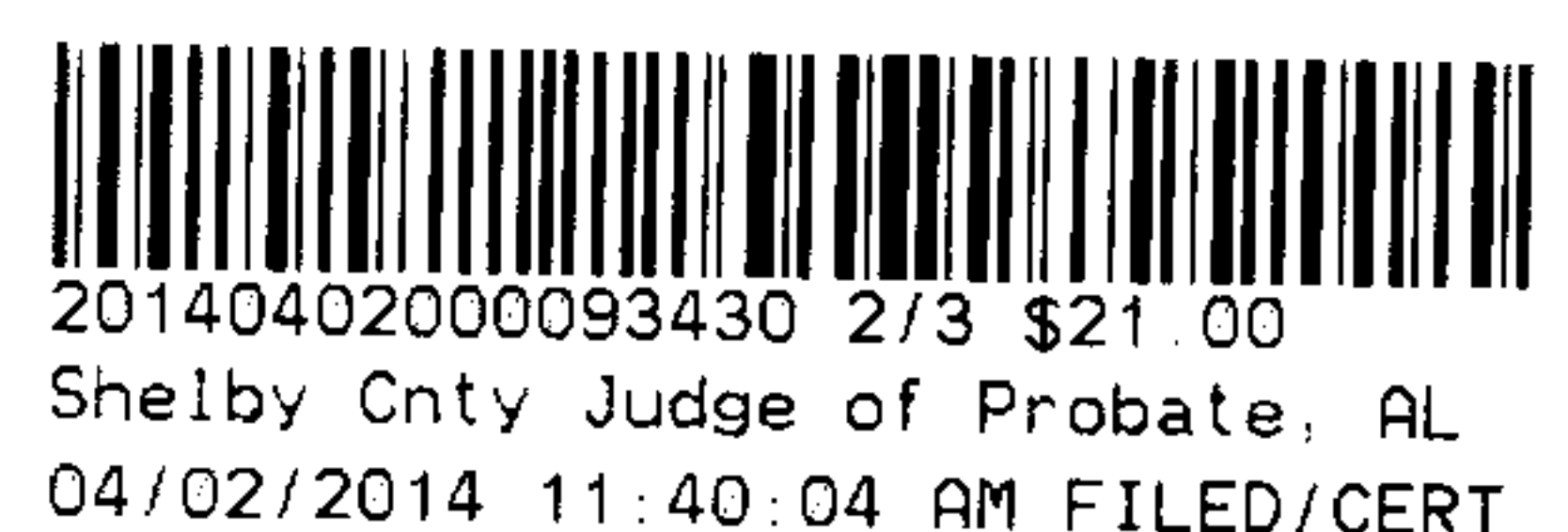
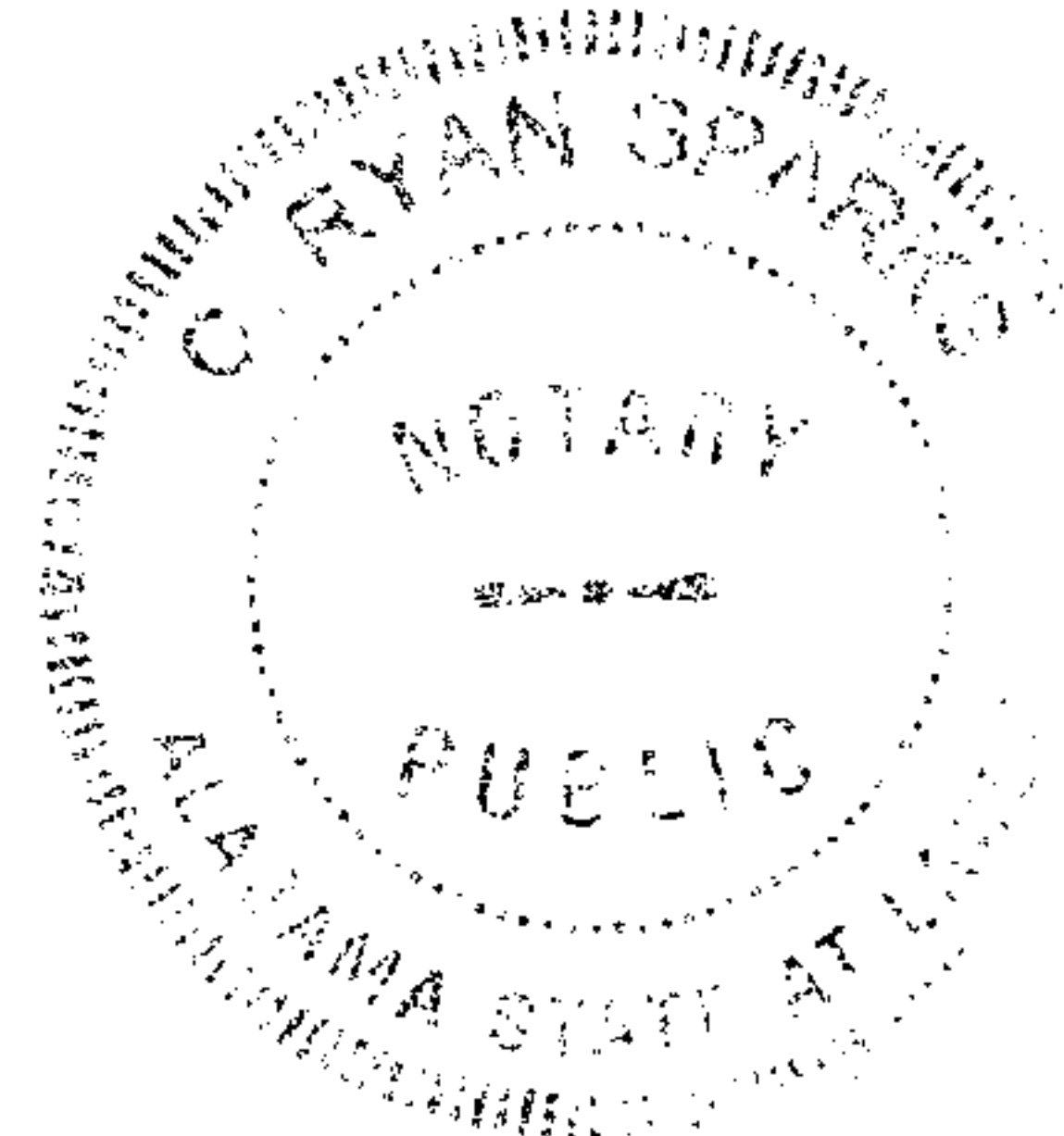
