

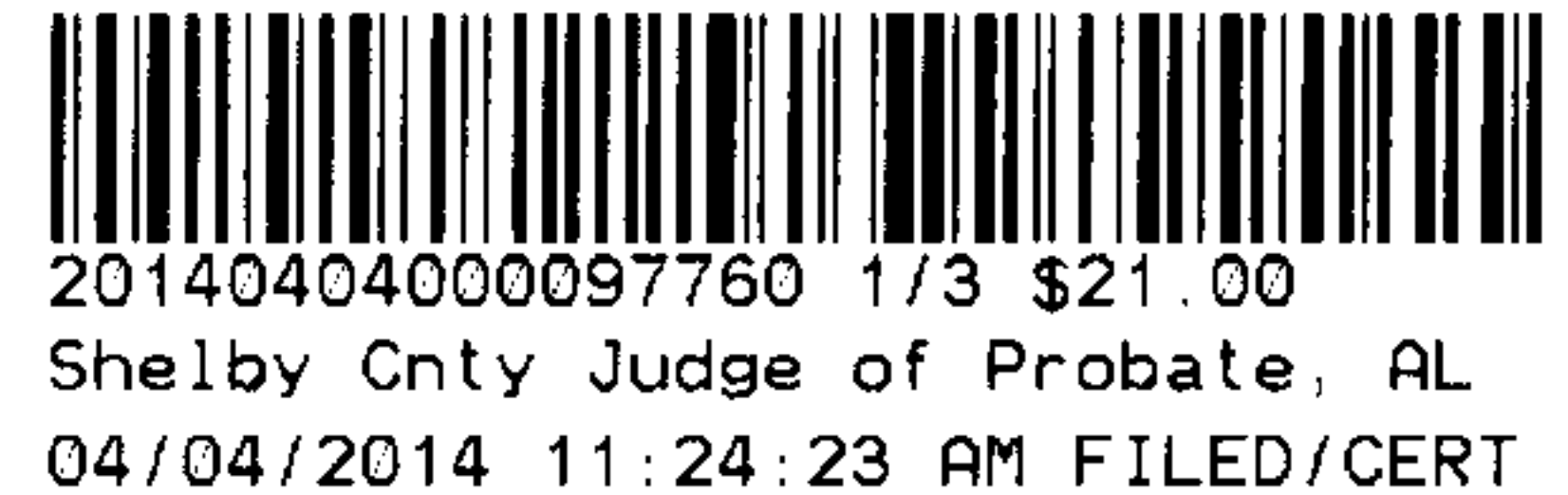

KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED FIFTY-NINE THOUSAND SIX HUNDRED TEN & 00/100-----(\$259,610.00)* DOLLARS to the undersigned Grantor, NEWCASTLE CONSTRUCTION, INC., a corporation, whose address is 3978 Parkwood Road SE, Bessemer, AL 35022 (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey KYLE DAVIS AND HEATHER DAVIS (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in SHELBY COUNTY, Alabama, to-wit:

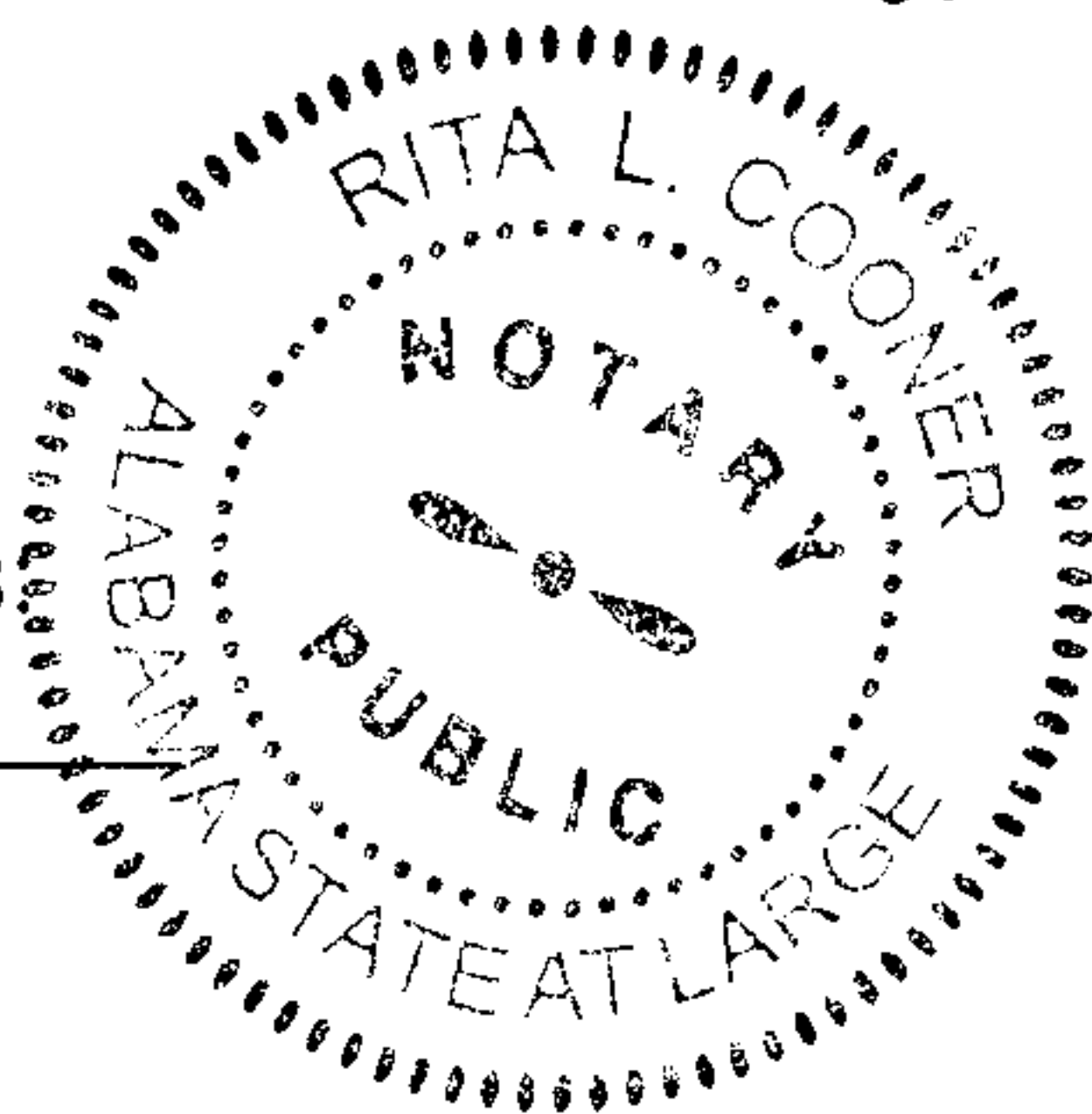

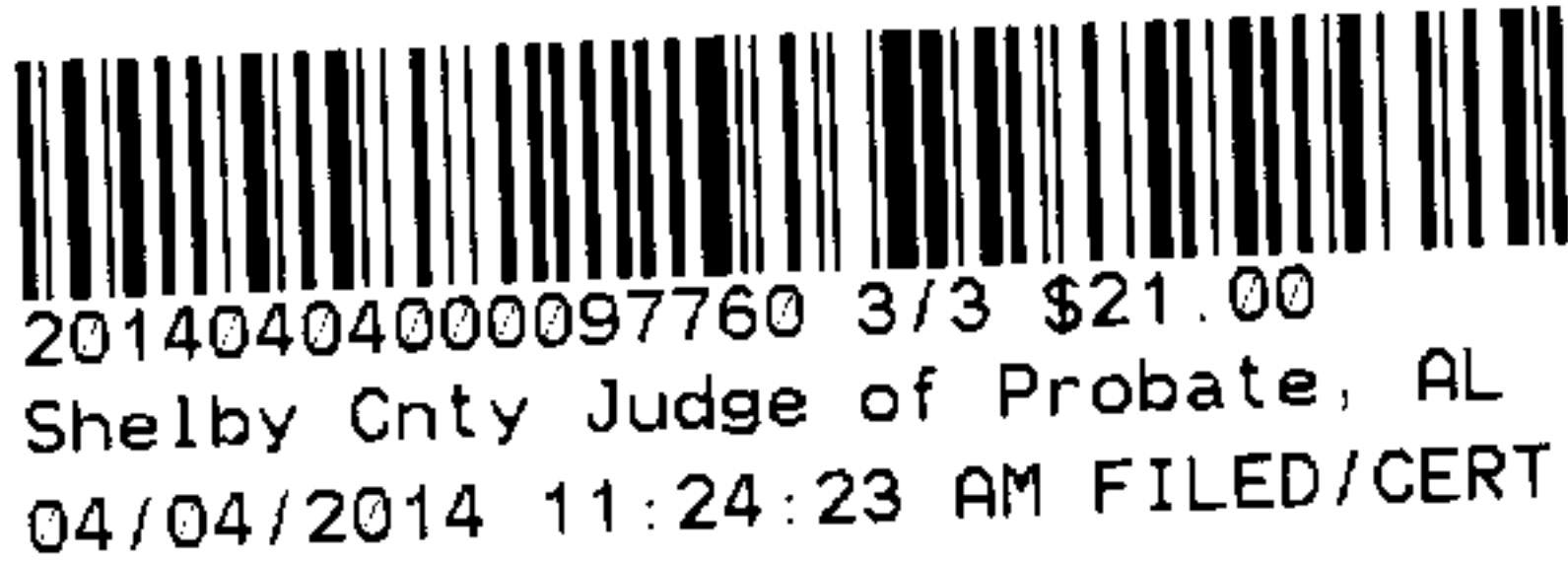
