

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,

On this April 4, 2014, That for and in consideration of ONE HUNDRED THIRTY SEVEN THOUSAND AND N0/100 (\$137,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS ROBERT W. CREEL and JUNE H. CREEL, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, AURORA RODRIGUEZ, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantors' interest in the following-described Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:

Lot 16, in Block 1, Cahaba Valley Estates, First Sector, according to the Map as recorded in Map Book 5, Page 84, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2014 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 5, Page 84.
