Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.


This instrument is executed as required by the Articles of Organization and Operating Agreement and same have not been modified or amended.


\$281,000.00 of the purchase price herein above has been paid by a purchase money mortgage loan closed simultaneously herewith.




