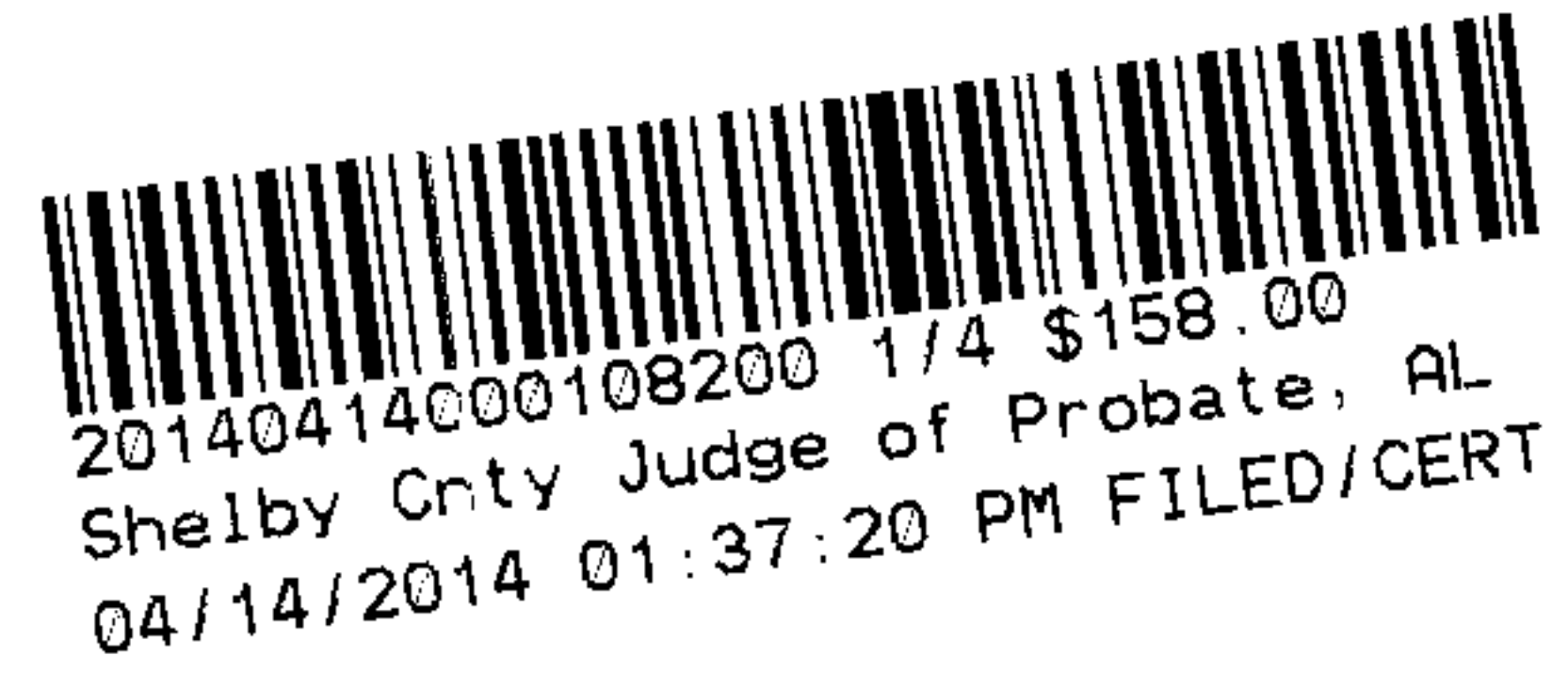

**ARTICLES OF ORGANIZATION
OF
HIGH MARK HOMES LLC
AN ALABAMA LIMITED LIABILITY COMPANY**

Pursuant to the Provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I
Name**

The name of the limited liability company is High Mark Homes, LLC, an Alabama Limited Liability Company (the "Company").

**ARTICLE II
Duration**

The Company shall have a duration from the date of organization until December 31, 2053, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

**ARTICLE III
Purposes**

The purpose for which the Company has been organized is to engage in the development of real property in the State of Alabama and to engage in any lawful act or activity for which limited liability companies may be organized pursuant to the Act.

**ARTICLE IV

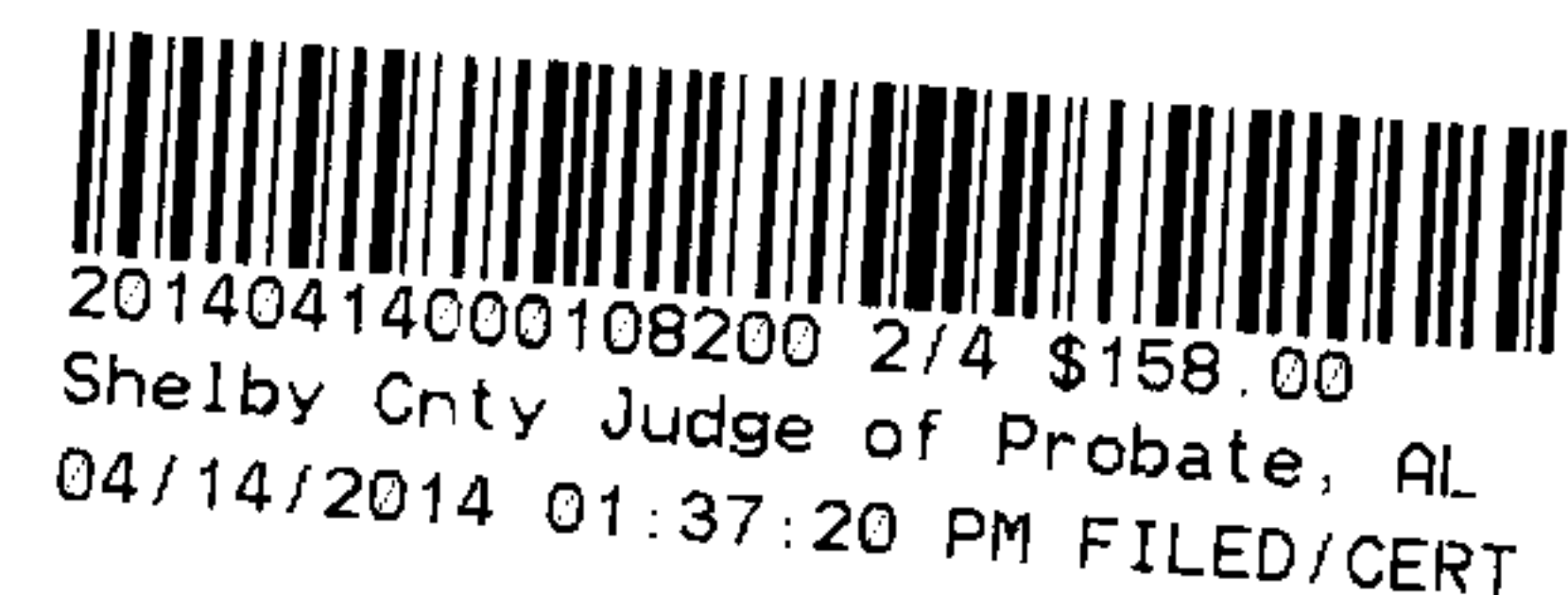

Admission of Additional Members

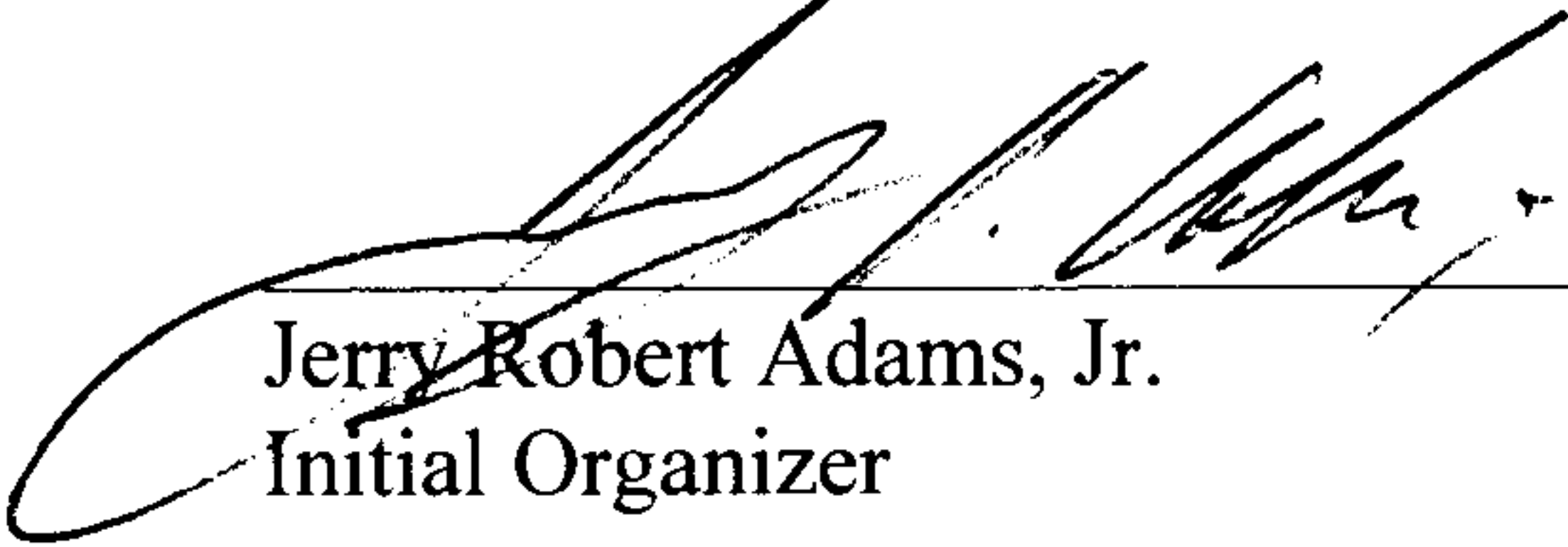

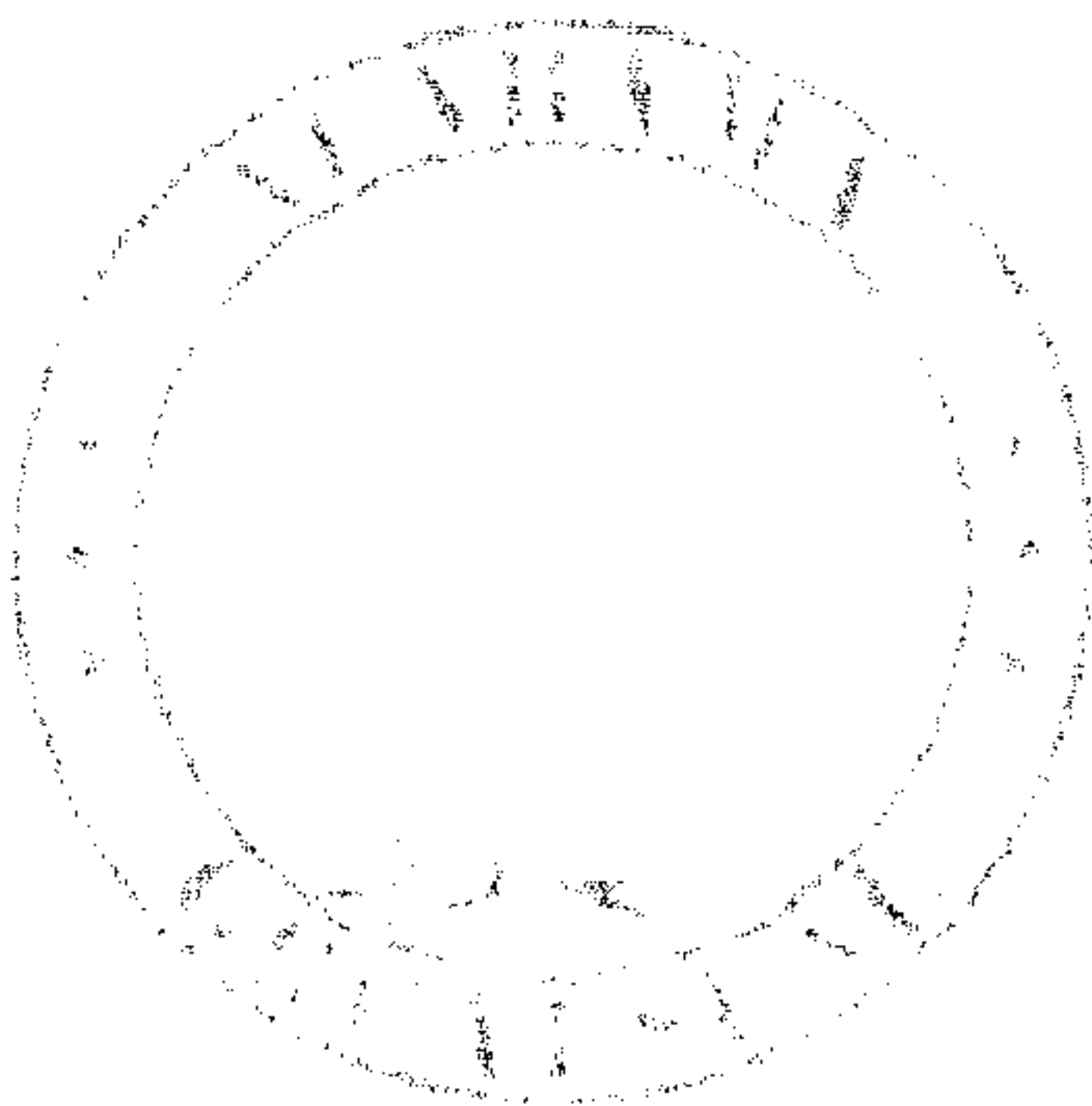
