KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of July, 2004, Danny J. Amos and Mary R. 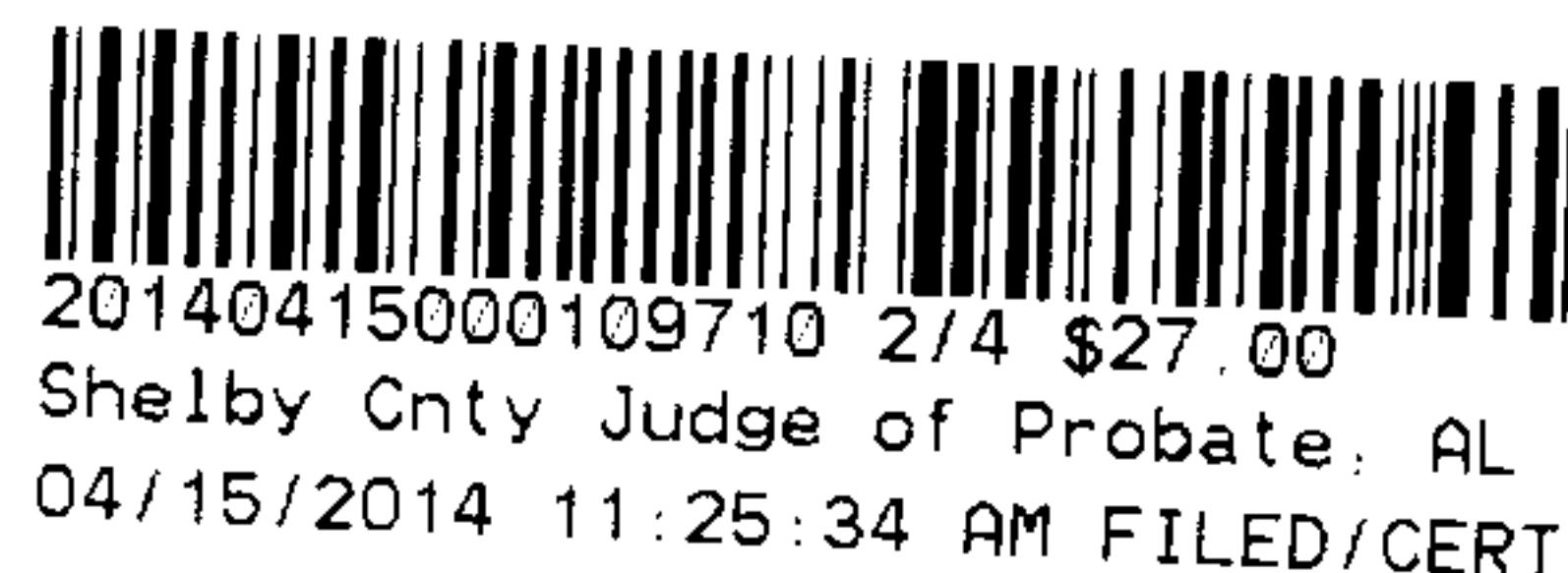

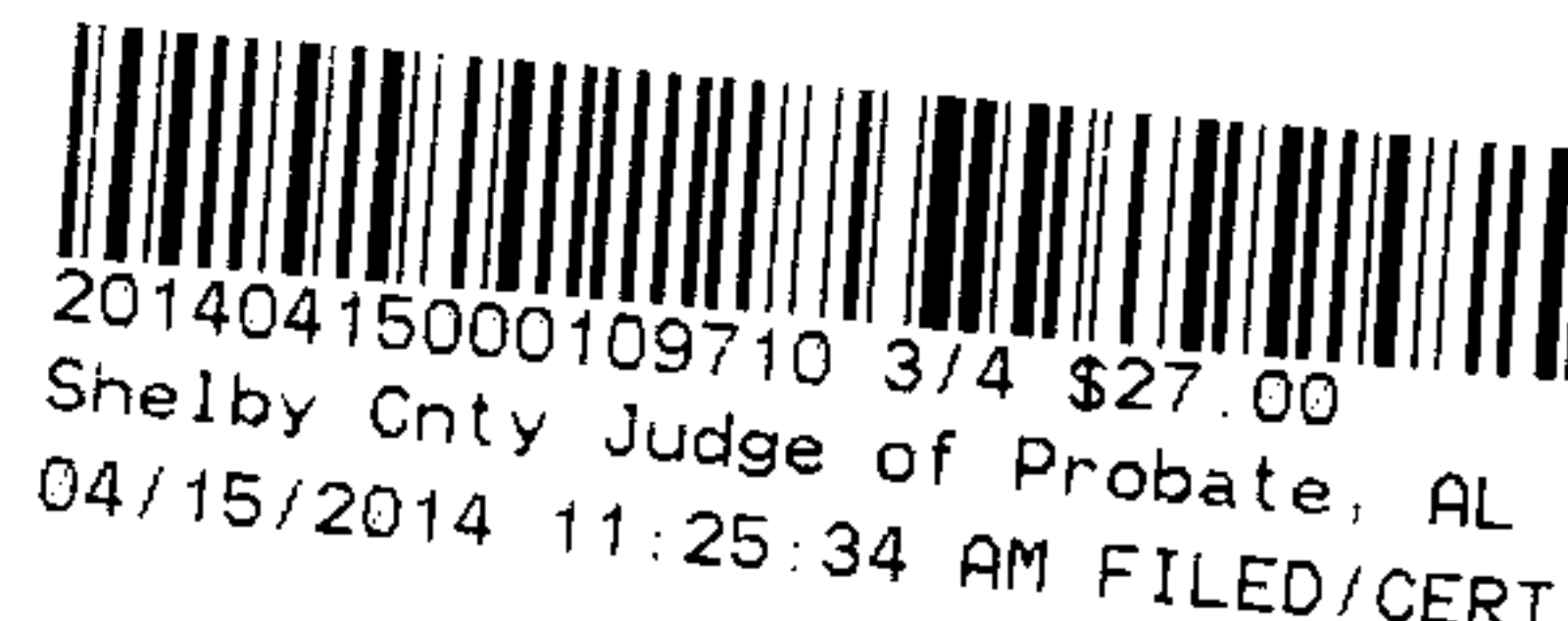


