FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of June, 2013, John Ernest Wilson; an unmarried person, executed that certain mortgage on real property hereinafter described to Trustmark National Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20130819000338870, in the aforesaid Probate Office ("Mortgagee"); and

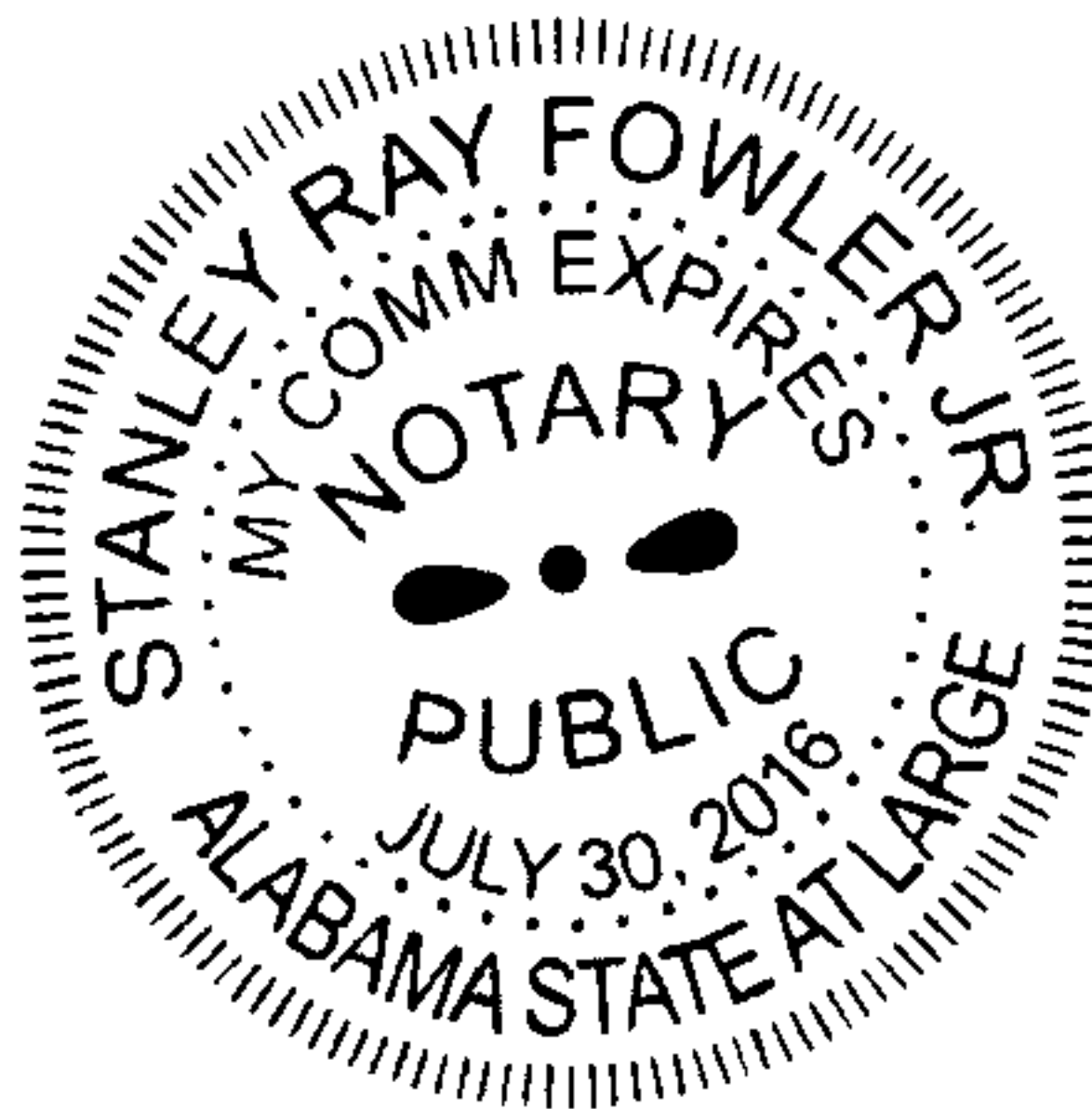
