**CORPORATION WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of **Three Hundred Two Thousand Two Hundred Sixteen Dollars and No Cents (\$302,216.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Harris Doyle Homes, Inc.** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Shaun Jourdan and Danielle Jourdan (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama, to-wit:

Lot 76, according to the Final Plat for Multi-Vest, Inc.'s Addition to Bent River - Phase IV, as recorded in Map Book 42, Page 125, in the Probate Office of Shelby County, Alabama.

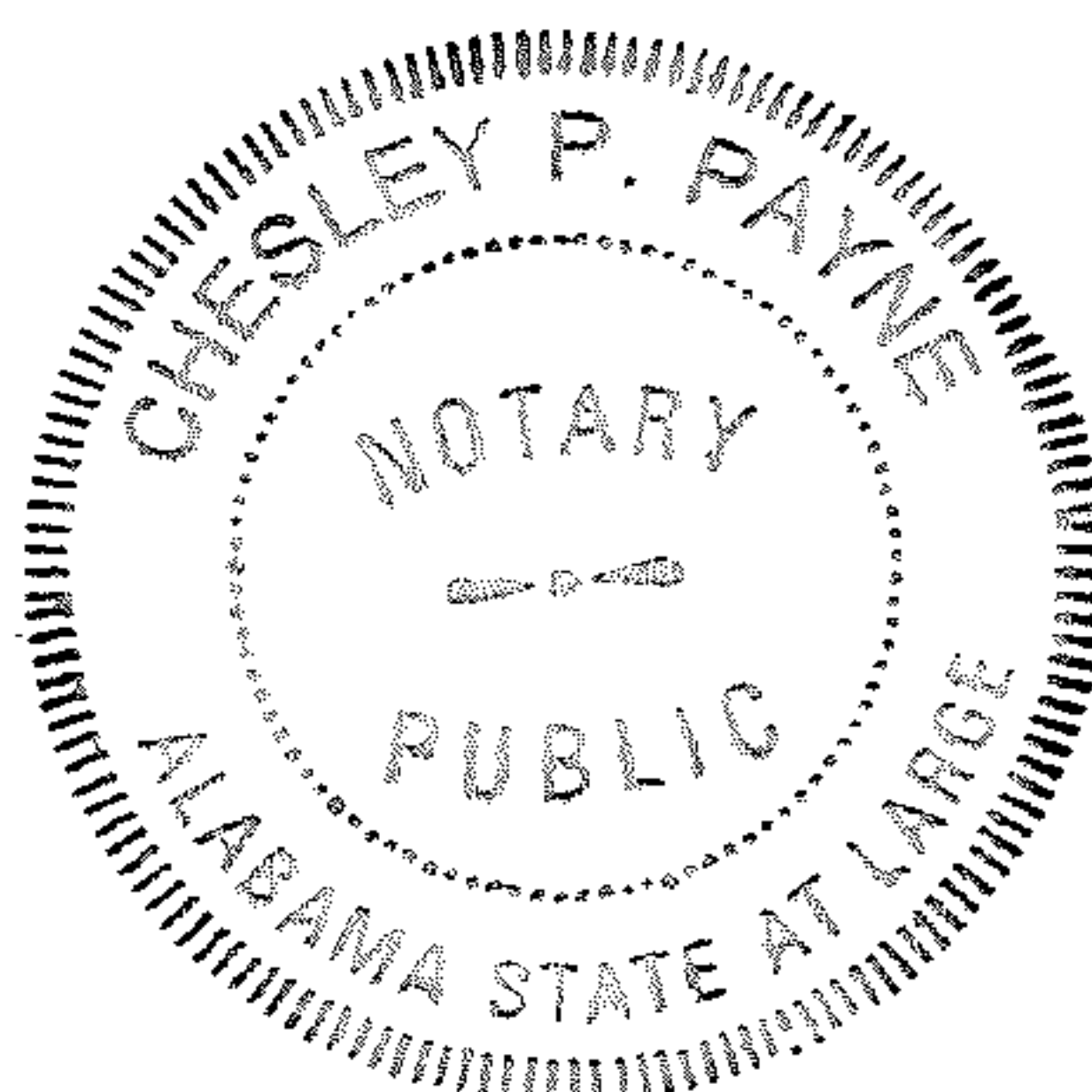



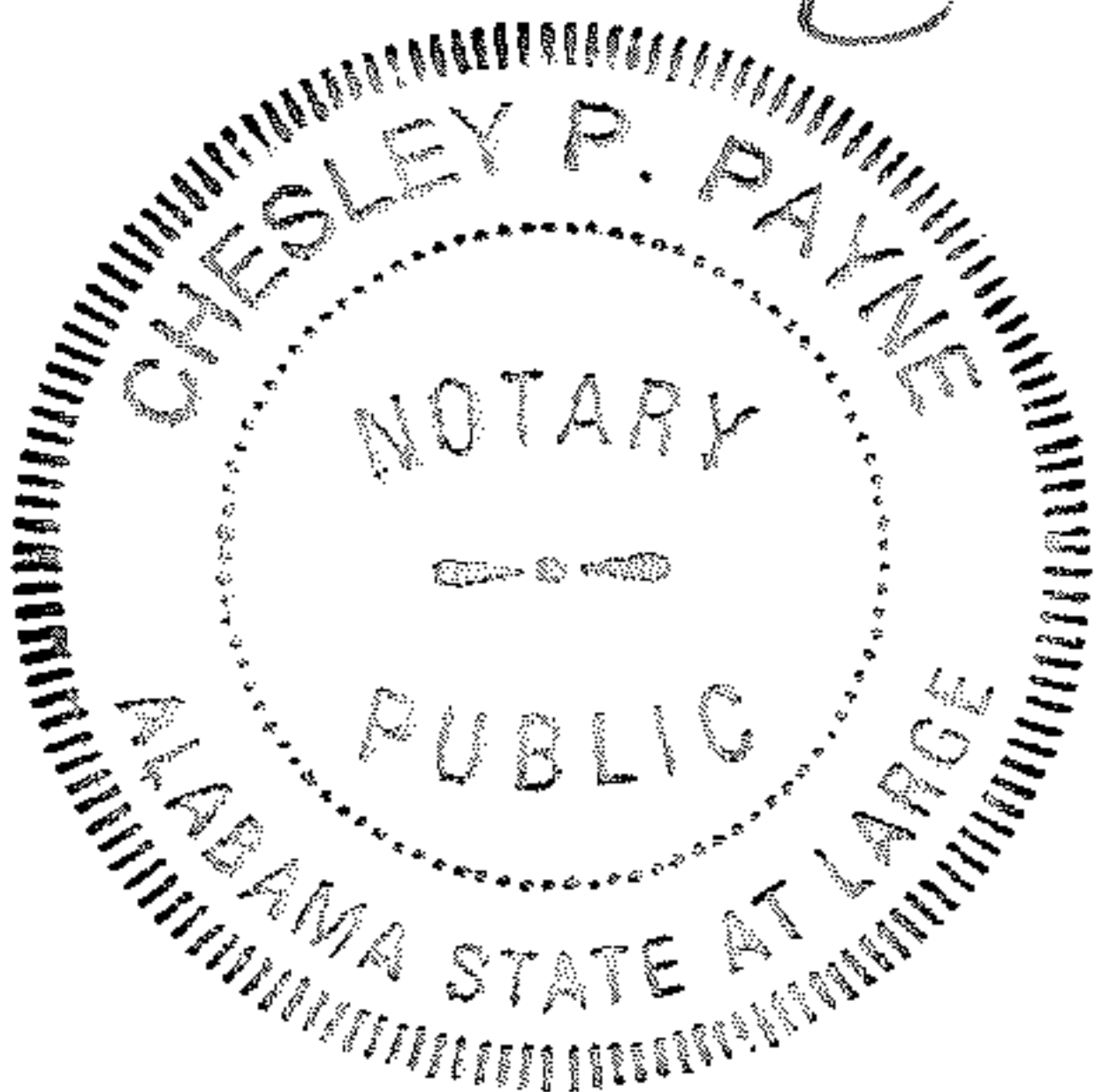
