

SUBORDINATION AGREEMENT

THIS AGREEMENT is entered into this 21ST day of FEBRUARY, 2014, by NATIONSTAR MORTGAGE LLC., dba GREENLIGHT LOANS (Lender) & MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., as nominee for AEGIS FUNDING d/b/a AEGIS HOME EQUITY, ITS SUCCESSORS AND ASSIGNS (Lienholder).

NOW THEREFORE, in consideration of the covenants contained herein, the parties agree as follows:

- 1. <u>Subordination</u>. Lienholder agrees to and hereby does subordinate its second deed of trust lien in the Property to a new first deed of trust lien to be filed by Lender in order to refinance the existing first deed of trust.
- 2. Effect. Lender agrees that Lienholder's second deed of trust shall in no way be impaired or affected by the Agreement except that the second deed of trust lien shall stand junior and subordinate to the Lender new first deed of trust in the same manner and to the same extent as if the Lender new first deed of trust had been filed prior to the execution and recording of the Lien holder's second deed of trust.
