KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of April, 2007, Stephanie J. Nicholas aka Stephanie J. 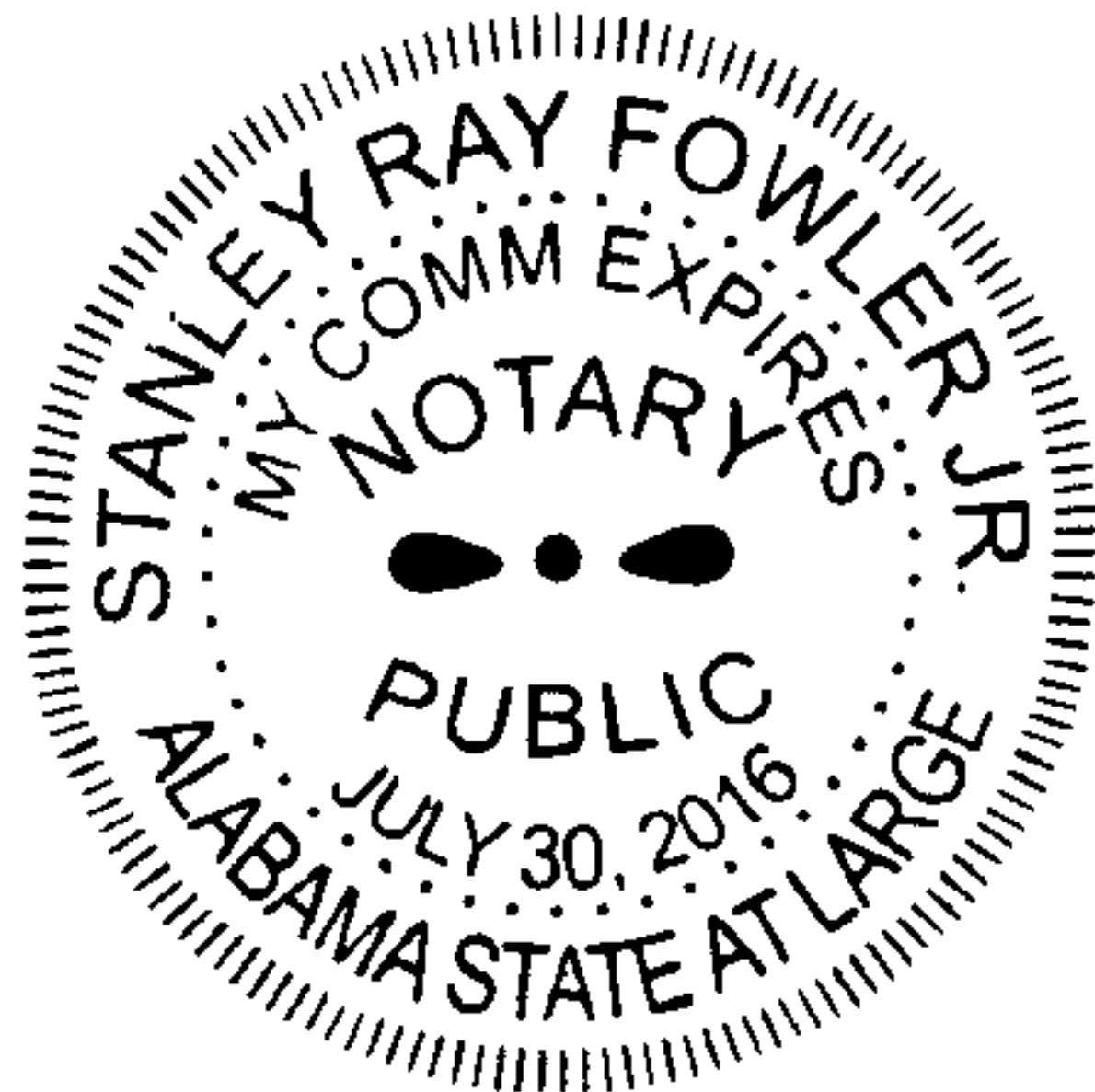

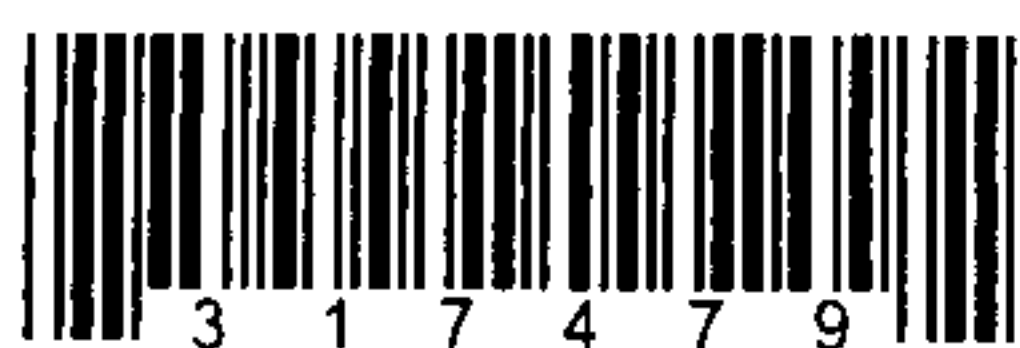
