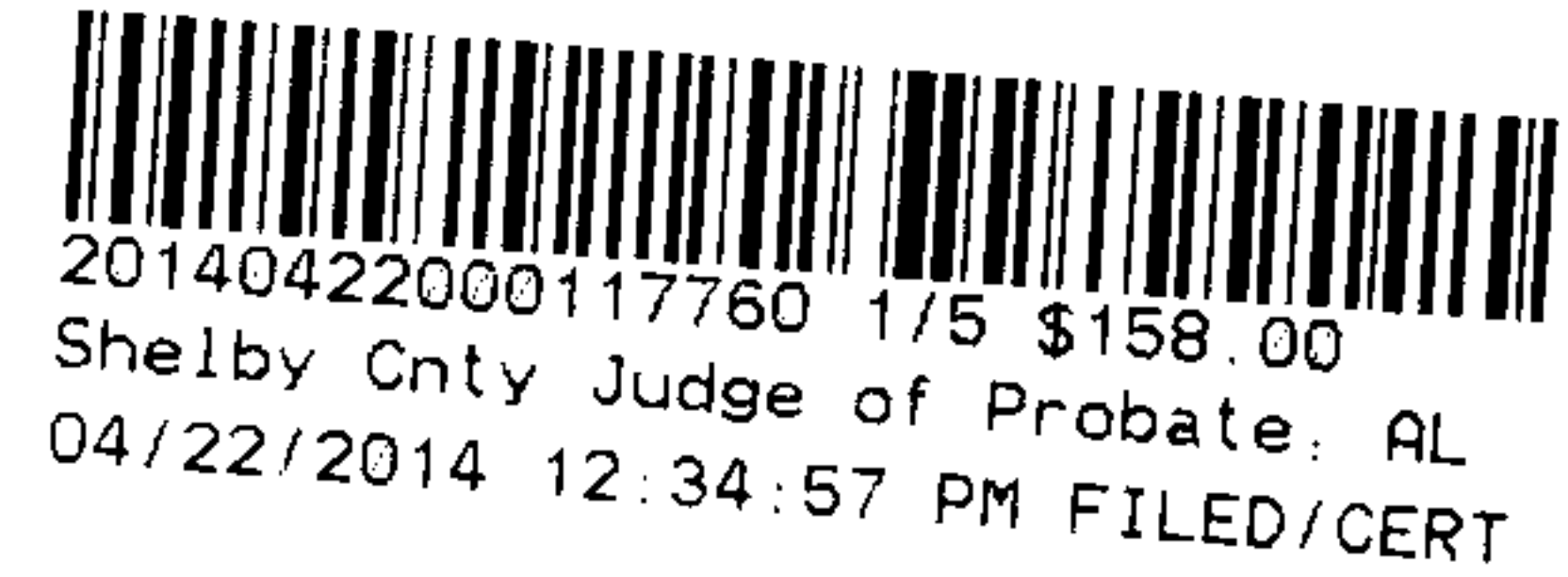


ARTICLES OF ORGANIZATION OF ATJ Properties, LLC



A LIMITED LIABILITY COMPANY ORGANIZED UNDER THE LAWS OF ALABAMA

The undersigned, acting as the organizer(s) of a limited liability company under the Alabama Limited Liability Company Law (the "Act"), Code of Alabama, 1975 § 10A-5-1.01, et seq., hereby adopt the following Articles of Organization for ATJ Properties, LLC (hereinafter called the "Company").

ARTICLES

Article I – Name

The name of the Company is ATJ Properties, LLC, a Limited Liability Company ("L.L.C." or "LLC") or under such other name as its Members may determine from time to time, and notice thereof shall be given to the Members.

Article II – Duration

The Company shall continue in existence until it is dissolved or in accordance with the provisions of the operating agreement. If there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with Title 10A, Chapter 5, Section 7 of the Code of Alabama, or other applicable laws.

Article III – Purpose

The Company is organized for the purpose of engaging in the business of acquire, manage, hold, develop, and sell real estate properties and such other functions as necessary to achieve that purpose. The purpose includes the transaction of any lawful business for which limited liability companies may be organized in Alabama under Title 10A, Chapter 5 of the Code of Alabama.

Article IV – Form

As provided by Title 10A, Chapter 5, Section 4.01 of the Code of Alabama, the Company reserves the right to create classes or groups of members or managers having such relative rights, powers, and duties as to be specified in the operating agreement. This right shall include the right to limit or eliminate voting by the specific classes or groups.

Article V – Principle Office

The street address of the principal office of the Company will be:

or at such other location as its Members may determine from time to time, and notice thereof shall be given to the Members.

Article VI – Registered Agent and Office

The mailing address of the initial registered office will be:

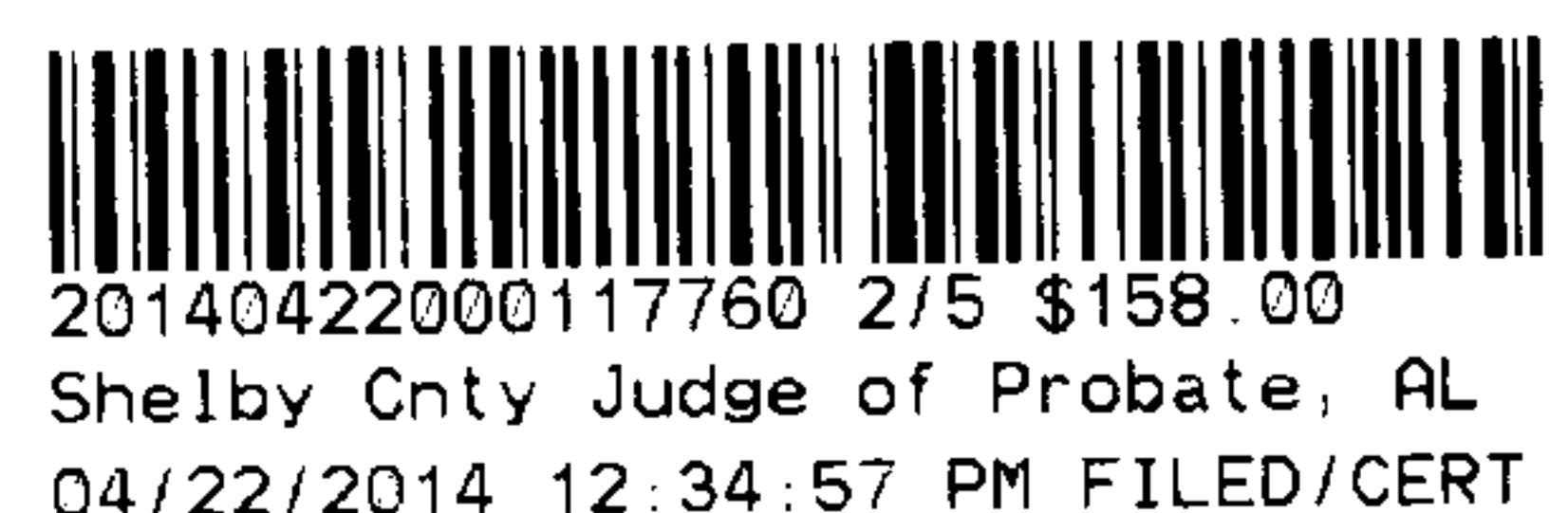

Article VII – Initial Members

The initial members of the Company may admit additional members at such times and upon such terms and conditions as agreed upon by the Company and the additional members.

The name and mailing address of each Member and the amount contributed by such Member to the capital of the Company shall be listed on the books and records of the Company and as from time to time amended as necessary to accurately reflect the information therein.

Article VIII – Management

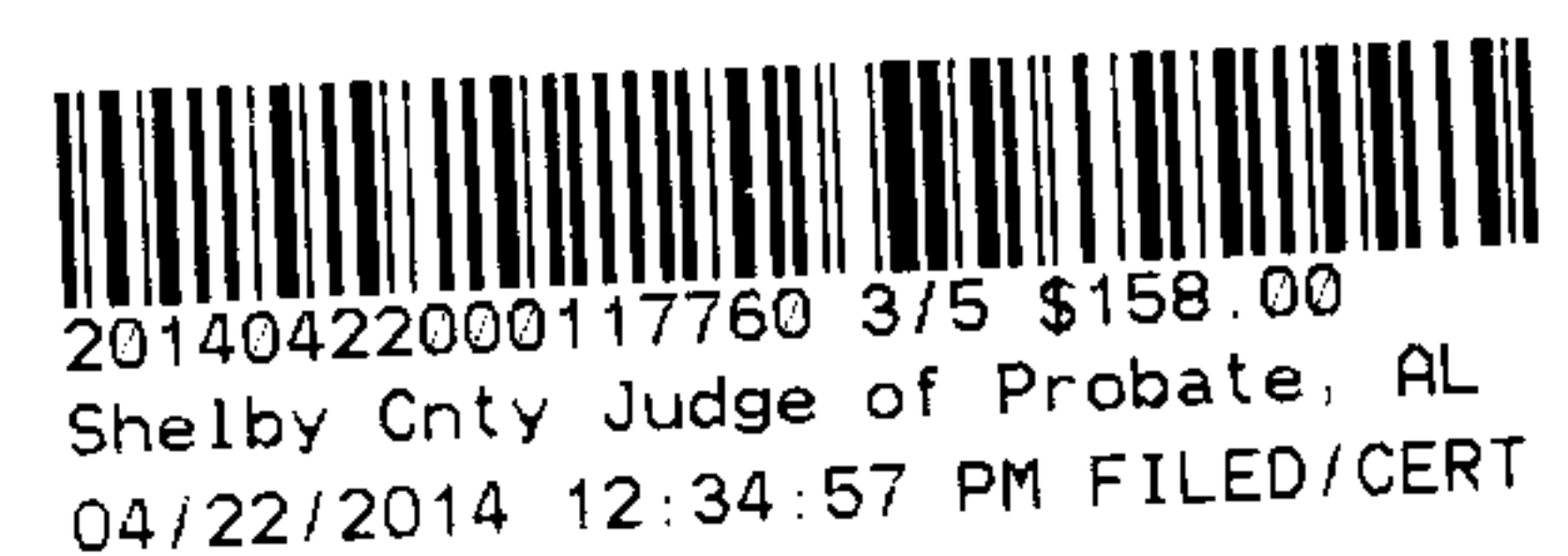
The Company shall be managed by its Members.

Article IX – Effective Date

The Company shall be considered existing and in good standing effective April 25, 2014.

Article X – Indemnification

As provided by Title 10A, Chapter 5, Section 1.04 of the Code of Alabama, the Company has the power to indemnify any member, manager, or employee or former member, manager, or employee of the Company against expenses actually and reasonably incurred in connection with the defense of an action, suit, or proceeding, civil or criminal, in which the member, manager, or employee is made a party by reason of being or having been a member, manager, or employee of the Company, except in relation to matters as to which the member, manager, or employee is determined in the action, suit, or proceeding to be liable for negligence or misconduct in the performance of duty. The Company reserves the right, by a resolution adopted by the members after notice, to purchase and maintain insurance on behalf of any person who is or was a member, manager, or employee of the limited liability company against any liability asserted against and incurred by the member, manager, or employee in any capacity or arising out of the member's, manager's, or employee's status as such, whether or not the limited liability company would have the power to indemnify the member, manager, or employee against that liability under the provisions of this Article. The effect of Article X shall be constructively amended from time to time to grant to the LLC the greatest power to indemnify a member, manager, or employee or former member, manager, or employee of the Company to the greatest extent allowable by law.

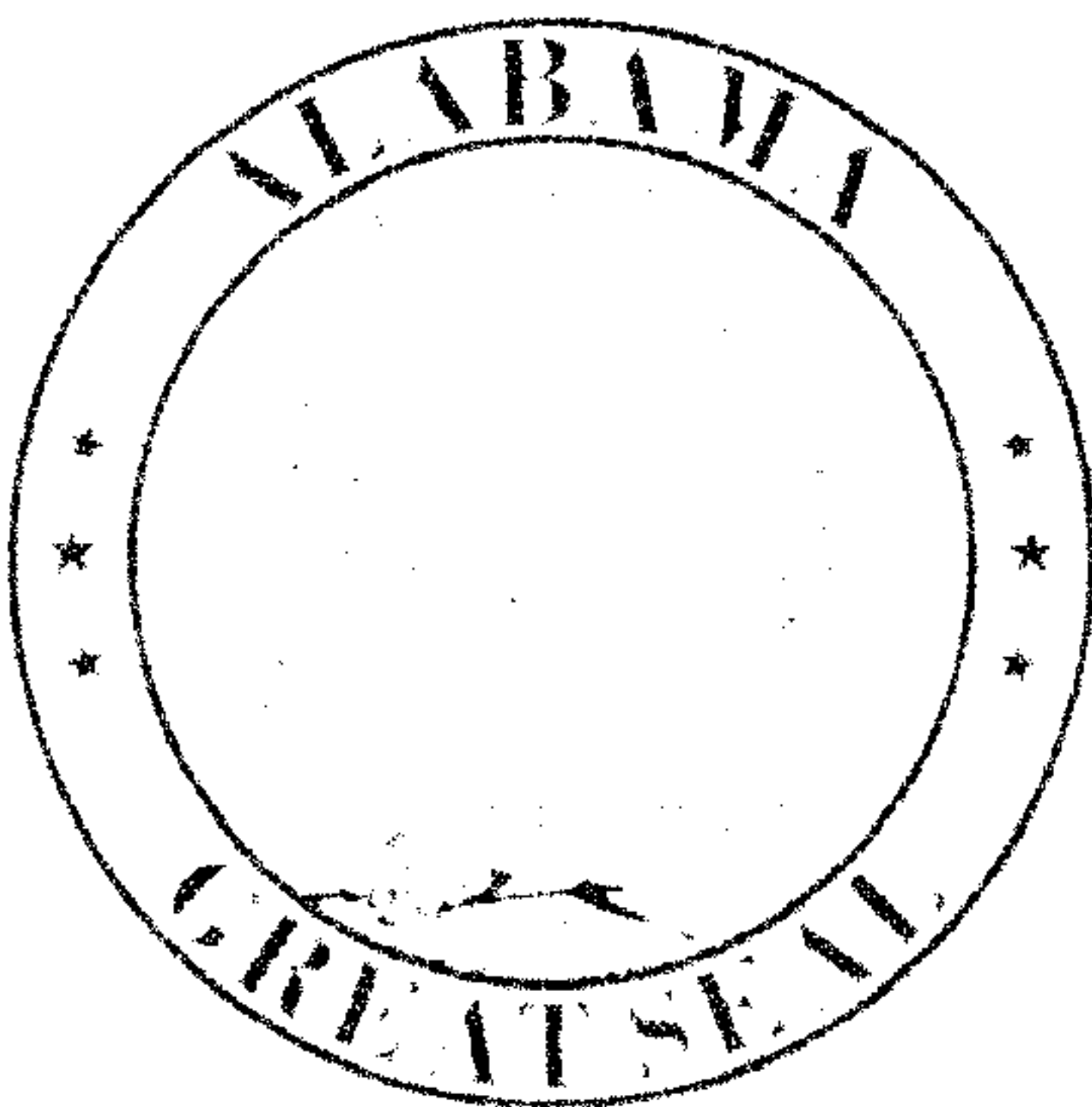
