The Association claims a lien upon property owned by **Gregory & Sandra Tope**, situated in Shelby County, Alabama described as follows:

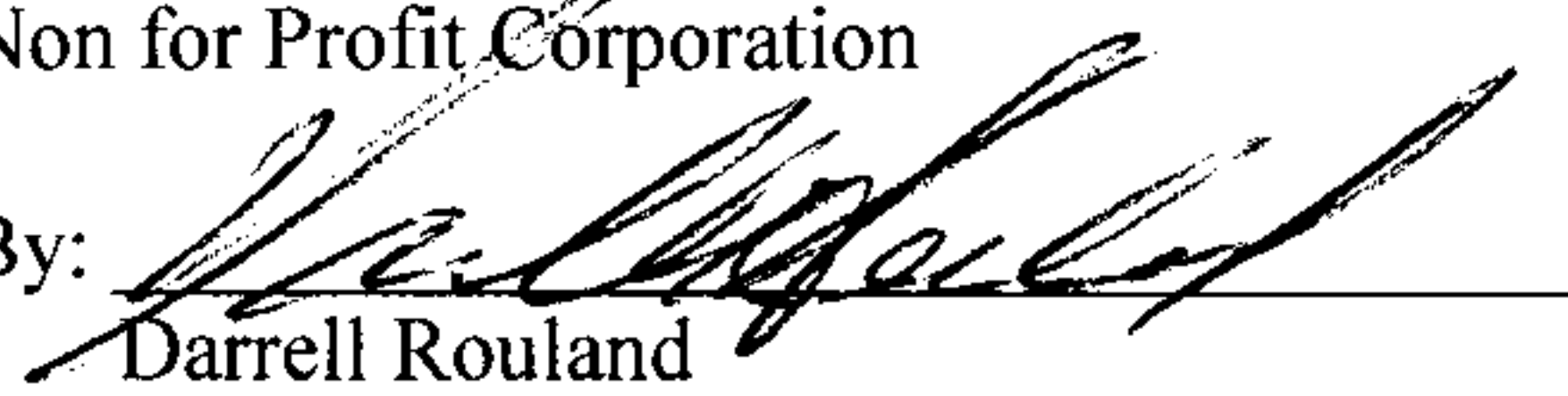

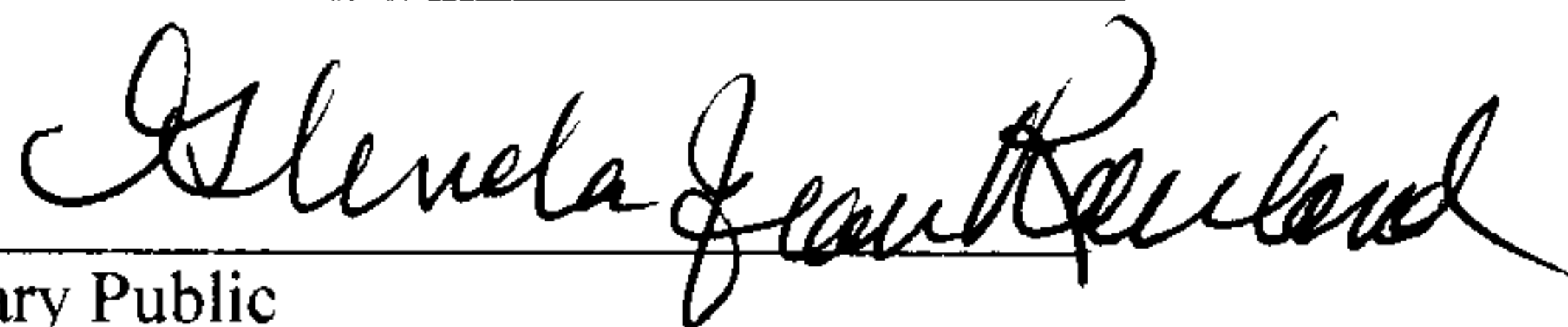
