**ARTICLE I

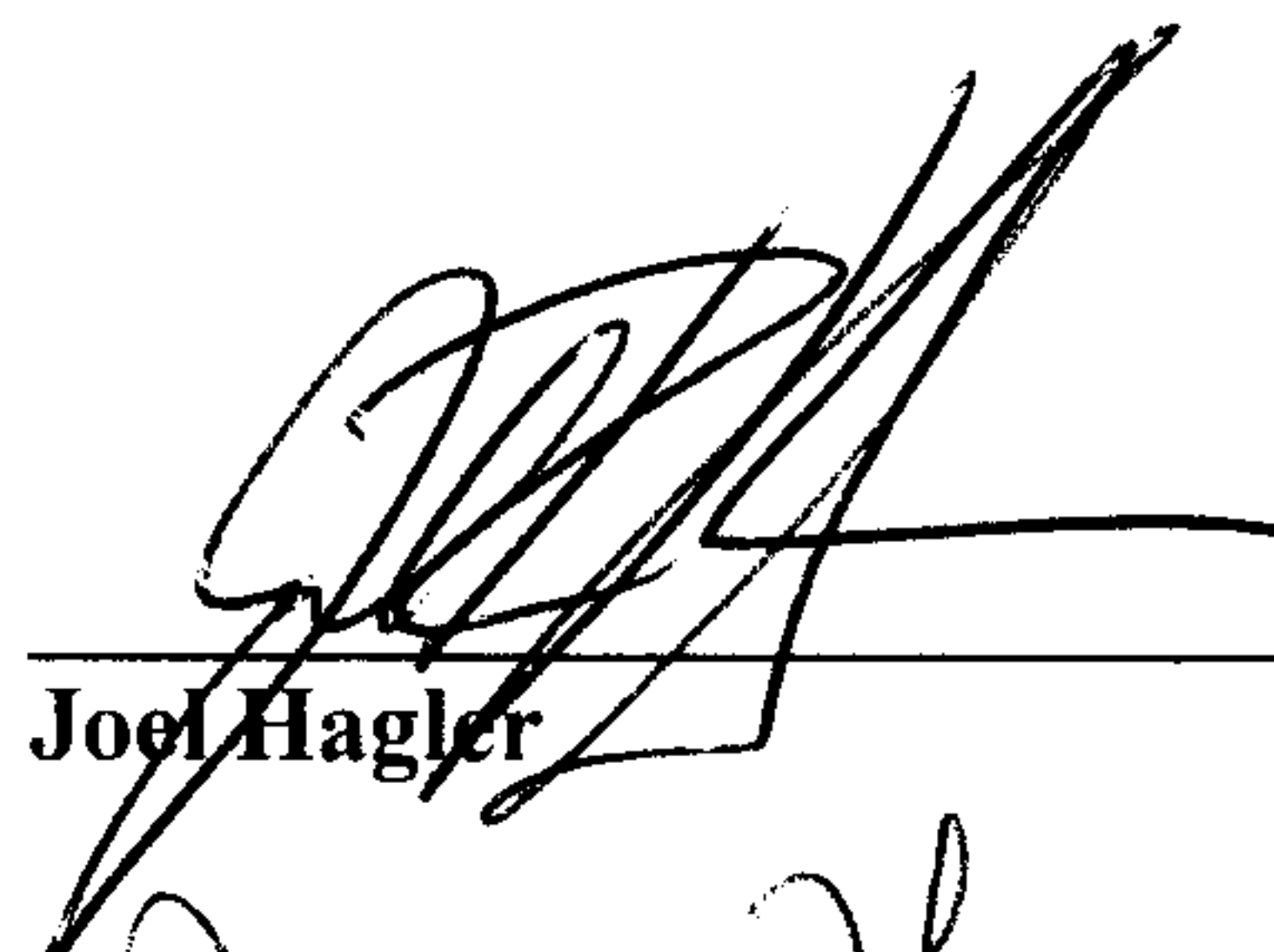

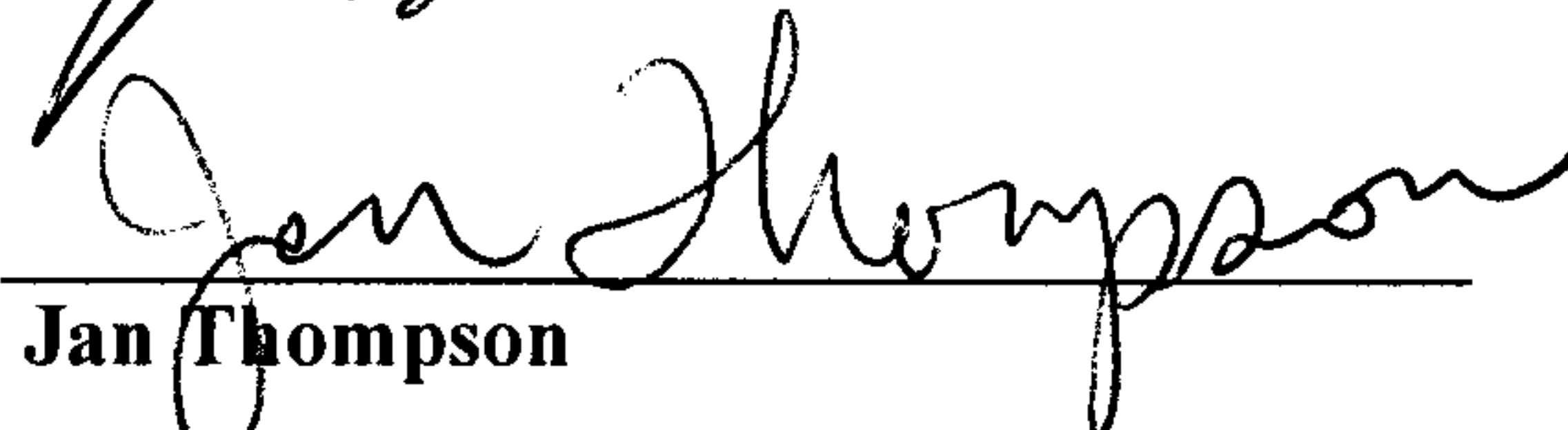
ARTICLE IX

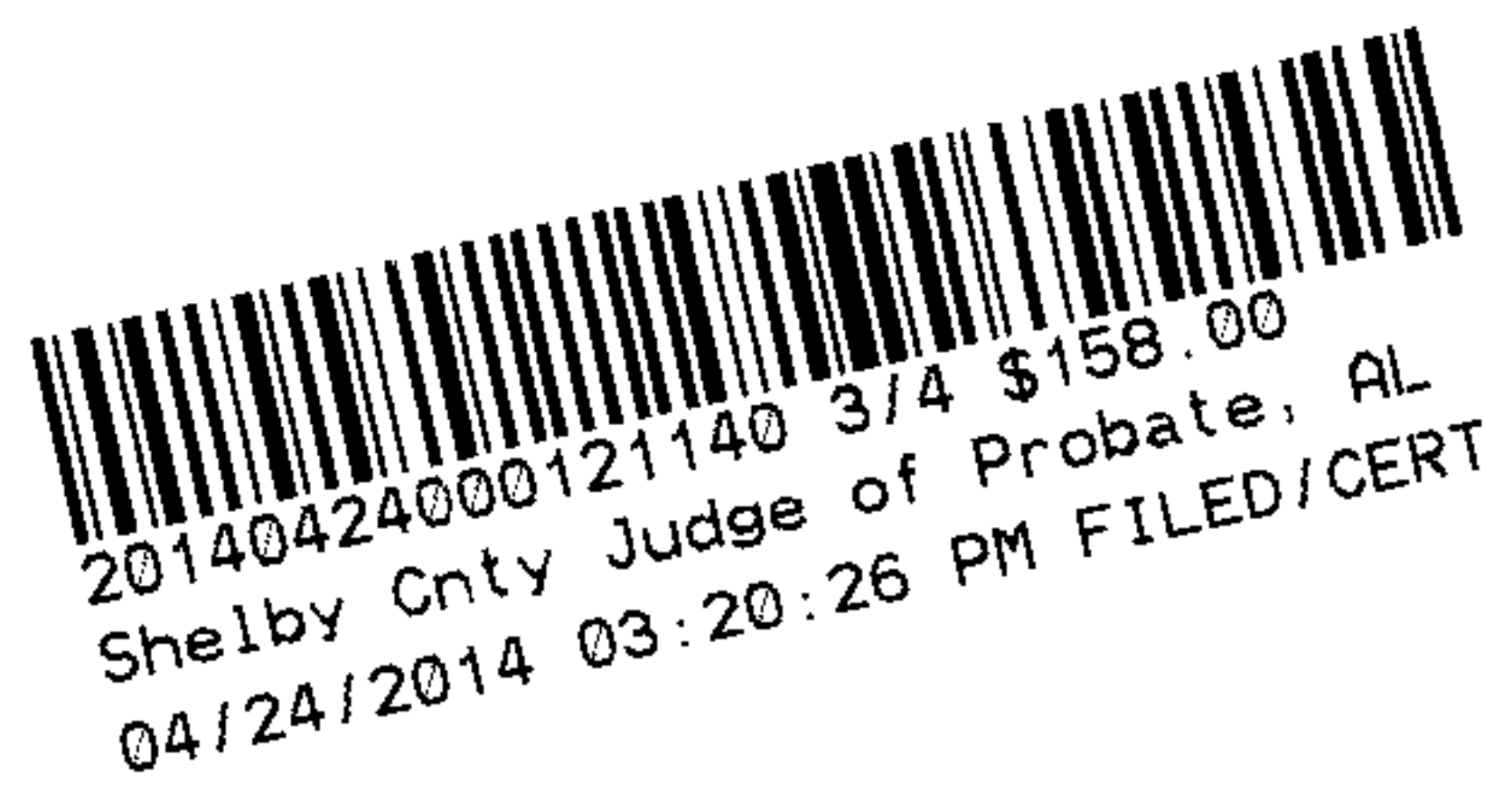
