

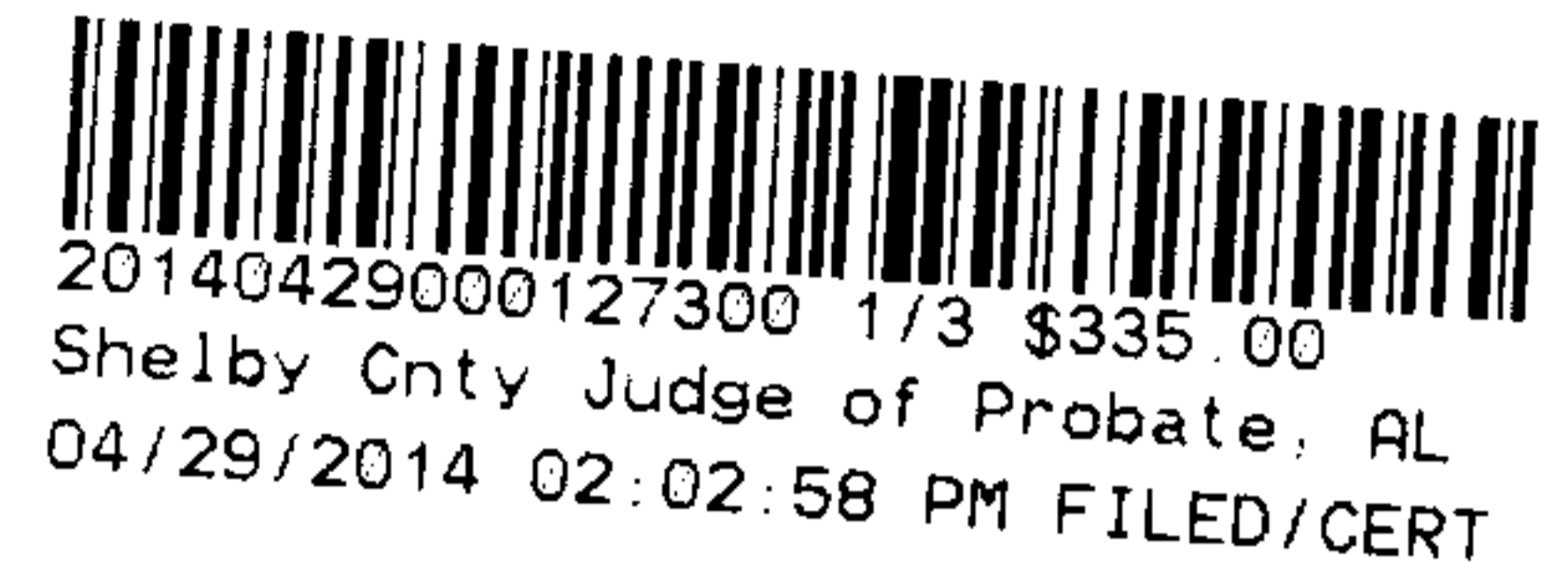

7. Restrictions appearing of record in Book 131, Page 522, Office of the Judge of Probate of Shelby County, Alabama.


