Purposes

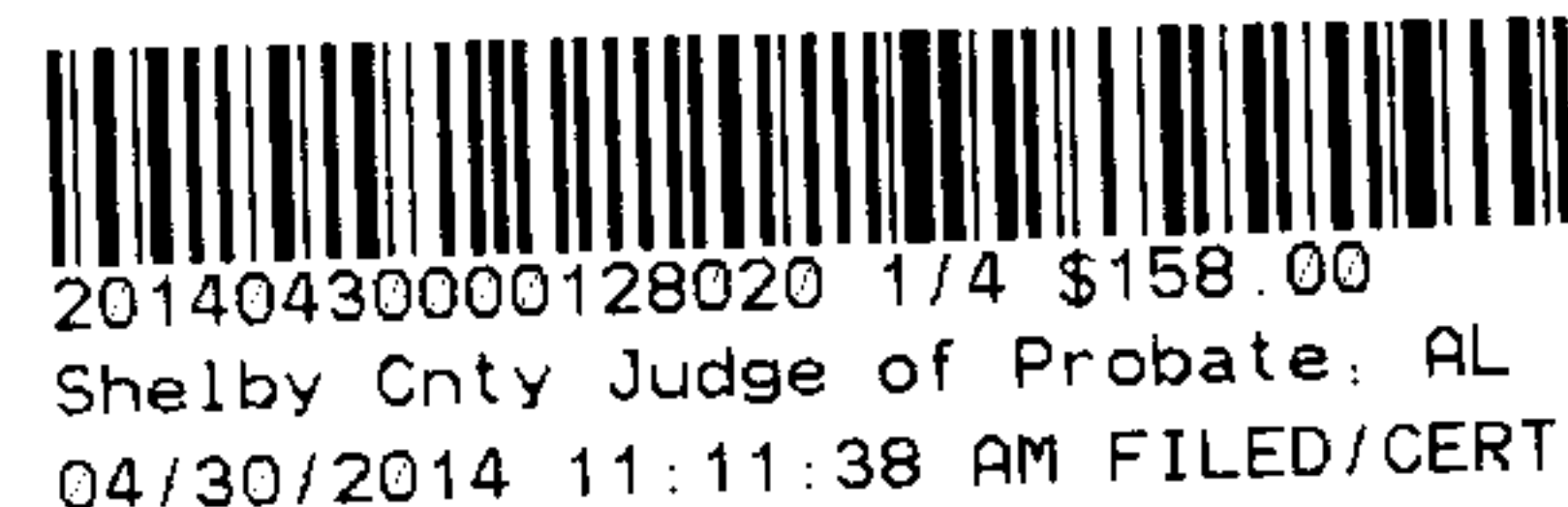
The purposes for which the Company is formed are:

ARTICLE VII

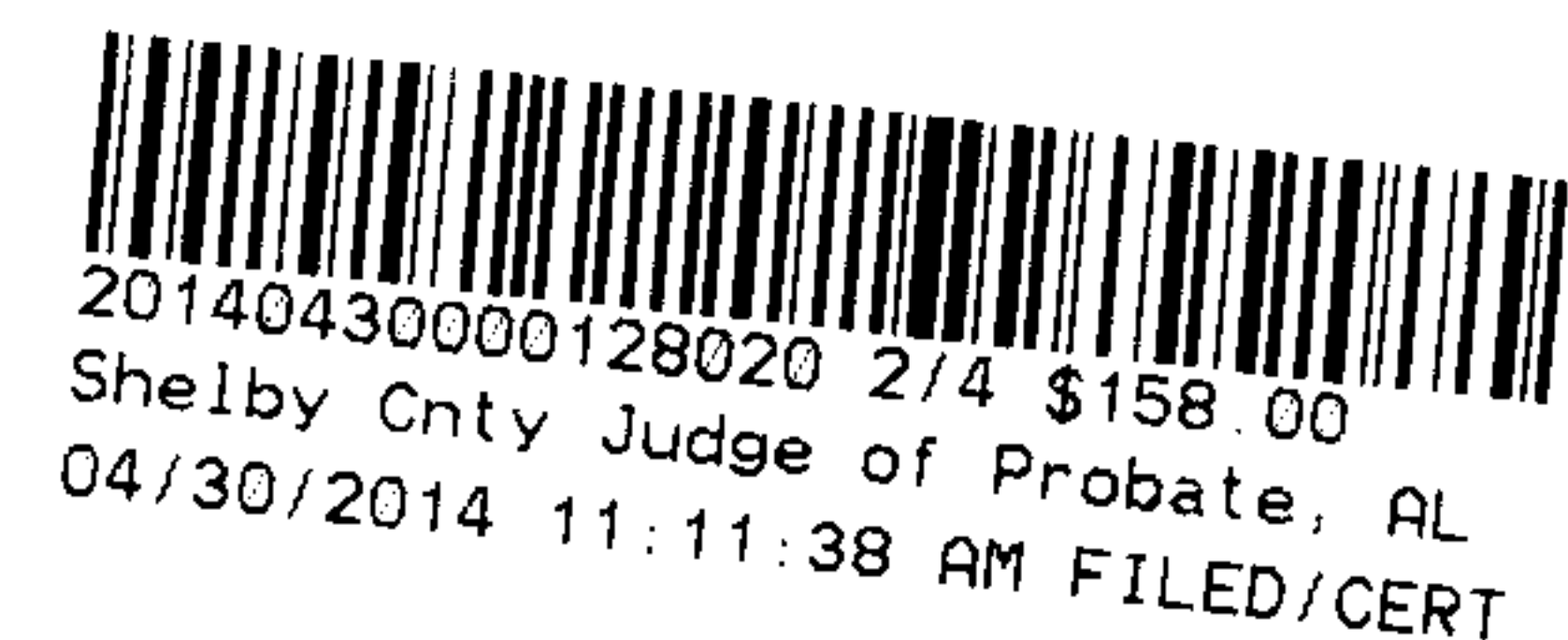
Continuation of Business

ARTICLE VIII

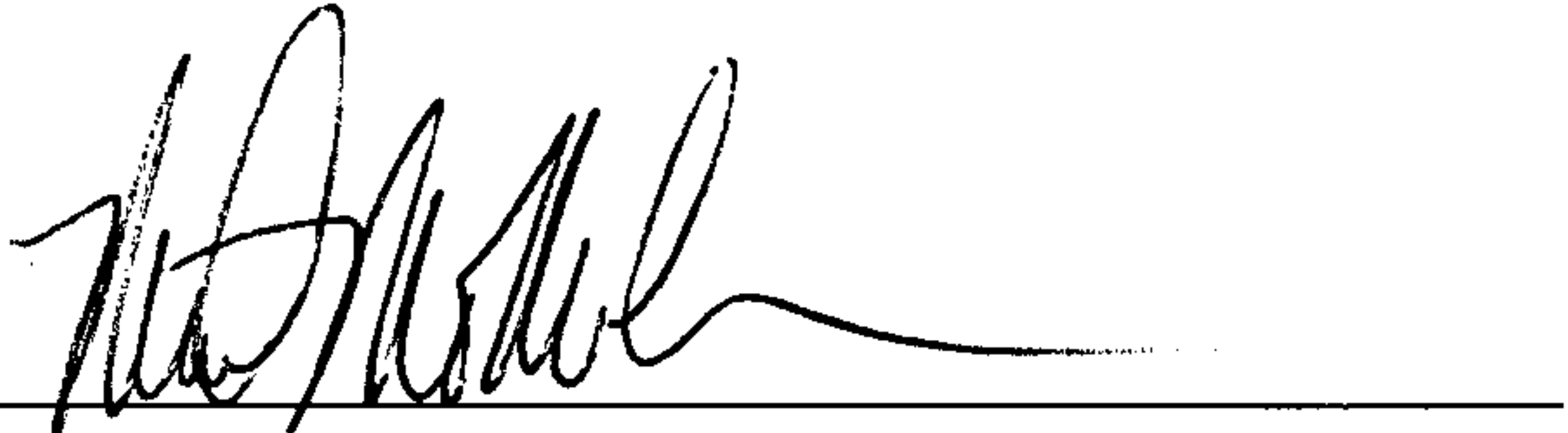
Member Managed
