THIS AGREEMENT is made and entered into on this 2nd day of December, 2013, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of NATIONSTAR MORTGAGE LLC, its successors and/or assigns (hereinafter referred to as "Lender").
