## ARTICLES OF ORGANIZATION

## To the Honorable Judge of Probate in and for Shelby County, Alabama:

The undersigned, acting as Organizers of a limited liability company under the Alabama Limited Liability Company Act, hereby adopt the following Articles of Organization for Liquid Lightning, LLC:


