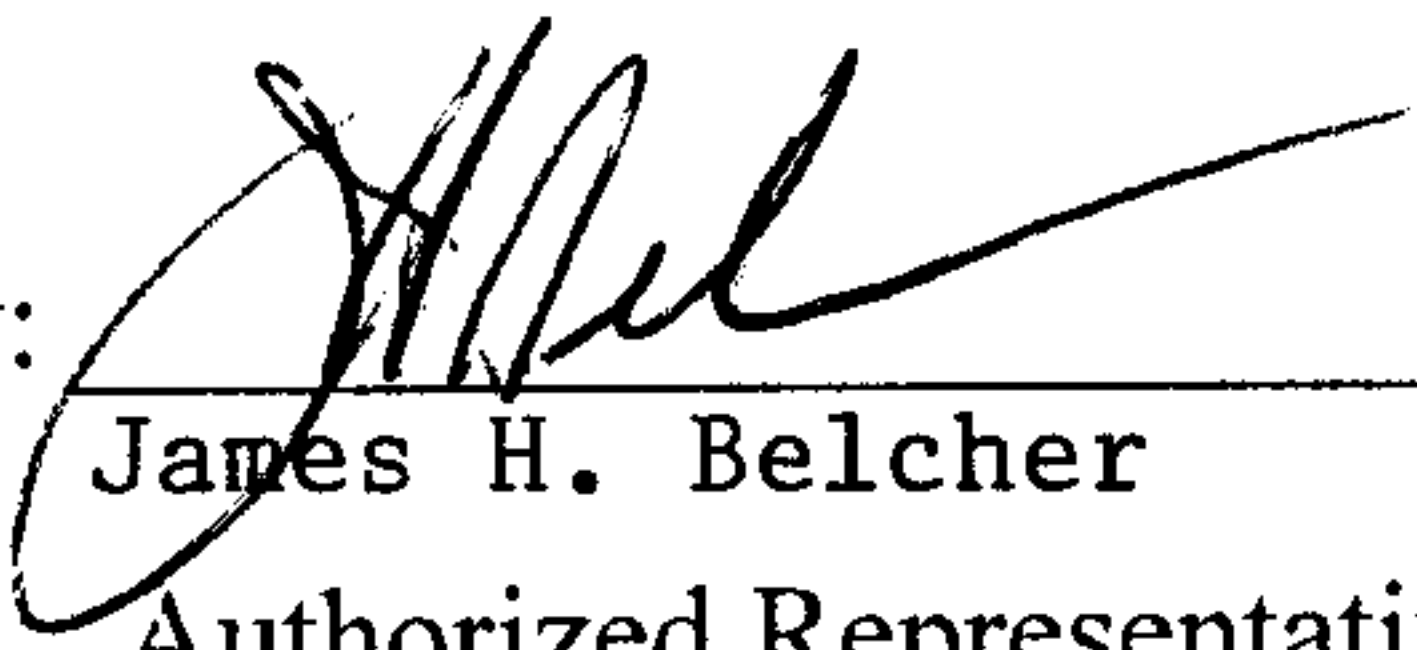
\$379,857.00 of the purchase price recited above has been paid from the proceeds of a

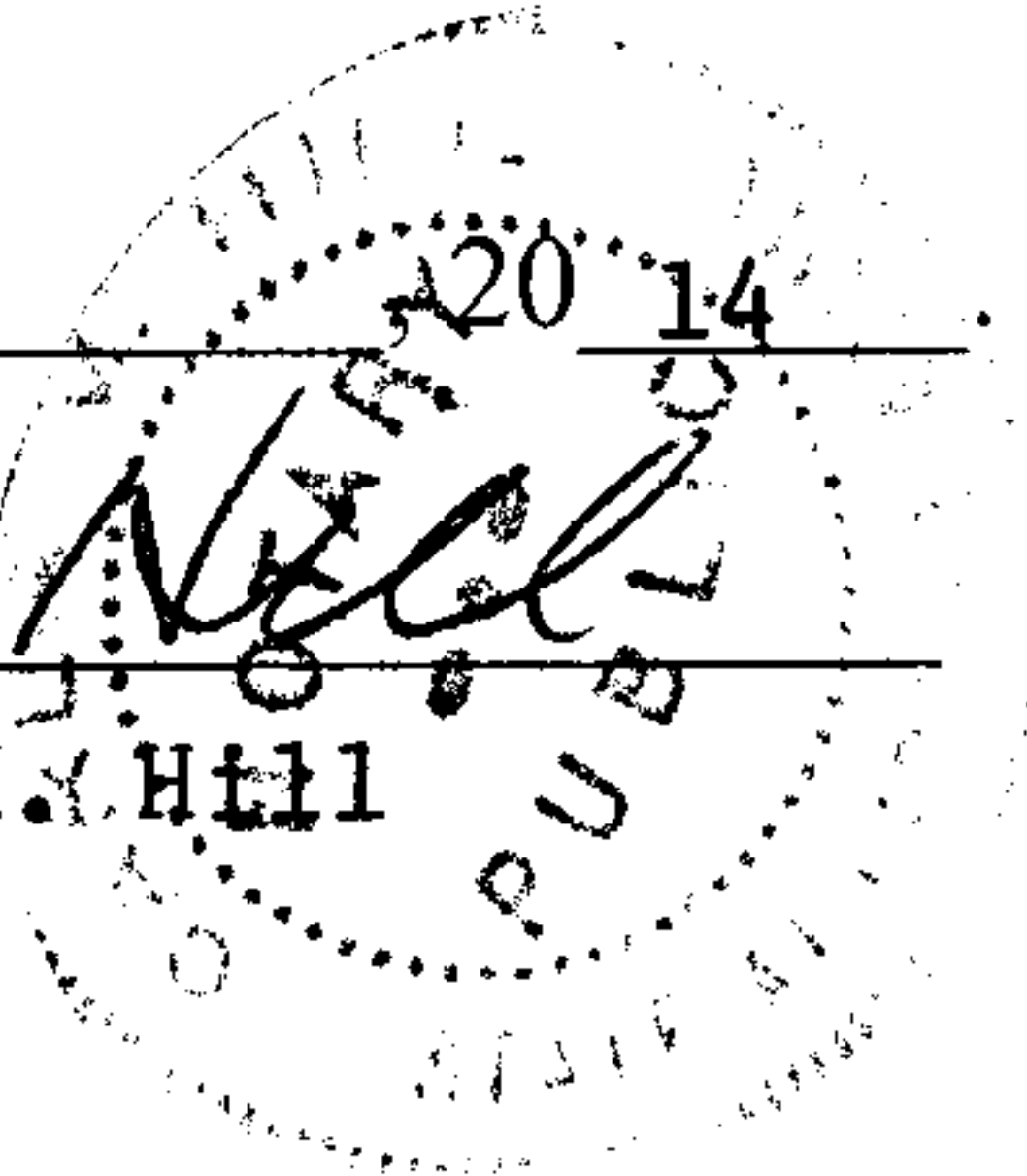

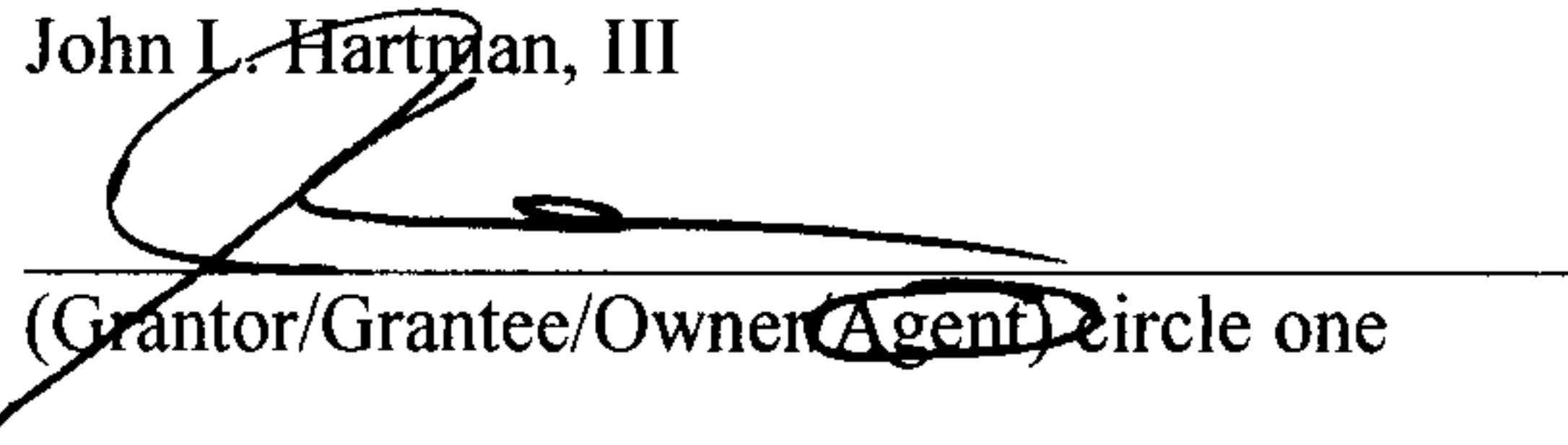
