KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of March, 2009, Latoya Washington, a married woman and Roy Alan King, her husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090408000129490, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument 20140212000040080, in the aforesaid Probate Office ("Transferee"); and

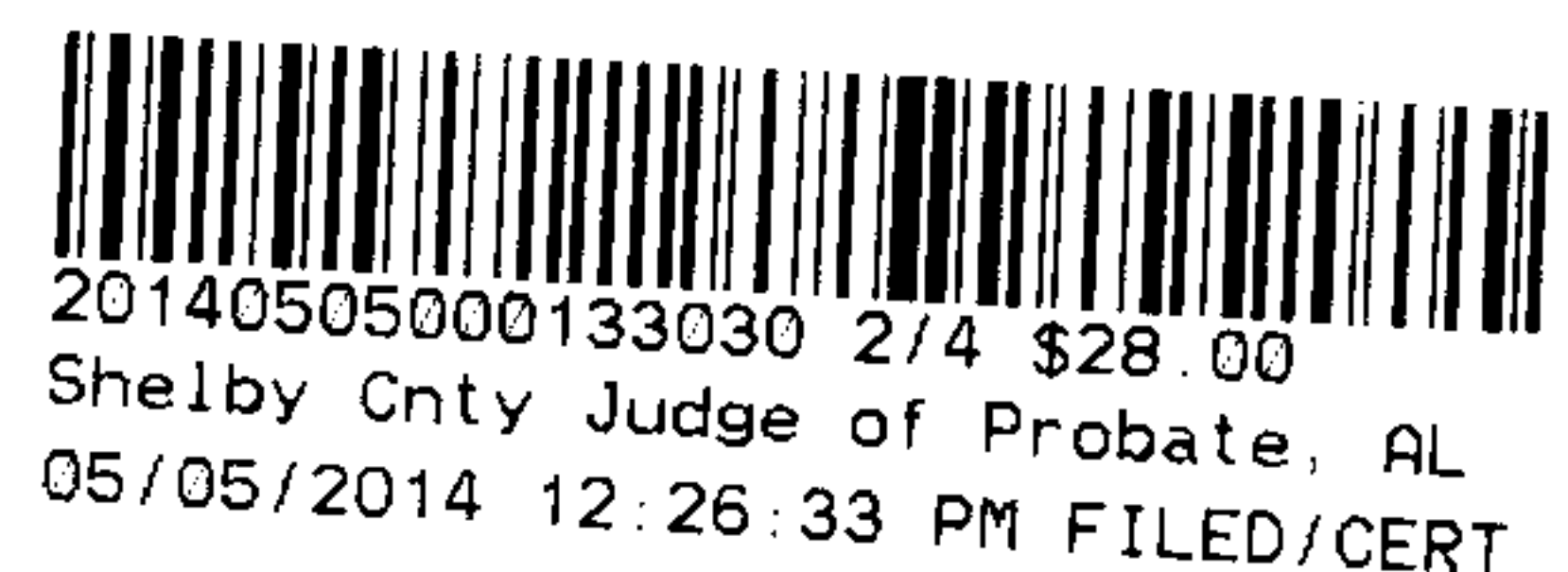

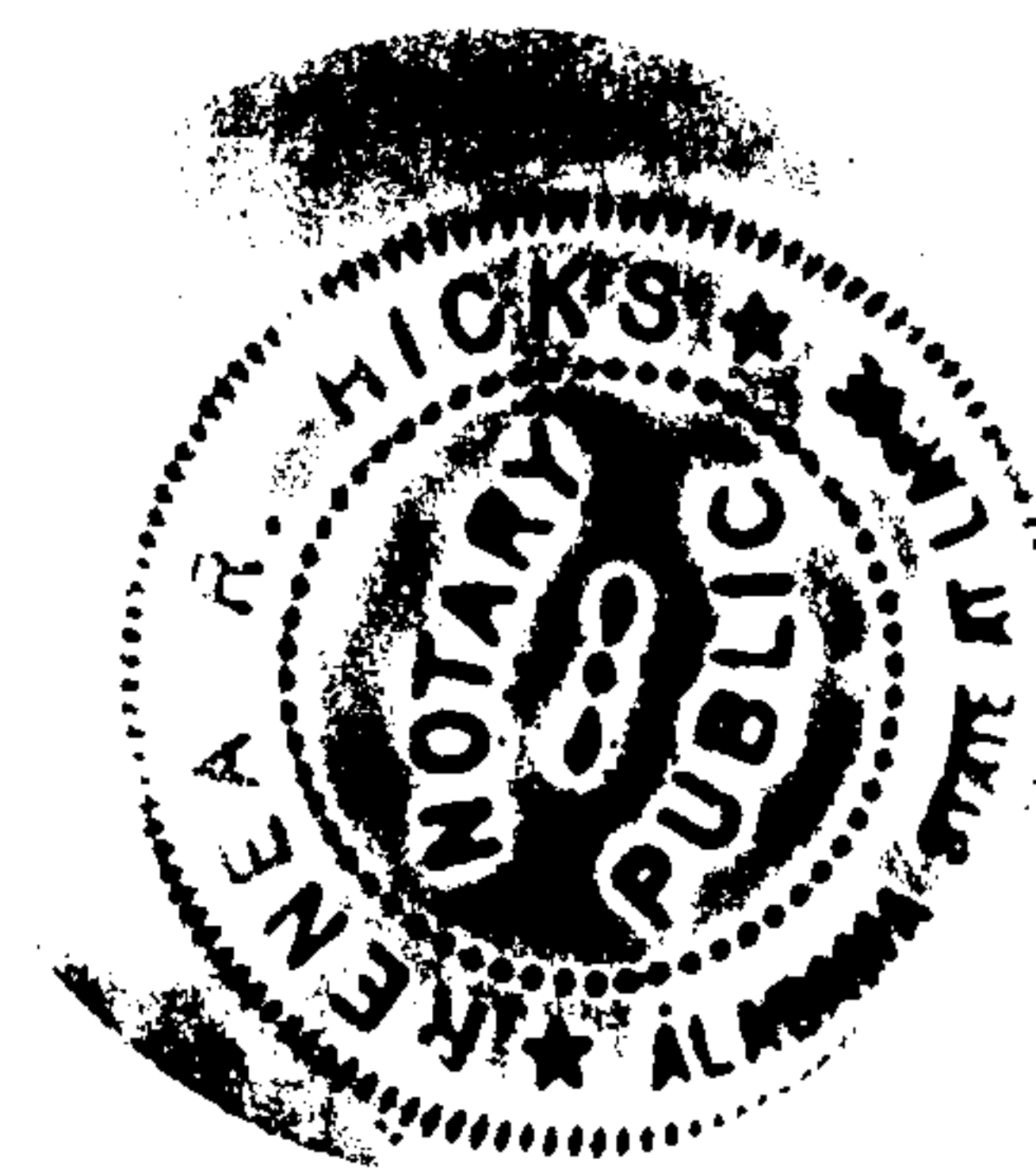
