Know All Men by These Presents: That in consideration of **Four hundred eight thousand nine hundred and no/100 (\$408,900.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Vines Construction, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Charles M. Purvis, Sr. and Barbara Y. Purvis** (herein referred to as grantee, as joint tenants of survivorship, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.


\$250,000.00 of the purchase price recited above was paid from a purchase money mortgage loan closed simultaneously herewith.

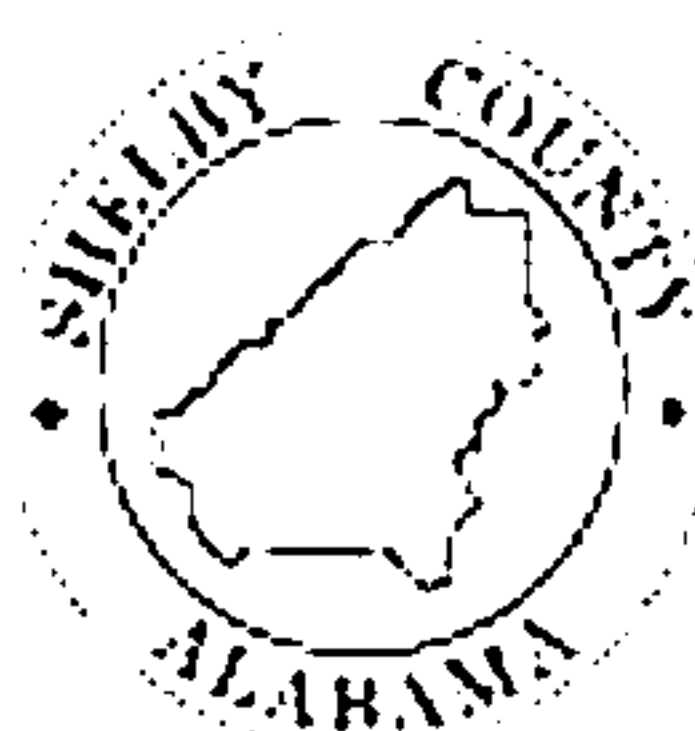
