KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of September, 2009, Joshua David Chamblee, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090924000364390; modified by Loan Modification Agreement recorded in Instrument Number 20131203000468850, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument Number 20121008000385010, in the aforesaid Probate Office ("Transferee"); and

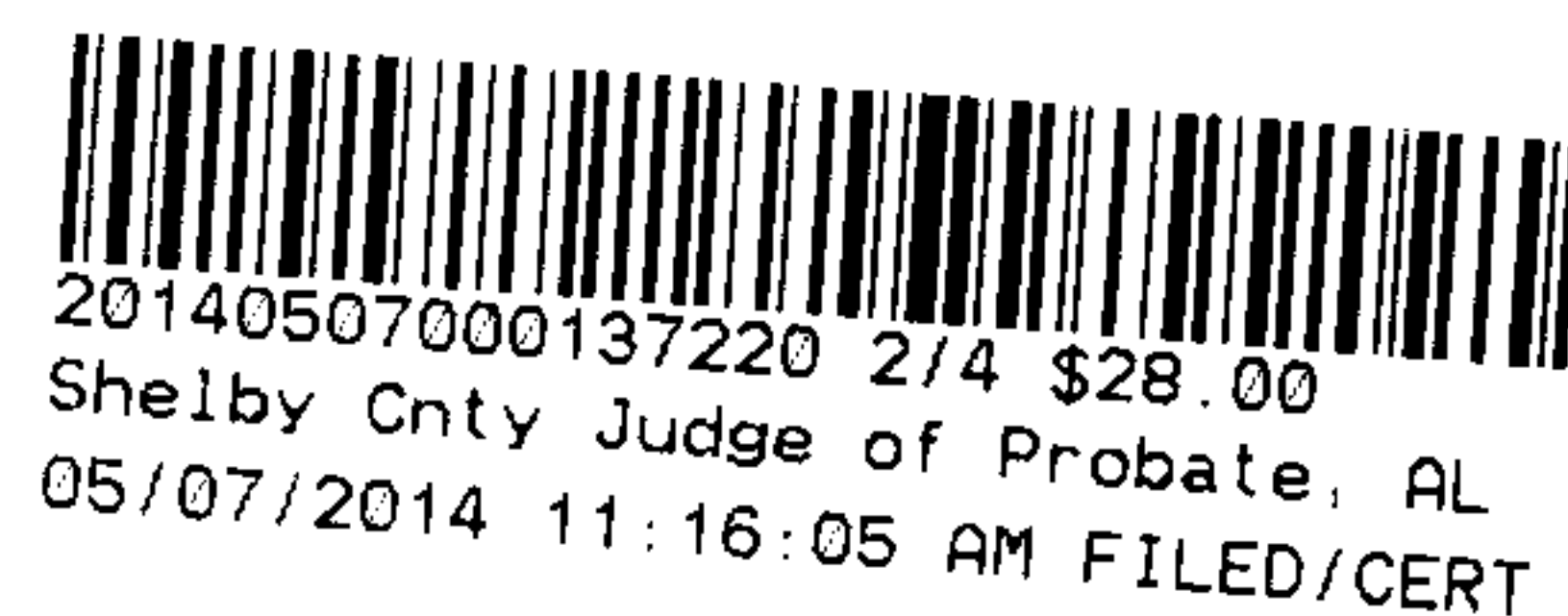
