KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of October, 2005, Robert R. Wellborn and Laura C. 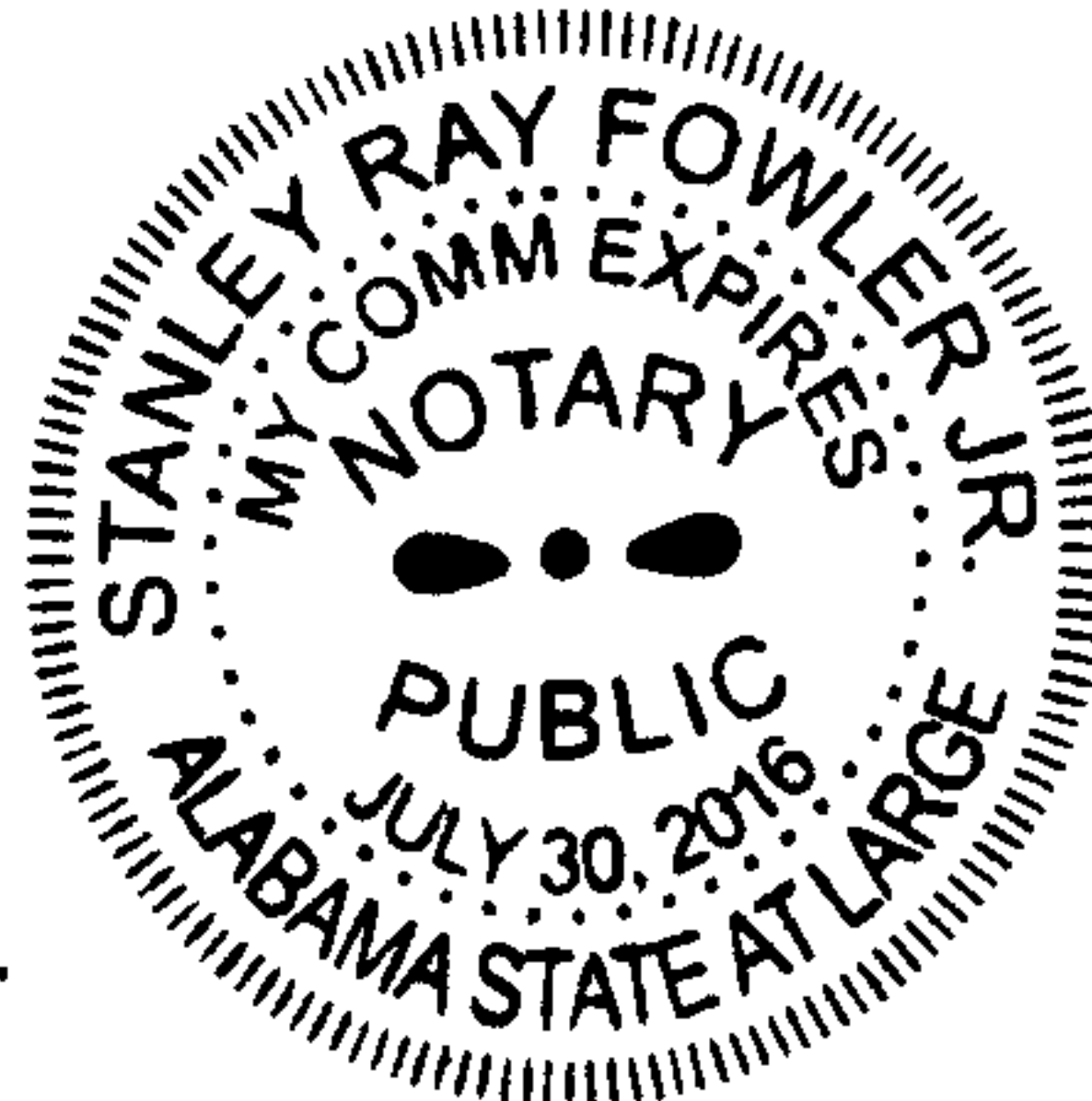
