KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of August, 2007, Thomas E. Crowder and Cynthia A. Crowder, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Wachovia Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070917000434020, said mortgage having subsequently been transferred and assigned to Sparta GP Holding REO Corp. , by instrument recorded in Instrument Number 20140214000041890, in the aforesaid Probate Office ("Transferee"); and

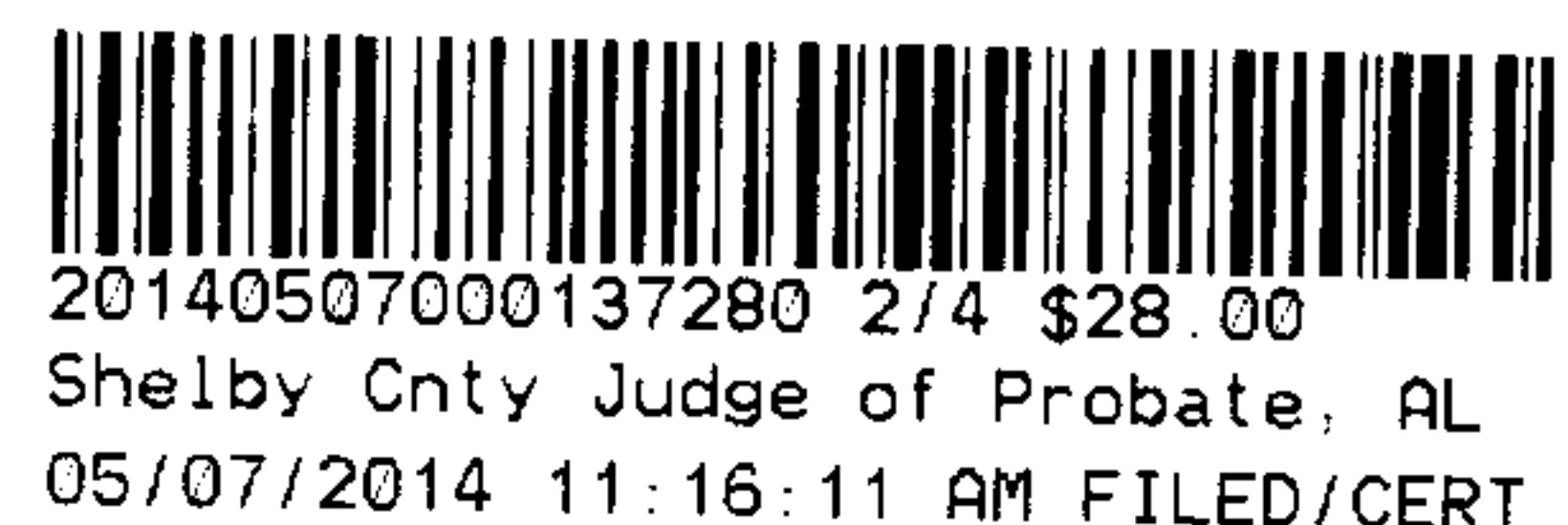

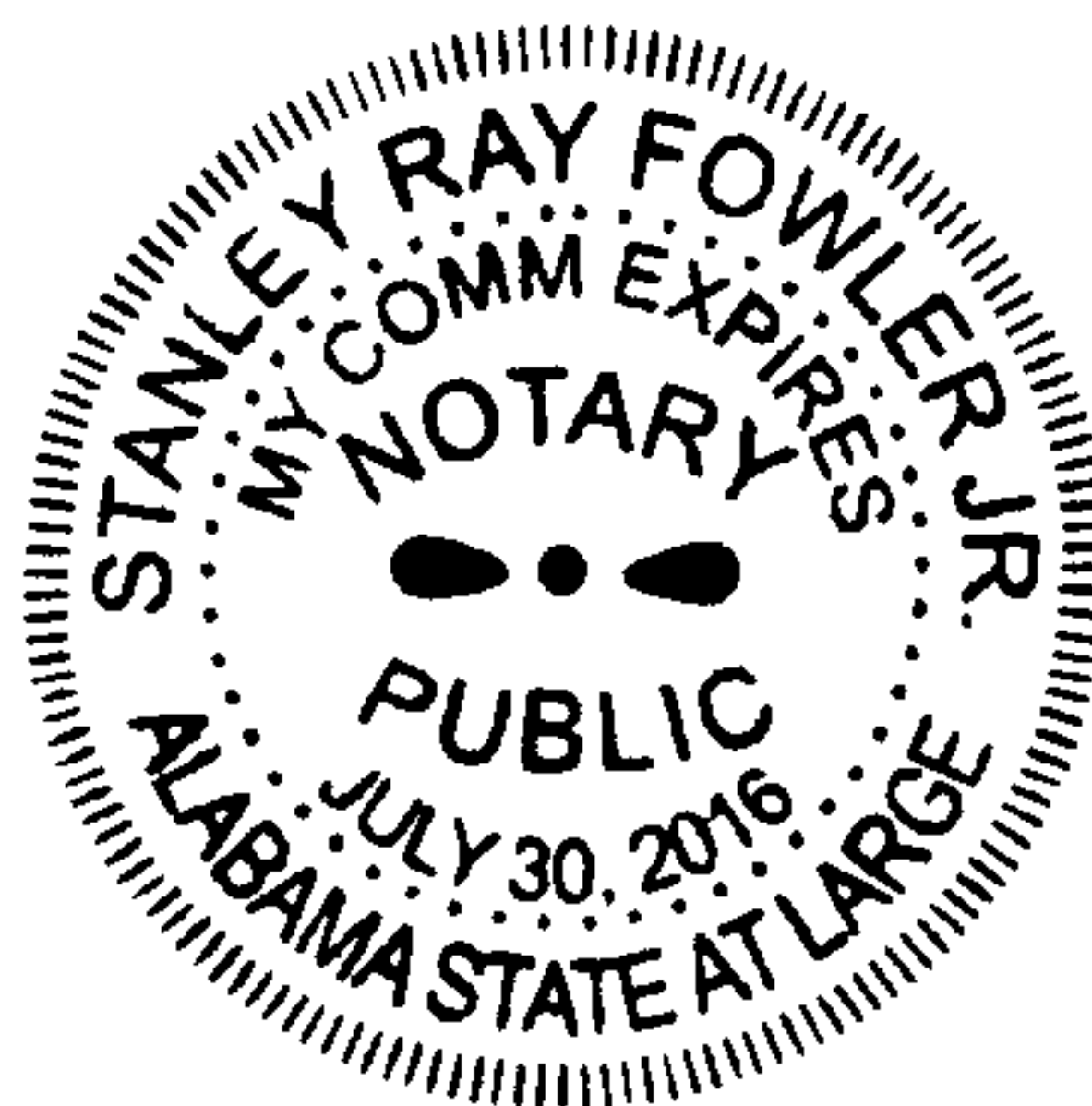
